Independent Auditors' Report

To the Trustees and Board of Directors of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of T & C Markets, Inc. Savings & Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of July 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2022 to July 31, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2022 and December 31, 2021, and for the period from January 1, 2022 to June 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Notes 1 and 2 to the financial statements, the governing body of the Plan approved a plan of liquidation on December 5, 2021, and management determined liquidation to be imminent. As a result, the Plan changed its basis of accounting to the liquidation basis used in presenting the 2022 and 2021 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Notes to Financial Statements

July 31, 2022 and December 31, 2021

1. Description of the Plan

The following description of the T & C Markets, Inc. Savings & Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan's summary plan description or plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by T & C Markets, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). All employees who have completed at least 1,000 hours of service in one year with the Company, as defined by the Plan and are age 21 or older are eligible to participate. Participation in the Plan begins on the first day of the first month or seventh month of the plan year following the satisfaction of eligibility requirements. The Company's Board of Directors is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

During 2021, Coborn's, Inc. acquired the Company. As a result of this transaction, the Company approved a resolution to terminate the Plan with an effective date of December 5, 2021. The Plan liquidated all mutual fund and guaranteed insurance contract balances by June 30, 2022. Employees of the Company terminated their employment and participants in the Plan received distributions of their account balances in accordance with plan provisions. The cash surrender value of life insurance policies, as disclosed in Note 9, was distributed by July 31, 2022.

The following provisions of the Plan were based on the plan document prior to termination and liquidation.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

The Plan provides for discretionary Company contributions which are determined annually by the Board of Directors. For the period from January 1, 2022 to July 31, 2022, the Company did not make any matching contributions. The Company may also make discretionary annual profit sharing contributions to the Plan as determined by the Board of Directors. There were no discretionary profit sharing contributions to the Plan for the period from January 1, 2022 to July 31, 2022. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's salary reduction contributions and Company's contributions, as well as allocations of Company profit sharing contributions and the Plan's earnings. Participants are charged with an allocation of administrative expenses that are paid by Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary reduction and rollover contributions plus earnings thereon. Participants who leave the Plan because of death, early or normal retirement or disability retirement, as defined by the plan document, are considered 100% vested. Vesting in the Company's discretionary matching contributions and profit sharing contributions are based on years of continuous service as follows:

As the Plan was terminated with an effective date of December 5, 2021, all participants in the Plan became 100% vested in the Company's discretionary matching contributions and profit sharing contributions regardless of vesting percentage reached as of that date.

Forfeited Accounts

As of July 31, 2022 and December 31, 2021, forfeited nonvested accounts were \$0 and \$4,416, respectively. These accounts will be used to reduce future plan expenses or Company contributions. During 2022, no Company contributions or plan expenses were reduced by forfeited nonvested accounts.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined by the plan document. The Plan provides for normal retirement at age 65 and early retirement on or after attaining age 55 and completion of five years of service. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment, installments or an annuity. Participants experiencing financial hardship may withdraw a portion of this account balance as defined by the plan document.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account. Loans bear interest at rates ranging from 4.25% to 6.50% at December 31, 2022, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions. Terms range from two to five years. All loans were reclassified as distributions prior to July 31, 2022 due to the termination of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

As a result of the plan sponsor's decision on December 5, 2021, to terminate the Plan, the accompanying financial statements are prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at liquidation value. Liquidation value is expected to approximate fair value based on the Plan's intent to conduct an orderly disposition of plan assets in connection with the Plan's liquidation. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net depreciation includes the gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2021. All loans were reclassified as distributions prior to July 31, 2022 due to the termination of the Plan.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

3. Information Certified by Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for period from January 1, 2022 to July 31, 2022 and for the year ended December 31, 2021. Accordingly, Nationwide Trust Company, FSB, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits in Liquidation as of July 31, 2022 and December 31, 2021, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits in Liquidation for the period from January 1, 2022 to July 31, 2022.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at liquidation value. There have been no changes in the methodologies used for the period from January 1, 2022 to July 31, 2022 and year ended December 31, 2021.

Guaranteed insurance contract is valued using fair value that represents contract value less any contingent deferred sales charge and market value adjustments. Fair values are based on unobservable inputs used for valuing the asset or liability. This contract seeks to guarantee a return of principal plus interest as stated in the contract.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of July 31, 2022, the Plan no longer had any assets due to the termination of the Plan. The following tables present balances of assets measured at liquidation value, as applicable, by level within the hierarchy. For purpose of determination of liquidation value for financial instruments held by the Plan as of December 31, 2021, fair value and net asset value, as applicable, have been used based on the plan sponsor's intent to conduct the disposition of such assets in an orderly manner.

5. Administration of Plan Assets

The Plan's assets are administered under a contract with the custodian. The custodian invests funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants.

6. Related-Party and Parties in Interest Transactions

Certain of the Plan's investments are managed by the custodian, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net depreciation in the fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Amounts Owed to Participants Withdrawing From the Plan

As of July 31, 2022 and December 31, 2021, there were no amounts owed to participants who have withdrawn from the Plan.

8. Tax Status

The Plan adopted a volume submitter plan offered by CCH Incorporated, DBA ftwilliam.com. The volume submitter plan received an advisory letter dated March 16, 2010, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the advisory letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Reconciliation of Financial Statements to Form 5500

The Form 5500 includes life insurance policies held by the custodian, assets for which have been properly excluded from the Plan's financial statements. The reconciliation between the financial statements and Form 5500 are as follows:

10. Prohibited Transactions

For the year ended December 31, 2021, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the DOL's Rules and Regulations for Reporting and Delinquent Participant Contributions Disclosure under ERISA. Untimely remittances identified on the Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions, which totaled \$273 for the year ended December 31, 2021, were corrected outside of the DOL Voluntary Fiduciary Correction Program during 2022. Additionally, the Company has compensated participants for lost earnings resulting from the delay in contributions.

11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

The Plan holds certain investments that represent 10% or more of the Plan's net assets available for benefits. As of July 31, 2022, the Plan no longer had any investments due to the plan termination as disclosed in Note 1. As of December 31, 2021, the Plan held five such investments totaling \$6,632,387.

12. Subsequent Events

The Plan has evaluated subsequent events through April 24, 2023, which is the date that the financial statements were approved and available to be issued, for events requiring recording or disclosure in the Plan's financial statements.
