NOTES TO FINANCIAL STATEMENTS

March 31, 2022 and December 31, 2021

NOTE A - PLAN DESCRIPTION

The following description of the Foresight Sports 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which was established January 1, 2010, under Internal Revenue Code Section ("IRC") 401(k) that covers all eligible employees of WAWGD Newco LLC dba Foresight Sports (the "Company" or "Foresight Sports"). Foresight Sports was acquired by Vista Outdoor Inc. (the "Plan Sponsor") on September 28, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Vista Outdoor Inc. Retirement Investment Committee is responsible for the oversight of the Plan, while the Plan is administrated by the Company, Plan Sponsor and Fidelity Management Trust Company (the "Trustee" or "Fidelity").

Plan Mergers

On March 31, 2022, the Plan merged into the Vista Outdoor Inc. 401(k) Plan.

Following are the Plan provisions in effect prior to the merger of the Plan into the Vista Outdoor Inc. 401(k) Plan.

Eligibility

Employees are eligible to participate in the Plan after completing six months of service and are at least 18 years of age. Eligible employees exclude those employees whose employment is governed by a collective bargaining agreement (unless the agreement specifically provides for a participant to be covered by the Plan), non-resident aliens, or leased employees. Employees may be enrolled for salary deferral contributions on the first day of the following month they are eligible. Employees are eligible to receive safe harbor nonelective company contributions and discretionary profit-sharing contributions (collectively "Company contributions") upon enrollment as long as the employee is actively employed during the Plan year.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation subject to the IRC limitation, as defined in the Plan. Participant who has attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Eligible employees may elect to make pre-tax and/or Roth contributions.

In addition to salary deferrals, the Company will make a safe harbor nonelective contribution of 3% to all eligible participants, as defined in the Plan document. In addition, the Company may decide to make discretionary profit-sharing contributions and discretionary matching contributions, which are determined by management. There were no profit-sharing contributions for the 3 month period ended March 31, 2022.

Participant Accounts

A separate account is established for each participant. The account is credited or charged, as applicable with the participant's salary deferral contributions, an allocation of Company contributions, the participant's share of investment earnings and losses, the participant's distributions and certain administrative charges. Allocations are based on participant earnings or account balances, as defined. Participants direct the investment of their account into the various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contributions and safe harbor nonelective company contributions plus earnings thereon. Vesting in each participant's discretionary profit-sharing and discretionary matching contribution accounts plus investment income earned thereon is based on years of service according to the following schedule:

2	50%

4	100%

If a participant becomes permanently disabled, or in the event of death, the participant becomes fully vested.

Notes Receivable from Participants

Participants are permitted to borrow from their accounts at a minimum of \$1,000, and up to a maximum of the lesser of \$50,000 reduced by the excess of the highest outstanding balance of plan loans during the one-year period ending on the day before the loan is made, or 50% of their vested account balance. Loan terms may not exceed 5 years unless the loan is for the purpose of acquiring a principal residence in which case the term of the loan may not exceed 10 years and participants may have two loans outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% over the prime rate as determined at the time of the loan application. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

Upon termination of service due to death, disability or retirement, a participant may receive a lump-sum distribution. For termination of employment for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Under certain circumstances (such as a hardship), and with approval of the Company, a participant can elect at any time to receive a portion of his or her vested account balance subject to the provisions of the Plan. The Plan also allows hardship withdrawals from all vested allowable sources. In-service withdrawals are permitted once a participant has attained age 59½.

Forfeitures

Forfeited non-vested accounts at March 31, 2022 and December 31, 2021 totaled \$0 and \$27,120, respectively. Forfeitures may be used to pay Plan expenses or reduce future Company contributions. For the 3 month period ended March 31, 2022, \$1,670 of forfeitures were used to fund Company contributions. The remaining balance was transferred as part of the merger of the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recognized when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation).

Subsequent Events

The plan has evaluated subsequent events through April 17, 2023, the date the financial statements were available to be issued.

The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The Plan also utilizes the authoritative guidance under GAAP for estimating the fair value of investments in the investment funds that have calculated net asset value (“NAV”) per share in accordance with the specialized accounting guidance for investment companies. Accordingly, the Plan estimates the fair value of an investment in an investment fund using the NAV of the investment (or its equivalent) without further adjustment unless the Plan determines that the NAV is deemed to be not reflective of fair value.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. In evaluating the level at which the Plan’s investments have been classified, the Plan has assessed factors including, but not limited to price transparency, the ability to redeem at net asset value at the year-end and the existence or absence of certain restrictions at year-end.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of March 31, 2022 and December 31, 2021.

Registered Investment Companies:

Valued at the daily closing price as reported by the fund. Registered Investment Companies (RIC) held by the Plan are open-end RICs that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE D - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator determined that the certification received from the Trustee meets the requirements of ERISA Section 103(a)(3)(C). The Trustee certified that the following data included in the accompanying financial statements are complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of March 31, 2022 and December 31, 2021.
- Net investment (loss) income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the 3 month period ended March 31, 2022.

NOTE E - TRANSACTIONS WITH PARTIES-IN-INTEREST

During the year, the Plan was invested in funds managed by the Trustee and permitted notes receivable from participants. These transactions qualify as exempt party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

NOTE F - PLAN TERMINATION

The Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and terms of the Plan. In the event of termination or partial termination of the Plan, applicable participants' accounts shall be fully vested as of the date of such termination. The Company determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

NOTE G - TAX STATUS

The Internal Revenue Service has determined and informed the Plan administrator by a letter dated June 30, 2020, that the volume submitter plan is acceptable under the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the volume submitter plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt. If any compliance matters are identified, the Plan Sponsor will remediate, as applicable.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
