Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Convercent 401(k) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of July 22, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to July 22, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution for the period ended July 22, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1. Description of Plan

The following description of Convercent 401(k) ("the Plan") provides only general information for the eligible employees of Convercent, Inc. (the "Company"). Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Merger:

In April 2021, OneTrust LLC acquired the Company as part of a purchase agreement. The Board of Directors of OneTrust LLC made the decision to merge the Plan into the OneTrust LLC 401(k) Plan effective July 22, 2022. As a result, all investments were transferred from the Plan to the OneTrust LLC 401(k) Plan on July 22, 2022. Prior to the merger, the Company instituted a reduction in workforce that resulted in a partial plan termination.

General:

The Plan is a defined contribution plan covering employees of the Company who are not union employees, nonresident aliens, residents of Puerto Rico, part-time employees who work less than 1,000 hours, and temporary/seasonal employees. The Plan has no age or service requirement for Plan eligibility. Employees may enter the Plan on the first day of the month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may contribute a percentage of their pre-tax annual compensation, as well as post-tax Roth contributions, as voluntary contributions in accordance with the provisions of Section 401(k) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Each year, the Company may make a matching contribution equal to a discretionary percentage to be determined by the Company for all participants who were active employees on the last day of the Plan year. The Company may also make nonelective contributions to participants based on participant's compensation as a ratio to the total of all participants' compensation. There were no Company matching or nonelective contributions during the period from January 1, 2022 to July 22, 2022.

Participant accounts:

Each participant's account is credited with the participant's contribution and an allocation of the employer's contribution and plan earnings, and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

CONVERCENT 401(K)**NOTES TO FINANCIAL STATEMENTS**

Note 1. Description of Plan (continued)

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer's contributions portion of their accounts is based on years of continuous service. A participant is 100 percent vested in employer matching contributions after one year of credited service. Vesting in any nonelective employer contributions is based on years of service, and a participant is full vested in these contributions after three years of continuous service. Participants covered under the Plan prior to March 1, 2017 are immediately 100 percent vested in employer contributions.

Forfeited accounts:

Forfeitures are retained in the Plan and may be used to reduce employer contributions or pay plan expenses. There were no forfeited accounts as of July 22, 2022 and December 31, 2021.

Payment of benefits:

Upon retirement, death, or disability, a participant or beneficiary may elect to receive either a lump sum amount or equal installments, a direct rollover to an IRA or other qualified plan, or any combination thereof. Payments of benefits will be made as soon as administratively feasible, with participant consent required for balances greater than \$5,000. Participants may also make withdrawals prior to termination after attaining age 59 1/2.

In-service hardship withdrawals are permitted as defined in the Plan.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition:

Investments are reported at fair value, except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

CONVERCENT 401(K)**NOTES TO FINANCIAL STATEMENTS**

Note 2. Significant Accounting Policies (continued)

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses and certain participant-requested service fees are included in administrative expenses and charged directly to the participant's account.

Payment of benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Note 3. Related Party Activity

Transamerica Life Insurance Company is the custodian of the Plan, therefore, fees paid to the custodian qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 4. Information Prepared and Certified by Custodian

The following information was compiled from data certified by the custodian, Transamerica Life Insurance Company, as being complete and accurate:

- A. Investments included in the Statements of Net Assets Available for Benefits as of July 22, 2022 and December 31, 2021.
- B. Investment income included in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2022 to July 22, 2022.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 6. Income Tax Status

The Plan adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan document which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the prototype basic plan document is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Any employer adopting this form of the plan will be considered to have a plan qualified under the applicable section of the IRC. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt and no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 (none at July 22, 2022).

Pooled separate accounts: Pooled separate accounts (PSAs) invest in mutual funds. The fair value of the mutual funds is a publicly quoted pricing input and is used in determining the net asset value (NAV) of the PSAs, which is not publicly quoted. These PSAs can be redeemed at NAV as of the measurement date.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) The pooled separate accounts are measured using NAV as a practical expedient. In accordance with guidance in ASU 2015-07, these investments have not been classified in the fair value hierarchy table. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The investments measured at fair value based on NAV per share have no unfunded commitments or redemption restrictions.

Note 8. Stable Value Fund

The Plan has entered into a benefit-responsive investment contract with Transamerica Life Insurance Company (Transamerica). Assets held in the Stable Value Fund are commingled with assets in the general account. The account is recorded at its contract value, which approximates fair value. The Stable Value Fund has no stated maturity. Interest rates reset monthly as of the beginning of each month, during which a new interest rate is applied daily to the total outstanding balance of the investment.

The Stable Value Fund investment choice is a non-tradable obligation of Transamerica. The investment's contract or proceeds cannot nor will not be assigned or sold to another party without the consent of Transamerica. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Transamerica. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable, the Stable Value Fund may no longer be considered fully benefit-responsive.

Note 8. Stable Value Fund (continued)

The terms of the contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying Plan such as withdrawals for benefits, loans or transfers to other investment choices within the Plan. Since the Stable Value Fund investment choice is an obligation of Transamerica, the occurrence of an event that limits the ability of the investment to transact at contract value between Transamerica and a participant holding the investment is not probable. The Stable Value Fund investment choice allows a participant reasonable access to their assets. There are no unfunded commitments, the redemption frequency is daily, and the redemption notice period is daily.

Note 9. Plan Amendments

Effective January 1, 2022, the Plan was amended and restated in accordance with the Internal Revenue Service's third cycle pre-approved defined contribution plan program. As part of this restatement, union employees, nonresident aliens, residents of Puerto Rico, part-time employees who work less than 1,000 hours, and temporary/seasonal employees are excluded from Plan eligibility.

Note 10. Subsequent Events

The Plan has evaluated subsequent events through May 2, 2023, the date the financial statements were available to be issued.
