Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the accompanying financial statements of Navitas Midstream Management L 401(K) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of October 13, 2022 on the liquidation basis of accounting and as of December 31, 2021 on the accrual basis of accounting, and the related statement of changes in net assets available for plan benefits on the liquidation basis of accounting for the period January 1, 2022 to October 13, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Navitas Midstream Management L 401(K) Profit Sharing Plan & Trust's (the Plan) financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 13, 2022 and December 31, 2021, and for the period January 1, 2022 to October 13, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the liquidation basis and with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter

As more fully discussed in Note F, on February 17, 2022, Enterprise Products Company acquired Navitas Midstream Management L and the Plan Sponsor, and as a result, the Plan was terminated the day prior to the acquisition date and all assets distributed on or before October 13, 2022.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the liquidation basis with accounting and accrual basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General - The Navitas Midstream Management L 401(K) Profit Sharing Plan & Trust (the Plan) was adopted effective January 1, 2016. The Plan Sponsor for the Plan is Navitas Midstream Management L (the Company). The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective January 1, 2022 to comply with current laws.

Basis of Presentation - The Plan's financial statements are prepared on the liquidation basis for 2022 and the accrual basis of accounting for 2021 in accordance with generally accepted accounting principles in the United States (GAAP). Interest and dividend income is recognized when earned.

As mentioned in Note F, On February 17, 2022, Enterprise Products Company acquired the Company and Plan Sponsor. The Plan was terminated the day prior to the acquisition date. As a result, the financial statements are on the liquidation basis of accounting which is similar to GAAP basis.

Estimates - The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for several investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits.

Notes Receivable from Participants - Loans to participants are reported as a receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits - Benefits are recorded when paid.

Federal Income Tax - The Plan operates under an adoption agreement in connection with a prototype non-standardized profit sharing plan (Prototype Plan) sponsored by Paychex Inc. This Prototype Plan document was filed with the appropriate agency, and the Prototype Plan has obtained a favorable opinion letter from the IRS dated August 31, 2020 stating that the Prototype Plan constitutes a qualified plan under Section 401 of the IRC, and that the related trust was a tax exempt as of the financial statement date. The Plan has been amended since the favorable opinion letter was obtained. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, the Plan Administrator believes the Plan was qualified and the related trust was tax-exempt as of October 13, 2022 and December 31, 2021.

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of October 13, 2022, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2019 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in net assets available for plan benefits.

Subsequent Events - The Plan has evaluated subsequent events through May 9, 2023, the date the financial statements were available to be issued. No subsequent events occurred which require adjustment or disclosure to the financial statements at October 13, 2022.

NOTE B PLAN DESCRIPTION

The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Participation - The Plan covers all employees except union employees, non-resident aliens, and employees who become employees as a result of a Code Section 410(b)(6)(c) transaction. Covered employees who have attained the age of 21 are eligible to participate in the Plan. Eligible employees may enter the Plan on the date the eligibility requirements are met.

Contributions - The Plan permits eligible employees to contribute, on a before-tax or Roth basis, up to 75% of eligible compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which is \$20,500 for 2022. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$6,500 for 2022).

For the period from January 1, 2020 through May 6, 2020, the Company made safe harbor matching contributions to the Plan on behalf of participants in an amount equal to 100% of participants' elective contributions up to a maximum of 4% of eligible compensation. If a participant did not receive the full Company match, the Company provided a year-end "true up" contribution to provide such participants with the match that they would have received had the timing of their contributions not limited the Company match.

NOTE B PLAN DESCRIPTION (CONTINUED)

The Company ceased making safe harbor matching contributions under the Plan with respect to compensation earned by Plan participants effective May 7, 2020. The Plan was amended effective August 31, 2020 to remove the safe harbor Company matching contributions provision. Effective October 1, 2021, the Plan was amended to provide for a 4% non-elective safe harbor Company matching contribution to eligible participants. In addition, the Plan was amended to exclude reimbursements or other expense allowances, fringe benefits, moving expenses, deferred compensation and welfare benefits from eligible compensation for purposes of calculating contributions to the Plan. Effective January 1, 2022, the plan was further amended to provide for a 6% non-elective safe harbor Company matching contribution to eligible participants.

Eligible compensation is limited to \$305,000 for 2022.

Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's contributions and earnings attributable to each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions and safe harbor Company matching contributions, plus actual earnings thereon.

Investments - Each participant directs the investment of their account into any of the available investment options designated by the Plan Administrator.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the Prime rate, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly. Interest rates on loans outstanding at December 31, 2021 range from 4.25% to 6.50%.

Form of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, a partial withdrawal, or installment payments. Vested account balances of less than \$5,000 are immediately distributable in a lump sum under the terms of the Plan without the participant's consent. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE D FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 – Unadjusted quoted prices for identical financial instruments in active markets that the Plan has the ability to access. Registered investment companies and interest bearing cash are classified as Level 1 investments.

Level 2 – Other significant observable inputs (including quoted prices in active and inactive markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the financial instruments.

NOTE D FAIR VALUE DISCLOSURES (CONTINUED)

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the financial instruments. The fair value of Level 3 financial instruments is determined using pricing models or similar techniques which require significant management judgment or estimation.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used during 2022 and 2021.

Registered investment companies and interest bearing cash are valued at the market value of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no significant transfers in and/or out of the fair value categories during 2022 or 2021.

NOTE E PARTY-IN-INTEREST

The Plan invests in various funds offered by Mid Atlantic Trust Company. These investments are considered party-in-interest transactions because Mid Atlantic Trust Company serves as trustee of the Plan. The Plan Sponsor has approved of these investment options.

NOTE F PLAN LIQUIDATION

On February 17, 2022, Enterprise Products Company acquired the Company and Plan Sponsor. The Plan was terminated the day prior to the acquisition date. The participants were given the option to voluntarily rollover their account to the Enterprise 401(k) Plan, receive a distribution or rollover their balance to another qualified plan. The Plan was liquidated as of October 13, 2022.
