## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of RBC Profit Sharing & 401(k) Salary Deferral Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2022 (in Liquidation) and December 31, 2021 (Ongoing), and the related statement of changes in net assets available for benefits for the year ended July 31, 2022 (in Liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RBC Profit Sharing & 401(k) Salary Deferral Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 31, 2022 and December 31, 2021, and for the year ended July 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirement of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of RBC Profit Sharing & 401(k) Salary Deferral Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting***

As further discussed in Note 8 to the financial statements, the Board of Directors of RBC Profit Sharing & 401(k) Salary Deferral Plan, the Plan's sponsor, voted on July 29, 2021 to terminate the Plan and management determined liquidation is imminent. As a result, the RBC Profit Sharing & 401(k) Salary Deferral Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about RBC Profit Sharing & 401(k) Salary Deferral Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the RBC 401(k) & Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Robinson Brothers Construction, Inc. is the Plan's sponsor and manages all activity related to the Plan.

(a) General - The Plan is a defined contribution profit sharing plan and a salary reduction plan established January 1, 2012. The Plan covers all employees who are age 18 or older who have completed at least two consecutive months of service and are not covered by a collective bargaining agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions - Each year, participants may contribute the maximum of pretax compensation as defined in the Plan and by the Internal Revenue Service. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may contribute discretionary matching contributions to all participants making salary deferrals. The matching contribution is invested as directed by the participant. Additional discretionary profit sharing amounts may be contributed to participants who have met the requirements for participation in the profit sharing portion of the Plan, have at least 1,000 hours of service during the Plan year, and are employed on the last day of the Plan year. The profit sharing contribution is invested as directed by the participant. Contributions are subject to certain limitations. The Company made discretionary contributions of \$0 and \$85,961 for the years ended July 31, 2022 and December 31, 2021, respectively.

The Company also contributes those hourly benefits required on wages that are paid to employees performing work subject to the federal Davis-Bacon Act provisions or similar state provisions (prevailing wage contributions). The Company made prevailing wage contributions of \$0 and \$21,892 for the years ended July 31, 2022 and December 31, 2021, respectively.

(c) Participant Accounts - Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, if any, plus a proportionate interest in the investment earning or losses of the funds in which the contributions are invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances on a quarterly basis. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

(d) Investment options - Participants may direct the investment of all contributions into various investment options offered by the Plan. The Plan allows participants to direct their contributions and account balances among various options offered by Great-West Life & Annuity Insurance Company.

(e) Vesting - Participants are immediately vested in their salary deferral contributions, rollover contributions, and prevailing wage contributions plus actual earnings or losses thereon. Vesting in the Company's matching and profit sharing contributions plus earnings or losses thereon is based on years of continuous service. A participant is 100% vested after five years of credited service or upon death, disability, or normal retirement.

(f) Payments of Benefits - Upon termination of service due to death, disability, retirement, or termination due to other reasons, a participant will receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or as partial withdrawals of at least \$1,000. The participant must consent to the distribution if his or her vested benefit under the Plan exceeds \$5,000.

(g) Forfeited Accounts - Forfeited nonvested accounts are first used to pay administrative expenses of the Plan. Any remaining forfeitures are used to offset required employer contributions into the Plan. Forfeited nonvested accounts totaled \$0 and \$8,962 at July 31, 2022 and December 31, 2021, respectively. During the years ended July 31, 2022 and December 31, 2021, forfeited non-vested accounts of \$5,825 and \$423, respectively, were used to pay plan expenses and reduce employer contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

(a) Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Payment of Benefits - Benefits are recorded when paid. There are no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not been paid at July 31, 2022 and December 31, 2021.

(e) Administrative Expenses - The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation or depreciation of fair value of investments.

(f) Date of Management's Review - Subsequent events were evaluated through May 5, 2023, which is the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2022 and December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

During the year ended December 31, 2019, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company (Great-West). Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments include shares of mutual funds managed by Great-West Life & Annuity Insurance Company and an annuity contract issued by Great-West. Great-West Trust, LLC, is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in the net appreciation or depreciation in fair value of the related investment, as they are paid through revenue sharing rather than direct payment. In addition, fees incurred by the Plan for third-party administration and investment advisory services are paid through revenue sharing rather than direct payment.

An officer of the Plan sponsor is a current participant in the Plan and serves as the administrator of the Plan.

**NOTE 7 - TAX STATUS**

The Plan sponsor adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated July 7, 2014, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

**NOTE 8 - PLAN TERMINATION**

The Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

The Plan sponsor froze the accrued benefits as of July 28, 2021 and terminated the Plan effective July 29, 2021. All participants became fully vested in their account balances, and had the option of either receiving a distribution (less applicable penalties and taxes), transferring their balance to another eligible retirement plan, or transferring their balance to the Quanta 401(k) Savings Plan ("Quanta's Plan"). The Plan was fully liquidated as of July 29, 2022.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
