INDEPENDENT AUDITORS' REPORT

To the Finance Committee of
the Houston Country Club 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Houston Country Club 401(k) Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of July 29, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the period January 1, 2022 to July 29, 2022 (in liquidation), and the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the statement of changes in net assets available for benefits for the year then ended (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Emphasis of Matter—Basis of Accounting

As described in Note 1 to the financial statements, the Plan was liquidated and transferred to a professional employer organization. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of the Plan

The following description of the Houston Country Club 401(k) Plan ("Plan") provides only general information. Participants should refer to the plan document and trust agreement for a more complete description of the Plan's provisions.

General

The Plan commenced and was made effective on January 1, 1999 and was last amended February 22, 2022. The Plan was a qualified retirement plan under the Internal Revenue Code ("IRC") to enable eligible employees to save for retirement. The Plan covered all full-time and part-time employees of the Houston Country Club ("Club"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan termination

Effective July 29, 2022, the Plan was liquidated and transferred total investments in the amount of \$15,731,444 and notes receivable from participants in the amount of \$429,719 to Club Retirement Plan, a multiple employer plan sponsored by Club Management Association of America.

Plan trustee

Fidelity Management Trust Company is the trustee of the Plan.

Eligibility and contributions

The Plan's eligibility requirement allowed participation upon obtaining the age of 21. Participants must have had at least 1,000 hours of service before becoming eligible for the safe harbor matching and discretionary nonelective contributions.

Participants could voluntarily contribute up to 60% of their eligible compensation (i.e., salary reduction) to the Plan up to the maximum limit allowed by the IRC regulations. Participants age 50 or older could also make catch-up contributions to the Plan. Participants could rollover amounts representing distributions from other eligible retirement plans.

The Club adopted the safe harbor provision of the IRC. The Club contributed and allocated to each eligible participant's account a safe harbor matching contribution equal to 100% of elective salary deferrals up to the first 4% of compensation. The Club could also make discretionary nonelective contributions.

Participant accounts

Each participant's account was credited with the participant's contribution, Club contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings or losses, account balances, or specified participant transactions. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Notes receivable from participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000.

Participants could have only one note outstanding at a time. Participant notes were secured by the participant's account balance and bore interest at a reasonable rate of interest which remained fixed throughout the duration of the note. All notes required that repayment be amortized in level payments, not less than quarterly, over a period not extending beyond five years from the date of the note or ten years for notes to acquire a principal residence.

Vesting

Participants were 100% vested in their contributions and safe harbor matching contributions. A participant's interest in the discretionary nonelective contributions the Club made to the Plan became 100% vested upon attaining the Plan's normal retirement age or if employment was terminated due to death or disability. If employment was terminated prior to normal retirement age for any reason other than death or disability, the participant's interest in Club discretionary nonelective contributions became vested in accordance with specific vesting schedules based on years of service as follows:

Forfeitures

Upon termination of service, a participant would forfeit the non-vested portion of their employer account. Forfeitures were retained in the Plan and used to pay administrative expenses. Any remaining amounts were used to reduce Club contributions payable under the Plan. Forfeitures of \$3,597 and \$2,075 were used to offset the Club contributions for the period January 1, 2022 to July 29, 2022, and the year ended December 31, 2021, respectively. As of December 31, 2021, forfeited non-vested accounts totaled \$3,597.

Payment of benefits

Participants were eligible for distributions of their vested account balances upon the event of death, disability, retirement, termination of employment, or the attainment of age 59 1/2. If the value of the participant's account balance was less than \$1,000, the payment was made in cash in a single lump sum without the participant's consent. If the value of the participant's account balance was greater than \$1,000, the participant could elect to receive either a lump-sum payment or installment payments equal to the value of the participant's vested interest in their account, or a life annuity as specified in the basic plan document. Any taxable distribution paid directly to the participant was subject to mandatory federal income tax withholding of 20% of the requested distribution.

Note 2 - Summary of Accounting PoliciesBasis of accounting

The 2022 financial statements of the Plan are prepared on the liquidation basis of accounting. The 2021 financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Club to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation and net appreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

Benefit payments

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Club. Expenses that are paid by the Club are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation and net appreciation in fair value of investments.

The Club has evaluated subsequent events through April 25, 2023, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 29, 2022 and December 31, 2021.

- Money market fund – Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily net asset value ("NAV") and to transact at that price. The money market fund is deemed to be actively traded.
- Mutual fund – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- Collective trust – Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liability. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV.

Note 4 - Tax Status

The Club adopted a non-standardized pre-approved profit sharing plan with CODA which received an opinion letter dated June 30, 2020, in which the IRS stated that the non-standardized plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended and restated since receiving the opinion letter. However, the Club believes that the Plan was designed, and was operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Club to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at July 29, 2022 and December 31, 2021, and net depreciation in fair value of investments, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by the Club and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

Note 6 - Party in Interest Transactions and Related Party Transactions

Certain Plan investments were shares in a money market fund, shares in mutual funds, or units in a collective trust managed by Fidelity Investments. Fidelity Investments was the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Note 7 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
