INDEPENDENT AUDITORS' REPORT

To the Plan Trustee
Corporate Business Solutions 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Corporate Business Solutions 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of July 29, 2022 (date of liquidation) and December 31, 2021 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to July 29, 2022 (date of liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Corporate Business Solutions 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 29, 2022 (date of liquidation) and December 31, 2021 (in liquidation), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Corporate Business Solutions 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of Corporate Business Solutions 401(k) Plan approved a plan of liquidation on December 8, 2021, and management determined liquidation is imminent. As a result, the Plan is using the liquidation basis of accounting to present July 29, 2022 and December 31, 2021 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Corporate Business Solutions 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Corporate Business Solutions 401(k) Plan's internal control. Accordingly, no such opinion is expressed.

Note 1: DESCRIPTION OF THE PLAN

The following description of the Corporate Business Solutions 401(k) Plan (the Plan) provides only general information. Refer to Plan documents for a more complete description of Plan provisions.

General

The Plan is a defined contribution plan covering substantially all full time employees of the Southeastern Employee Benefits Group, Inc. d/b/a Corporate Business Solutions (the Company, Sponsor, Employer, or Plan Administrator). The Company, a professional employer organization, is the sponsor of the Plan which is a multiple employer plan in which various unrelated employers participate. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustee is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustee.

Plan assets are held and managed by John Hancock Life Insurance Company (U.S.A.) (John Hancock), which invests contributions and Plan earnings, makes investment transactions as directed by the Investment Committee and provides certain recordkeeping services. The Retirement Advantage, Inc. (TRA) acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

On December 8, 2021, the Plan Administrator and Management of the Plan approved the termination of the Plan effective December 31, 2021. All Plan assets were liquidated by July 29, 2022 (date of liquidation). See Note 8.

The following is a description of the Plan prior to termination:

Eligibility

Employees may become a participant of the Plan when they have completed one hour of service with the Company.

Contributions

Employee contributions to the Plan are made through pre-tax salary deferrals not to exceed the amount allowable by law for income tax purposes. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching contributions, as determined prior to the end of the plan year, equal to a percentage of the participant's elective deferrals. Each participating employers' adoption agreement determines the Company's matching contribution. The Company may also make a qualified non-elective contribution or a profit sharing contribution. Both of these contributions are discretionary.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in each Company's matching and discretionary profit sharing is determined in each Company's adoption agreement.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments, as provided for by the Plan. For termination of service for a reason other than normal retirement, death or disability, a participant may receive the value of the vested interest in his or her account as provided for by the Plan.

Forfeitures

At July 29, 2022 (date of liquidation) and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$8,833 respectively. These accounts will be used to pay Plan expenses or to reduce future employer contributions.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Due to the decision to terminate the Plan effective December 31, 2021, the financial statements as of July 29, 2022 and December 31, 2021, have been prepared using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting that would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value, but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements and NAV.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of July 29, 2022 (date of liquidation) or December 31, 2021.

Payment of Benefits

Distributions to participants are recorded when paid.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses

Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances, unless paid by the Employer. During the period ended July 29, 2022 (date of liquidation), expenses of \$12,160 were paid by the Plan and allocated to participant accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, May 12, 2023 and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at July 29, 2022 (date of liquidation) and December 31, 2021.
- b) Notes receivable from participants included in the statements of net assets available for benefits at July 29, 2022 (date of liquidation) and December 31, 2021.
- c) Investment income and interest income from notes receivable information included in the statement of changes in net assets available for benefits for the period ended July 29, 2022 (date of liquidation).
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All amounts included in Note 5, *Guaranteed Interest Accounts*.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021. All investments were fully liquidated at July 29, 2022.

Guaranteed interest accounts: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

Pooled separate accounts: The Plan's pooled separate accounts are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV based investments have been excluded from the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

(A) Investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statement of Net Assets Available for Benefits.

- (1) Guaranteed interest accounts guarantee the return of principal plus compound interest earned over a defined 3-, 5- or 10-year term, less any applicable contract or participant-level recordkeeping charges, provided all contributions remain in the account until the end of the guarantee period. Interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed interest account in that month. Contributions under a group annuity contract can be allocated to guaranteed interest accounts (referred to as guaranteed accounts), which are not, by definition, an investment contract, but rather are an investment option offered under the John Hancock group annuity contract.
- (2) Aggressive growth funds seek long-term growth of capital. The funds normally invest approximately 100% of assets in underlying funds, which invest primarily in equity securities or they may have an equity/fixed-income fund allocation of 90%/10%. There are no restrictions on redemptions of these investments and fair value is based upon net asset values of the underlying investments held by the funds.
- (3) Conservative funds seek the maximum current income that is consistent with maintaining liquidity and preserving capital. The fund intends to maintain a stable \$1 share price. There are no restrictions on redemptions of these investments and fair value is based upon net asset values of the underlying investments held by the funds.
- (4) Growth and income funds seek current income, long-term growth of capital and income, and preservation of capital. To pursue these goals, the funds allocate investments among a diversified mix of debt and equity securities. With regard to the funds' equity securities, the managers look for companies that appear to be undervalued compared to their historical valuations relative to the market. The fund's debt securities are used to enhance current income and provide some stability. There are no restrictions on redemptions of these investments and fair value is based upon net asset values of the underlying investments held by the funds.

Note 4: FAIR VALUE MEASUREMENTS (Continued)

- (5) Growth funds seek long-term growth of capital. The funds normally invest approximately 80% of its assets in underlying funds that invest primarily in equity securities, and approximately 20% in underlying funds that invest primarily in fixed-income securities. There are no restrictions on redemptions of these investments and fair value is based upon net asset values of the underlying investments held by the funds.
- (6) Income funds seek a high level of current income by primarily investing in foreign debt securities of developed and emerging markets, U.S. government and agency securities and U.S. high yield bonds. The funds may also invest in preferred stock and other types of debt securities. There are no restrictions on redemptions of these investments and fair value is based upon net asset values of the underlying investments held by the funds.
- (7) Lifestyle funds invest in different percentage combinations of stocks and bonds based on the different objectives. The funds offer instant and broad diversification with exposure to a wide range of asset classes and investment styles. There are no restrictions on redemptions of these investments and fair value is based upon net asset values of the underlying investments held by the funds.

Fair Value of Investments that Calculate Net Asset Value

Note 5: GUARANTEED INTEREST ACCOUNTS

The Plan entered into guaranteed interest contract with John Hancock Life Insurance Company (U.S.A.) (John Hancock) totaling \$10,205 for 2021. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the statements of net assets available for benefits at fair value as determined using the market approach based on market prices of similar contracts. The contracts are not considered fully-benefit responsive as described in FASB ASC 946-210, *Financial Services - Investment Companies*, as the contracts may be subject to a market value adjustment depending on the amount and recipient fund, certain withdrawals may be subject to a market value adjustment depending on the withdrawal amount and the reason for the withdrawal, certain transfers from certain sub-accounts may be subject to a redemption fee as set by the underlying fund manager and depending on the holding period of the underlying fund, and a contract charge may be applied at contract termination, per the contract specifications.

The contract value, which approximates fair value, of the investment contracts at July 29, 2022 (date of liquidation) and December 31, 2021 was \$0 and \$10,205, respectively. Rate of interest for 2022 was 0.50% (5 year contracts). Rates of interest for 2021 were 0.30% (5 year contracts), and 0.40% (10 year contracts).

Note 6: TAX STATUS

On January 1, 2016, the Plan adopted a Volume Submitter Profit Sharing Plan with CODA which received an opinion letter dated March 31, 2014. The letter indicates that the Plan and related trust are designed in accordance with the applicable regulations of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter and the Volume Submitter Profit Sharing Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6: TAX STATUS (Continued)

Tax positions are recognized only if it is “more likely than not” that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts managed by John Hancock and guaranteed interest accounts (Note 5) with John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 8: PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On December 8, 2021, the governing body of Corporate Business Solutions 401(k) Plan approved the termination of the Plan effective December 31, 2021. At the termination, participants became 100% vested in the contributions. The Plan was fully liquidated as of July 29, 2022.
