## INDEPENDENT AUDITORS' REPORT

To the Management

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of MG, LLC 401(K) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 1, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 through July 1, 2022 and for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of MG, LLC 401(K) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - Description of Plan

The following description of the MG, LLC 401(K) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Document, as amended, for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan with an I.R.C. Sec 401(k) provision covering all employees of the Company who meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan including monitoring of investment performance and determining appropriate investment offerings.
- B. Eligibility Requirements - Each employee who is not a non-resident alien, covered by a collective bargaining agreement, or considered an intern or seasonal employee is eligible to participate in the Plan when they have completed sixty days of service and attained the age of twenty-one.
- C. Employee Contributions - Eligible employees may make a voluntary tax deferred contribution of 1% to 100% of their pre tax annual compensation to the Plan to a maximum of \$20,500 and \$19,500, which is the maximum dollar limit set by law for the years ended December 31, 2022 and 2021, respectively.

Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up contributions." For the years ending December 31, 2022 and 2021, the maximum catch-up contributions were \$6,500.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

On January 1, 2022, the Plan froze and all participants in the Plan became participants in the Willis Towers Watson Savings Plan for U.S. Employees, which is sponsored by Willis Towers Watson US LLC, an affiliate of the entities participating in the Plan. As a result, no employee or employer contributions were permitted to enter the Plan for the period from January 1, 2022 through July 1, 2022.

- D. Employer Contributions - The employer may make a discretionary matching contribution of the participants' elective deferral. As a result of the Plan freeze referenced in the employee contributions section above, there were no employer contributions for the period from January 1, 2022 through July 1, 2022. For the year ended December 31, 2021, the employer matched salary deferred contributions at a rate of 100% of the first 1%, and 50% of the next 5% of participant's compensation. Employer matching contributions were \$2,706,368 for the year ended December 31, 2021. Additional profit sharing amounts may be contributed at the option of the Company's Board of Trustees. For the year ended December 31, 2021, the employer elected not to make profit sharing contributions.

- E. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the employer's contribution, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specified participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- F. Payment of Benefits - A participant will receive a lump sum amount equal to the value of the individual's account upon termination of service due to death, disability, or upon attaining a Normal Retirement age or an early Retirement benefit if certain age and service requirements are met. Participants with vested balances that do not exceed \$1,000 will receive a lump sum payment as soon as administratively feasible following termination. Participants with vested balances that exceed \$1,000 but do not exceed \$5,000 who do not consent to a lump sum payment will automatically be rolled over into an individual retirement account. If total vested benefits exceed \$5,000, no distribution is made from the Plan without consent of the participant.
- G. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Participants become fully (100%) vested in the employer contribution upon the occurrence of death and total or permanent disability.

Other than as stated above, employer contributions vest based upon the following:

A year of vesting service is a vesting service period in which an employee has at least 1,000 hours of service, and is based on the plan year.

- H. Income Tax Status - The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Income Tax Status (Continued) - Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

- I. Forfeited Accounts - Any participant who terminates employment without being fully vested (100%) in their employer contribution account forfeits their unvested portion of the employer contribution. At July 1, 2022, there was no balance in the forfeited nonvested accounts. At December 31, 2021 the balance in forfeited nonvested accounts was \$27,064. These accounts are used to reduce future employer contributions or offset Plan expenses. During 2022 and 2021, Plan expenses of \$6,883 and \$7,875 were offset by forfeited nonvested accounts, respectively.

NOTE 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are a representation of the Plan's management, who is responsible for their integrity and objectivity. The accounting policies described below conform to accounting principles generally accepted in the United States of America and have been applied consistently in the preparation of the financial statements.

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment Benefits - Benefits are recorded when paid.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no contributions in excess of amounts allowed by the IRS during the period from January 1, 2022 through July 1, 2022. The Plan distributed the 2021 excess contributions to the applicable participants prior to March 15, 2022.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant's accounts, notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through May 10, 2023, which is the date the financial statements were available to be issued.

**NOTE 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 1, 2022 and December 31, 2021.

*Separate Investment Accounts:* Valued based on the net asset value ("NAV") of the underlying assets owned by the separate account, minus its liabilities, and then divided by the number of shares outstanding.

*Registered Investment Companies:* Share values are calculated based on the observable net asset value ("NAV") of the underlying investment and are valued at the daily closing price as reported by the fund. Shares of mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* The investment in common collective trusts (CCT) was formed for the purpose of allowing participating plan sponsors to invest in group annuity contracts. The CCT is valued at its net asset value (NAV). The NAV is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 - Investment Contract with Insurance Company**

During 2022 and 2021, the Plan maintained a fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company. Great-West Life & Annuity Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administration expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. There were no investments at contract value at July 1, 2022. The contract value of the investment contract at December 31, 2021 was \$1,336,094. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis.

Certain events limit the Plan's ability to transact at contract value with Great-West Life & Annuity Insurance Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, or (e) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 - Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of July 1, 2022 and December 31, 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, whichever is less. Loan transactions are treated as transfers between the investment fund and the Participant Loan Fund. Loan terms range from one to five years, except for loans for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 5.50%, which are commensurate with local prevailing rates as determined by the Plan's administrator. Principal and interest is paid ratably through payroll deductions. There were no balances outstanding at July 1, 2022. Balances outstanding at December 31, 2021 were \$395,288.

NOTE 7 - Plan Merger

On July 1, 2022 the Plan merged into the Willis Towers Watson Savings Plan for U.S. Employees. The transferred net assets have been recognized in the accounts of the Willis Towers Watson Savings Plan for U.S. Employees as of July 1, 2022, at their balances as previously carried in accounts of the MG, LLC 401(K) Savings Plan. The changes in net assets of the combined plans are included in the accompanying statement of changes in net assets available for benefits from July 1, 2022. NOTE 8 - Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - Related Party Transactions

Certain plan investments are administered by Great-West Life & Annuity Insurance Company and Reliance Trust Company. Great-West Life & Annuity Insurance Company and Reliance Trust Company are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and administrative services amounted to \$130,006 and \$267,710 for the period from January 1, 2022 through July 1, 2022 and the year ended December 31, 2021, respectively.
