Opinion on the Financial Statements

We have audited the financial statements of Cox & Company, Inc. Stock Bonus Plan and Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of July 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through July 31, 2022, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Cox & Company, Inc. Stock Bonus Plan and Employee Stock Ownership Plan as of July 31, 2022 and December 31, 2021, and the changes in its net assets available for benefits for the period from January 1, 2022 through July 31, 2022, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the Financial Statements

Employee Stock Ownership Plan. In connection therewith, all of the assets were transferred and incorporated into the Cox & Company, Inc. Employee Stock Ownership Plan July 31, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Cox & Company, Inc. Stock Bonus Plan and Employee Stock Ownership Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Cox & Company, Inc. Stock Bonus Plan and Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

Cox & Company, Inc. (the "Company," the "Plan Sponsor") originally established the Cox & Company, Inc. Stock Bonus Plan in January 1957. Effective December 1, 2003, the Company amended and restated the existing Stock Bonus Plan to the Stock Bonus Plan and Employee Stock Ownership Plan, which includes the Plan and the related Trust Agreement, and such Plan was further amended and restated effective January 1, 2015.

The Plan is set up for the benefit of the Company's employees, invested primarily in the stock of the Company ("Company Stock") and has a year end of December 31 ("Plan Year").

Effective July 31, 2022, the Plan was merged into the Company's Employee Stock Ownership Plan. As a result, all investments in the amount of \$10,829,283 were transferred from the Plan into the Company's Employee Stock Ownership Plan on that date.

PLAN ADMINISTRATION

The Plan is administered by the Board of Directors of the Company. TI-TRUST, Inc. is the Trustee and Custodian of the Plan (the "Trustee").

ELIGIBILITY

All employees who were participants in the Plan on December 31, 2003 were automatically eligible to participate in the Plan. All other employees of the Company who (1) were not covered by a collective bargaining agreement excluding participation or (2) were not leased employees were eligible to participate in the Plan as of the Plan entry date coinciding with their date of hire or if their hire date was not an entry date then on the next entry date ("Enrollment Date"). The Plan Enrollment Dates were January 1 and July 1. The Company, effective, December 31, 2013, froze the Plan.

CONTRIBUTIONS AND OTHER PLAN FUNDING

The Company is taxed as an S Corporation. Any S Corporation distributions paid by the Company on Company Stock owned by the Plan are added to the participant account balances or distributed to the participants.

The Company, under the Plan, is allowed to make discretionary contributions of either shares of the Company or cash up to an amount deductible by it under the Internal Revenue Code ("IRC") ("Company Contributions"). During the period ended July 31, 2022, the Company made no discretionary contributions to the Plan as it has been frozen and was merged into the Company's Employee Stock Ownership Plan.

Employee contributions are not permitted.

PARTICIPANT ACCOUNTS

The Plan is a defined contribution plan under which a separate account is established for each participant. Each participant's account is credited or charged annually with (1) the participant's allocation of the Company's contribution and forfeitures and (2) a proportional share of any gains or losses from the change in value of Company Stock, S Corporation distributions received on Company Stock or other investment income or expense.

VESTING

The Company, effective December 31, 2013, froze the Plan resulting in all participants becoming 100% vested as of that date.

DISTRIBUTIONS

Under the terms of the Plan, the distribution policy may be amended from time to time by the Company. Distributions are recorded when paid. The current distribution policy is described below:

Eligibility and Form of Payment

A participant shall be entitled to receive distributions in cash, of their vested account balance upon termination of service due to death, disability or normal retirement.

To enable cash payment by the Plan to a participant, the Company is required to purchase the vested Company Stock in the participant's account at its fair market value.

DISTRIBUTIONS (CONTINUED)

Distributions Due to Retirement, Death or Disability

If a participant retires at normal retirement age, dies or is disabled (“Current Separation Event”) the participant can elect, on an annual basis, to receive a distribution. If an election is made, the fair market value of the balance of the participant’s account will be paid on an installment basis. In the event that a participant dies, the beneficiary will be paid the full balance of the participant’s account by December 31 following the fifth anniversary of the participant’s death.

If a distribution is elected in the year that the Current Separation Event occurs, the distribution will be made before the end of the current Plan Year if the Current Separation Event occurs before November 1 and in the following year if it occurs on or after November 1. Elected distributions made after the year of the Current Separation Event will be paid by the end of the following Plan Year in which the election is made.

Other Distributions

If a participant terminates employment other than for retirement, death or disability (“Terminated Employee”) and the fair market value of the participant's vested account balance is less than \$10,000, the participant can elect, in the year of termination or any year thereafter, to receive a distribution. If the participant's vested account balance is more than \$10,000 the participant can elect, in the year after reaching normal retirement age or any year thereafter, to receive a distribution. If consent to a distribution is not given prior to death or the later of reaching age 62 and completion of a five-year break in service, the participant's vested balance will be distributed. The Plan can automatically distribute any participant balance under \$1,000. If the Terminated Employee's vested account balance is to be distributed ,it will be paid as a lump sum payment no later than the end of the following plan year in which the election is made.

The Plan, at the Plan Administrator's discretion, may make distributions in the event of participant conflicts of interest, as defined.

Timing and Calculation of Distributions

You must begin to receive your benefits no later than April 1st of the calendar year following the calendar year in which you reach age 70 ½ (if on or before 12/31/19; or if not, then the calendar year in which you reach age 72) only when you are no longer employed by the Company.

Fair Market Value for Distributions

Fair market value of a participant's account is determined, at each distribution date, using the fair market value of the Company Stock and other investments in the participant's account as of the previous Plan Year end.

The fair market value of Company Stock is determined by the Plan Trustee, as of the December 31 year end of the Company or other valuation date determined by the Plan Trustee.

ADMINISTRATIVE EXPENSES

The Company may but is not obligated to pay the administrative expenses of the Plan. For the period ended July 31, 2022, all expenses of the Plan were paid for by the Company.

VOTING RIGHTS

The Plan's Trustee, using its discretion as to what is in the best collective interest of the Plan participants, generally votes all shares of the Company Stock held by the Plan with respect to all corporate matters which Company shareholders are entitled to vote. However, each participant is entitled to direct the Plan Trustee as to the voting of shares in his or her account with respect to approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution and sale of substantially all assets of the Company.

PUT OPTION

Under federal income tax regulations, the Company Stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

CASH AND CASH EQUIVALENTS

The carrying amounts for cash reflect the assets' fair value. Included in the cash and cash equivalents balance as of July 31, 2022 and December 31, 2021 is \$-- and \$143,687, respectively, which is segregated for terminated participant accounts.

INVESTMENT VALUATION AND INCOME RECOGNITION

Substantially all of the Plan's assets at December 31, 2021 and assets transferred to ESOP as of July 31, 2022 were in the form of Company Stock. See Note 4 for a discussion of the fair value measurements. Since the Company is closely held, and there is no public market for its Company Stock, the Trustee obtains an annual appraisal performed by an independent appraiser to assist it in determining the Company Stock value. The appraisal is performed as of the close of business on December 31 of each Plan Year or other valuation date as determined by the Plan Trustee.

Interest income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

All of the Plan's investments, at December 31, 2021 and transferred to ESOP on July 31, 2022, consisted of Company Stock which had a fair market value of \$11,191,143 and \$10,685,189, respectively, and are classified within level 3 of the fair value hierarchy.

The fair value of the Company Stock is approved by the Plan Trustee on an annual basis.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company Stock. The Plan has a number of service providers. Such service providers are parties in interest under Employee Retirement Income Security Act of 1974 (“ERISA”). Certain employees and officers of the Company perform administrative services to the Plan at no cost to the Plan, and as such are considered to be parties in interest to the Plan.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan's investments are in Company Stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Market risks include global events which could impact the value of Company Stock, such as pandemic or international conflict. Due to the level of uncertainty related to changes in value of the Company Stock, it is reasonably possible that changes in the near term would materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 7 - PLAN TERMINATION AND AMENDMENT

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan subject to the provisions of ERISA. Upon termination, the Plan at the discretion of the Company, may distribute the participant account balances to the participants or distribute the participant account balances in accordance with the distribution section of the Plan. Effective July 31, 2022, the Plan was merged into the Company's Employee Stock Ownership Plan.

NOTE 8 - TAX STATUS

The Plan is a qualified benefit plan under Section 401(a) of the IRC, and therefore is not subject to taxation under present income tax laws. The Plan received a favorable Internal Revenue Service ("IRS") determination letter dated August 2, 2017. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events for recognition or disclosure through the date that the financial statements were available for issuance, May 12, 2023.
