Scope and nature of the ERISA Section 103(a)(3)(C) audit

NOTES TO FINANCIAL STATEMENTS

July 15, 2022 and December 31, 2021

NOTE A - DESCRIPTION OF PLAN

The following description of the Dura Automotive Systems 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution savings plan covering all employees of DUS Operating, Inc. (the "Company") and its U.S. subsidiaries.

Employees are eligible to participate in the Plan upon completion of 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Employee Benefits Committee of the Company is responsible for oversight of the Plan as well as determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective July 1, 2022, all Fremont union Dura employees merged to a new plan named Megalodon Fremont Union Plan ("Union Plan"). Employees who were previously participants in the Plan became participants of the Union Plan effective July 1, 2022.

Effective July 15, 2022, all other Dura employees merged into the Non-Union Employees 401(k) Plan ("Non-Union Plan"). Employees who were previously participants in the Plan became participants of the Non-Union Plan effective July 15, 2022.

Contributions

Each year, participants may contribute up to 75% of eligible compensation, as defined by the Plan subject to Internal Revenue Code ("IRC") limits. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers) and can contribute between 1% and 3% of their earnings on an after-tax basis. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Effective January 1, 2018, automatically enrolled participants have their deferral rate set at 3% (previously 2%) of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company's matching contributions are equal to 100% of the first 3% of the participant's salary deferral and 50% on the next 2% of the participant's salary deferral, which cannot exceed 4% of the Participant's compensation. Effective May 1, 2020, the Company elected to suspend Company matching contributions, however, the Company elected to reinstate Company matching contributions effective January 1, 2021. There were no discretionary contributions for the period January 1, 2022 through July 15, 2022.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings and losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, rollover contributions, and the Company's matching and discretionary contributions. These amounts are 100% vested and cannot be forfeited for any reason.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance or \$50,000, whichever is less. Participants may only have one loan outstanding at any given time. The loans are secured by the balance in the participant's vested account, and interest on the loan is determined by the Plan administrator based on the prevailing interest rates charged by financial institutions. Loan maturities must not be greater than five years but can be extended to a reasonable amount of time for the purchase of a primary residence. The principal and interest are paid ratably primarily through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, the participant's account balance shall be paid to the participant or the participant's beneficiary. The Plan also permits the participant's account balance to remain in the Plan until the participant elects a distribution as a lump-sum payment or a direct rollover into another plan or an Individual Retirement Account. A participant who has attained age 59½ or is experiencing a financial hardship may request a withdrawal of a portion of his or her vested account. Required minimum distributions are required when participants reach age 72.

Forfeited Accounts

As of July 15, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$1,056, respectively. Forfeitures are used to reduce future Company contributions and pay administrative expenses. For the period January 1, 2022 through July 15, 2022, \$2,888 of forfeited non-vested accounts were used to pay administrative expenses.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employee Benefits Committee of the Company determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of July 15, 2022 or December 31, 2021. Interest rates on loans outstanding as of July 15, 2022 and December 31, 2021 ranged from 4.25% to 9.5%. If a participant ceases to make loan repayments and the Company deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through May 12, 2023, the date the financial statements were available to be issued.

NOTE C - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator determined that the certification received from the Trustee meets the requirements of ERISA Section 103(a)(3)(C). The Trustee certified that the following data included in the financial statements are complete and accurate:

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of July 15, 2022 and December 31, 2021.
- Net investment loss and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 through July 15, 2022.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S.GAAP.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the (Level 2) input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the period January 1, 2022 through July 15, 2022 and as of December 30, 2021.

Money market fund: These investments include short-term instruments and cash and are valued based on quoted market prices.

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account: Valued at the fair value of the underlying investments based upon publicly quoted prices to determine the NAV of the pooled separate account, which is not publicly quoted. The Plan applied the practical expedient to determine the fair values of the pooled separate account of the Plan based on the NAV as of December 30, 2021. There were no investments as of July 15, 2022.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are investments managed by Fidelity, the Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan permits notes receivable from participants. These also qualify as party-in-interest transactions. These are exempt from prohibited transaction rules under ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

NOTE F - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. See Note A for discussion of the merger.

NOTE G - TAX STATUS

The Company adopted a pre-approved plan document created by Fidelity Management and Research Company ("FMR"). FMR received an advisory letter from the Internal Revenue Service ("IRS"), dated November 5, 2018, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. Because the Plan has adopted a pre-approved plan document that has received a favorable advisory letter from the IRS, the Plan can rely on the advisory letter as evidence that the Plan is qualified under IRC section 401(a) to the extent prescribed by the IRS in applicable revenue procedures. Although the Plan has been amended since the prototype plan received the advisory letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 15, 2022 and December 31, 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
