Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Plymouth Tube Company 401(k) Savings Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 18, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 to July 18, 2022 and the related notes to the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Emphasis-of-Matter – Plan Merger

As further discussed in Note 1, the Plan was merged into the Aon Pooled Employer Plan effective July 15, 2022. Our opinion is not modified with respect to this matter.

Note 1. Plan Description

The following brief description of the Plymouth Tube Company 401(k) Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined-contribution plan covering eligible employees of Plymouth Tube Company and Plymouth Specialty Manufacturing, LLC (together, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 15, 2022, the Plan merged into the Aon Pooled Employer Plan. All assets were transferred into the Aon Pooled Employer Plan on July 18, 2022.

Eligibility: Employees who are not covered by a collective bargaining agreement and complete 1 month of service are eligible to participate in the Plan immediately following meeting eligibility requirements. Pursuant to certain collective bargaining agreements, collectively bargained employees at the Winamac and East Troy locations are eligible to participate effective January 1, 1998 and January 1, 2005, respectively.

Contributions: Participants may contribute between 2 percent and 100 percent of annual compensation, as defined by the Plan, up to limits set by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of compensation. The Plan also includes an auto-deferral increase of 1 percent per year up to a maximum deferral rate of 15 percent. Participants may change their deferral rates at any time.

For participants not covered by a collective bargaining agreement, the Company may make a discretionary matching contribution. In 2022, the Company made a discretionary matching contribution of 100 percent of participant salary deferrals up to 3 percent of compensation, and then 50 percent of the salary deferrals between 3 and 5 percent of compensation.

For participants at the Plymouth Specialty Manufacturing location, the Company made a discretionary matching contribution of 100 percent of participant salary deferrals up to 5 percent of compensation.

For collectively bargained employees at the Winamac location, Company contributions per the agreement dated October 11, 2021, between the Company and the International Union, United Automobile, Aerospace and Agricultural Workers of America, U.A.W., and its affiliated Local Union No. 1448 for the employees located at the Winamac location, Company will match 100 percent of participant salary deferrals up to 3 percent of compensation, and then 50 percent of the salary deferrals on the next 2 percent of compensation.

In addition, the Company's Board of Directors can determine the amount of any additional profit-sharing contributions to be made. There were no additional profit-sharing contributions during the year ended July 18, 2022.

Contributions are subject to limitations.

Note 1. Plan Description (Continued)

Investment options: Upon enrollment in the Plan, a participant may direct contributions in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Participant accounts: Each participant's account is credited with the participant's contribution, Company matching contribution, if any, as well as allocations of the Company's profit-sharing contributions, if any, and Plan earnings/losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and the earnings thereon. Vesting in company contributions made prior to the January 1, 2006 safe-harbor amendment, the earnings thereon and vesting for company contributions for employees covered by collective bargaining agreements is determined in accordance with the following schedule:

Less than 1 year	0%
1 year but less than 2 years	20%
2 years but less than 3 years	40%
3 years but less than 4 years	60%
4 years but less than 5 years	80%
5 years or more	100%

Regardless of the vesting schedule above, discretionary matching contributions for non-union employees whose employment commencement date is on or after April 1, 2021 will be subject to the following vesting schedule:

Less than 1 year	0%
1 year but less than 2 years	25%
2 years but less than 3 years	50%
3 years but less than 4 years	75%
4 years or more	100%

Discretionary matching contributions for non-union employees whose employment commencement dates are prior to April 1, 2021 will be 100% vested at all times. Upon reaching age 65 or if the participants terminate employment due to death or disability, they are 100 percent vested in their account balances.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance, whichever is less. Only 1 loan may be outstanding at any time. The loan prepayment period is not to exceed 5 years, except for the purchase of a principal residence, in which case the repayment period is not to exceed 15 years. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1 percent above the prime rate. Principal and interest are paid ratably through payroll deductions.

Note 1. Plan Description (Continued)

Payment of benefits: On termination of service due to death, disability, or retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Partial payments are allowed in the minimum amount necessary to satisfy IRC 401(a)(9). In-service withdrawals prior to termination of service are allowed for any reason after attaining age 59-½.

Forfeited accounts: At July 18, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$17,078, respectively. Forfeitures may be used to pay administrative expenses of the Plan or to reduce Company contributions. During the period ended July 18, 2022, forfeited nonvested amounts of \$18,544 were used to pay Plan expenses.

Other income: Empower, the Plan's record-keeper, receives revenue sharing payments from shares of registered investment companies and collective trust funds in which Plan assets are invested. The administrative services agreement between the Plan and Empower provides that a portion of the revenue sharing payments received by Empower will be credited to the Plan. For the period ended July 18, 2022, \$64,676, was credited to the Plan under this agreement. The balance in the ERISA Credit Account, which holds these revenue sharing payments was \$0 and \$20,575 at July 18, 2022 and December 31, 2021, respectively. At July 18, 2022, \$46,132 was used for Plan expenses.

Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) in fair value of investments.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through May 11, 2023, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at July 18, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2022 to July 18, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (Empower), the trustee of the Plan.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Shares of registered investment companies – Valued at the daily closing price as reported by the fund. Shares held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These shares are required to publish their daily net asset value (NAV) and to transact at that price. The shares held by the Plan are deemed to be actively traded.

Note 4. Fair Value Measurements (Continued)

Common/collective trust funds – Value based on the NAV of units of the common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Note 5. Related Party and Party-in-Interest Transactions

Empower is the custodian and trustee of the Plan, as defined by the Plan, and therefore, transactions with Empower qualify as party-in-interest.

Sheridan Road Advisors, LLC provides investment advisory services to the Plan. Transactions with Sheridan Road Advisors, LLC qualify as party-in-interest transactions.

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan.

Certain other administrative expenses are paid by the Company on behalf of the Plan. These amounts are not material to the financial statements.

Note 6. Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by Great-West Trust Company, LLC. The pre-approved plan has received a letter from the Internal Revenue Service, dated June 30, 2020, stating that the pre-approved plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan Administrator believes that the Plan is designed and is currently operating in compliance with applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
