

NOTE A - Description of Plan

The following description of the **Seligman & Associates, Inc. 401(k) Profit Sharing Plan** provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Transfer - Plan management adopted a resolution to transfer the net assets available for benefits into the Seligman Group Retirement Plan, a pooled employer plan, as of July 30, 2022.

General - The Plan is a defined contribution plan covering all employees that have attained the age of twenty-one, except non-resident alien employees with no U.S. source income, collectively bargained employees, and leased employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became a safe-harbor 401(k) plan effective January 1, 2020.

Contributions and eligibility - Each year, participants may contribute pretax compensation, as defined in the Plan, subject to the annual maximum set by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan permits Roth (401k) deferrals. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants may change their investment options and deferral amounts daily. In addition, the Company shall contribute one of the safe harbor matching contributions equal to a uniform percentage of each participant's deferred compensation, as determined by the Board of Trustees each year. The Plan permits the employer to contribute a discretionary profit-sharing contribution. All active participants that have reached the age of 21 shall be eligible to share in the matching contribution for the year. The Company elected to satisfy the safe harbor rules by making a matching contribution equal to 100% of participant salary deferrals that do not exceed 5% of compensation.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after two years of credited service.

Notes receivable from participants - Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their account balance. Loans shall provide for level amortization with payments not to exceed five years. However, loans used to purchase a primary residence may exceed five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through weekly payroll deductions. Notes receivable from participants are valued at amortized cost, which approximates fair value.

NOTE A - Description of Plan (continued)

Payment of benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a period not to exceed the participant's life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum.

Forfeitures - Forfeited balances of terminated participants' non-vested accounts are first used to pay administrative expenses, then to reduce future Company contributions. For the period ended July 30, 2022 and the year ended December 31, 2021 forfeited non-vested amounts totaled \$47,946 and \$32,641, respectively.

NOTE B - Summary of Accounting Policies

Basis of accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Administrative expenses - Certain expenses of operating the Plan are paid for by the Plan Sponsor and are therefore not recognized as an expense in these financial statements. The Plan allows certain administrative expenses to be paid from Plan assets.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment valuation and income recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note G, Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plans gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid. There were no benefits requested before year-end that were not paid.

Date of management's review - Subsequent events were evaluated through May 15, 2023, which is the date the financial statements were available to be issued.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act") was enacted. The CARES Act contains provisions that will temporarily impact the Plan, including allowing certain eligible Plan participants to receive coronavirus-related distributions, delaying participant loan repayments and increasing the maximum amount of such participant loans, and suspending required minimum distributions. The Committee agreed to implement the provisions of the CARES Act that relate to the Plan effective April 5, 2020.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of July 30, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

NOTE C - Investment Information and Information Certified by the Custodian

Information certified by the custodian – For the year ended December 31, 2021, the Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under this election, no audit procedures have been performed with respect to information certified as complete and accurate by the custodians of the Plan. Empower Trust Company, LLC, held the Plan's investment assets and executed investment transactions from January 1, 2021 to December 31, 2021. The unaudited information included in the accompanying financial statements and supplemental schedule, which are certified by the custodian, is summarized below.

Investments and notes receivable from participants as shown on the statement of net assets available for benefits as of December 31, 2021.

Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2021.

NOTE D - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE E - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a favorable opinion letter dated March 31, 2014, that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE F - Related Party and Party-In-Interest Transactions

Certain administrative functions are performed by employees of the Company. No employee receives compensation from the Plan for these services.

Plan investments are held and executed by Empower Trust Company, LLC, the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services to the custodian and the third-party administrator amounted to \$37,889 and \$45,994 for the period ending July 30, 2022 and December 31, 2021, respectively.

NOTE G - Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that the plan has the ability to access.
- Level 2: Inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE H - Contract with Insurance Company

The Company maintained an investment contract and plan services agreement with Empower Trust Company LLC. Empower Retirement, the retirement services division of Empower Trust Company, LLC, performed record keeping for the allocation of employee and employer contributions, as well as the allocation of income or loss earned, to each participant's account.

NOTE I - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credits risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
