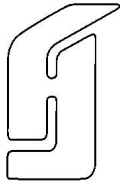

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Sentry Data Systems, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of July 27, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to July 27, 2022, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of July 27, 2022 and December 31, 2021 and for the period from January 1, 2022 to July 27, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP"), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a period of one year from the date of this report.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, due to the acquisition of Sentry Data Systems, Inc., the Plan merged into the Craneware, Inc. 401(k) Profit Sharing Plan & Trust ("Craneware Plan") effective July 27, 2022. The Plan transferred its net assets into the Craneware Plan and ceased operations as of that date. Our opinion is not modified with respect to this matter.

Notes to Financial Statements

At July 27, 2022 and December 31, 2021 and the Period from January 1, 2022 to July 27, 2022

(1) Description of Plan

The following description of the Sentry Data Systems, Inc. 401(k) Profit Sharing Plan (the "Plan") provides general information. The participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan was a defined contribution plan covering all employees of Sentry Data Systems, Inc. (the "Company") who had three months of service and were age twenty-one or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator was responsible for the oversight of the Plan and determined the appropriateness of the Plan's investment offerings and monitored investment performance.

The Plan was administered and sponsored by the Company. The Company engaged Transamerica Retirement Solutions, LLC ("Transamerica") to be the Plan's third-party record-keeper. Transamerica Life Insurance Company was the Plan's custodian and Reliance Trust Company ("Reliance") was the Plan's trustee.

Merger. On July 12, 2021, the Company was acquired by Craneware plc ("Craneware") and currently operates as a wholly-owned subsidiary of Craneware. Due to the acquisition of Sentry Data Systems, Inc., the Plan merged into the Craneware, Inc. 401(k) Profit Sharing Plan & Trust ("Craneware Plan") effective July 27, 2022 and all participants became fully vested in their account balances. The Plan transferred its net assets into the Craneware Plan and ceased operations as of that date.

Contributions. Each year, participants could make contributions to the Plan. Participants could elect to defer the receipt of a portion of their compensation on a pre-tax basis, not to exceed the maximum contribution limits specified by the Internal Revenue Code ("IRC"). Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants directed their contributions into various investment options offered by the Plan. The Company's matching contribution could be invested in different funds or in the same manner as the participant's own contribution allocations. Contributions were subject to certain limitations.

Participant Accounts. Each participant's account was credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings and account valuation increases or decreases. Allocations were based on participant earnings or account balances, as defined. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participation transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(1) Description of Plan, Continued

Vesting. Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions and earnings thereon was based on years of continuous service. Participants were fully vested after three years of credited service.

Notes Receivable from Participants. Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms could be up to five years. A longer term of up to ten years could be allowed if the loan was for the purchase of a principal residence. These loans were secured by the balance in the participant's account and bore interest at prevailing market rates as determined by the plan administrator. The loan interest rate was set at the loan origination date. Principal and interest were paid ratably through bi-weekly payroll deductions.

Payment of Benefits. Upon termination of service due to death, disability or retirement, a participant could elect to receive either a lump sum amount equal to his or her vested account balance, or annual installments over a ten-year period. Vesting in the Company's contributions of their account was based on years of continuous service. Upon termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution.

Participant Termination and Forfeitures. If at the time of termination of employment, the participant was not 100% vested, the nonvested portion ("forfeitures") of the participant's account was placed in a separate account and utilized to reduce future employer contributions or pay Plan expenses. During 2022, \$14,882 of forfeitures were used to reduce employer contributions. The unallocated forfeitures account balance at July 27, 2022 and December 31, 2021 was \$0 and \$1,411, respectively.

(2) Summary of Significant Accounting Policies

Basis of Presentation. The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP").

The following is a summary of the significant accounting policies:

Use of Estimates. The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ for those estimates.

Subsequent Events. Management has evaluated subsequent events through May 15, 2023, which is the date the financial statements were available to be issued, determining no events require additional disclosure in the financial statements.

Investment Valuation and Income Recognition. The Plan's investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability (at exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants. Notes receivable were measured at their unpaid balance plus any accrual but unpaid interest. Interest is recorded on the accrual basis. Related fees were recorded as administrative expenses and were recorded when a new loan was issued. If a participant ceased to make loan payments and the Plan administrator deemed the participant loan to be in default, the participant loan was reduced, and a benefit payment was recorded.

Contributions. Contributions were accrued and credited to participants' accounts as of each pay period.

Payment of Benefits. Benefits were recorded when paid.

Operating Expenses. Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation of fair value of investments.

(3) Plan Termination

The sponsor had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their total account balances. See "Merger" section under Note 1 for discussion of the Plan merger.

(4) Income Tax Status

The Company adopted a prototype 401(k) Profit Sharing Plan on December 16, 2011. The Plan was a prototype plan which received its determination letter on March 31, 2014 (updated on June 30, 2020) in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirement of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or the IRS. The Company has analyzed the tax positions taken by the Company, and has concluded that as of July 27, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

(5) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

(6) Information Certified by Custodian

The information contained in the financial statements, which was certified by the Plan's trustee, is as follows:

(7) Party-In-Interest and Related Party Transactions

Certain plan investments were managed by Transamerica, the record-keeper as defined by the Plan and Reliance, the Plan's trustee; therefore, these transactions qualify as party-in-interest transactions.

Additionally, the Company provided certain accounting and administrative services to the Plan for which no fees were charged, and certain Plan expenses were paid directly by the Company.

(8) Fair Value Measurements

GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. GAAP also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. GAAP describes three levels of inputs that may be used to measure fair value:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities that are not active; and model-driven valuations whose inputs are observable or whose significant value drivers are observable. Valuations may be obtained from, or corroborated by, third-party pricing services.

Level 3: Unobservable inputs to measure fair value of assets and liabilities for which there is little, if any market activity at the measurement date, using reasonable inputs and assumptions based upon the best information at the time, to the extent that inputs are available without undue cost and effort.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 27, 2022 and December 31, 2021.

Mutual Funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

Common Trust Funds. Valued at the NAV of units of a bank collective trust, which is based on the quoted market prices of the underlying investments of the funds, less any liabilities. There were no unfunded commitments and participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that investment liquidations will be carried out in an orderly business manner.

(8) Fair Value Measurements, Continued

The preceding methods described may produce a fair value calculation that may not be indicative of NAV or reflective of future fair values. Furthermore, although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
