Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Accelerated Solutions 401(k) Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of July 26, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the period ended July 26, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained a certification from a qualified institution as of July 26, 2022 and December 31, 2021, and for the period ended July 26, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Notes 1 and 7 to the financial statements, the governing body of the Plan approved a Plan liquidation on March 21, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Note 1—The Plan description

The following description of the Accelerated Solutions Cross-Tested 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description.

General – The Plan was established effective January 1, 2002 by Accelerated Solutions, LLC (the “Company”) as a defined contribution plan, which provides retirement, disability, and death benefits for all eligible employees electing to participate. The Plan was amended and restated effective January 1, 2009. The Plan incorporates provisions to permit qualification under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Termination – The Sponsor of the Plan approved a plan of termination on March 21, 2022, and management determined that liquidation was imminent. Final distributions were based on all participants being 100% vested. The investments held by the participants in the Plan were to be liquidated and the participants’ distributions options included rolling the proceeds to another qualified Employer Plan or an Individual Retirement Account or receiving a taxable distribution. As a result, the Plan changed its basis of accounting from the going concern basis used in the presentation of the 2021 financial statements to the liquidation basis used in presentation of the 2022 financial statements. All participant accounts were fully liquidated and distributed by July 26, 2022 (the “Termination Date”).

Contributions – Prior to the Plan’s termination, employees who were at least 18 years of age could participate in the Plan after three consecutive months of service. Employees could elect to commence salary deferred contributions on the first day of each Plan quarter. Participants in the Plan could elect to contribute through salary deferrals (payroll deductions) any amount up to 100% of their compensation, not to exceed the deferral limitation for a calendar year. The Plan also allowed Roth elective deferrals into the Plan.

The Company made a matching contribution equal to 25% of employee deferral contributions up to 4% of the participant’s eligible compensation. The Company could also make a discretionary profit sharing contribution to the Plan each year. In order to receive the matching or discretionary profit sharing contributions, the participant had to complete at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year. Participants terminated due to retirement, disability, or death were also eligible to receive the matching and discretionary profit sharing contributions. The Company made a profit sharing contribution of \$40,601 for 2022.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately 100% vested in their contributions, plus actual earnings thereon. Vesting in their allocated share of the Company’s matching and discretionary profit sharing contributions and Plan earnings thereon occurs in accordance with the following schedule:

Notwithstanding the above, a participant is fully vested upon reaching 65 years of age, termination by reason of disability or death during active employment. Due to the termination of the Plan, participants became immediately vested in their total balance beginning March 21, 2022, the effective date of the Plan termination.

Note 1—The Plan description (continued)

Payment of Benefits – Upon termination of service, death, disability, or retirement, a participant may receive a lump-sum amount or roll the account balance over into an individual retirement account or another qualified Plan. In-service distributions are allowed for immediate and heavy financial need, based on Plan provisions.

Hardship Withdrawals – The Plan allows participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant may request a hardship withdrawal for certain qualifying expenses as defined by the Plan document.

Forfeitures – Nonvested forfeitures are used to pay Plan expenses and reduce Company matching and discretionary profit sharing contributions. At July 26, 2022 and December 31, 2021, forfeited nonvested accounts held by the Plan totaled \$0 and \$5,562, respectively. During the period ended July 26, 2022, employer contributions of \$12,681 were paid from forfeited nonvested accounts

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) as of December 31, 2021. As discussed in Note 1, the Plan changed its basis of accounting from the going concern basis used in the presentation of the 2021 financial statements to the liquidation basis used in presentation of the 2022 financial statements.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements. The guaranteed interest accounts are not fully benefit responsive and are stated at contract value which approximates fair value.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation and appreciation in fair market value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – The Company provides staff without charge to assist in administration of the Plan. Fees related to participant recordkeeping are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment options in mutual funds and common/collective trusts. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Note 3—Information prepared and certified by the Custodian (unaudited)

The following is a summary of the unaudited information, included in the Plan's financial statements and supplemental schedule that were prepared by or derived from information prepared by John Hancock Life Insurance Company (U.S.A.), the "Custodian" of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Custodian that such information is complete and accurate.

- Investments, at fair value, as shown in the statements of net assets available for benefits as of July 26, 2022 (in liquidation) and December 31, 2021 (ongoing).
- Net depreciation in fair market value of investments, interest income, and other loss as shown in the statement of changes in net assets available for benefits for the period ended July 26, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information to the related information included in the financial statements.

Note 4—Fair value measurements

The Plan follows the *Fair Value Measurements* topic of the Financial Accounting Standards Board Accounting Standards Codification 820 which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value.

Pooled Separate Accounts – Valued at the net asset value ("NAV") of units held by the fund at end of year, as provided by John Hancock Life Insurance Company (U.S.A.) ("John Hancock"). NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee. The investment management fee is deducted prior to settling the daily unit value. NAV is not a publicly quoted price in an active market. There are currently no redemption restrictions on these investments.

Guaranteed Interest Accounts – Are held in the John Hancock general account. The participant transacts at contract value, which approximates fair value. Contract value is the total of contributions made plus interest earned less any fees and contract asset charges. Participants can withdraw or transfer a portion of their value from the account; however, amounts withdrawn prior to the end of the guarantee period may be subject to a market value adjustment.

Note 5—Related party and party-in-interest transactions

Transactions with parties-in-interest include purchases and sales of assets through John Hancock and contributions made by the Company. Fees incurred by the Plan for investment management services are included in investment income, as they are indirect fees paid through revenue sharing, rather than a direct payment. The Plan pays directly certain fees related to the Plan's operations which are included in administrative expenses.

Note 6—Tax status

The prototype plan, adopted by the Plan, has obtained a determination letter dated March 31, 2014, in which the Internal Revenue Service (“IRS”) stated the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The prototype plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 26, 2022 and December 31, 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Plan termination

In 2022, the Company was acquired by Aspirion Health Resources, LLC (“Aspirion”). In connection with the acquisition, the Company approved a plan of liquidation on March 21, 2022. As a result, Plan assets were liquidated. The participants’ distribution options included rolling the proceeds to another qualified employer plan or an Individual Retirement Account or receiving a direct taxable distribution.

Note 8—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent to the statements of net assets available for benefits date of July 26, 2022 through May 12, 2023, which is the date these financial statements were available to be issued.
