Basis for Opinion

As discussed in Notes 1 and 2 to the financial statements, the Company’s Board of Directors approved a plan of liquidation on March 31, 2022, and management determined liquidation is imminent. As a result, the FEMCO Machine Co. 401(k) Plan has changed its basis of accounting from the going-concern basis of accounting used in presenting the December 31, 2021 financial statements to the liquidation basis of accounting used in presenting the July 31, 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. NOTE 1 - DESCRIPTION OF PLAN

The following description of the FEMCO Machine Co. 401 (k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan generally covering all qualifying employees of FEMCO Machine Co. (the "Company", "Employer" or "Plan Sponsor") who have at certain services criteria. Participants are eligible to participate in the Plan if they are 18 years old and have completed 90 days of service. Service requirements can also be met if an employee works 1,000 hours or more within a 12-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Plan Termination and Liquidation - On March 31, 2022, the Plan Sponsor ("FEMCO Machine Co."), closed all business operations. As a result of the termination of the business, the governing body of the Plan adopted a resolution to terminate the Plan effective March 31, 2022. All assets were distributed out of the plan as of July 31, 2022.

- B. Contributions - Prior to the plan termination, participants may contribute up to 100% of pretax annual compensation, up to the annual maximum amount pursuant to the applicable section of the Internal Revenue Code. Participants who meet certain age requirements are eligible to make additional "catch-up contributions" also subject to certain dollar limits. Participants may designate all or a portion of their elective deferrals as Roth elective deferrals. The Plan also provides for employer discretionary matching contributions. The Company contributions are equal to 50% of the first 5% of eligible compensation that a participant contributes to the Plan. For the plan period January 1, 2022 to July 31, 2022, the Company elected not to make the discretionary matching contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company also has the option to make a discretionary profit-sharing contribution to the Plan, on an annual basis. Profit sharing contributions are allocated to the accounts of the active participants in direct proportion to the participants' eligible compensation as defined by the Plan.

Pursuant to the Plans' termination resolution participant contributions to the Plan are prohibited effective March 31, 2022. Employer contribution to the Plan follow the same rules that were in effect prior to the plan termination. For the period January 1, 2022 to July 31, 2022, there were no employer contributions to the plan.

- C. Participant Accounts - Prior to the plan termination, each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting - Prior to the plan termination, each participant is immediately and fully vested in all participant contributions and earnings thereon. Vesting in the remainder of the account balance is based on years of continuous service as follows:

Additionally, participants became fully vested in their account balances upon plan termination on March 31, 2022.

- E. Investment programs - Prior to the plan termination, upon enrollment in the Plan, a participant may direct employer and employee contributions in any percentage increments into any of the available investment options. Participants may change their investment options in accordance with the rules established by the Plan Administrator.
- F. Notes Receivable from Participants - Prior to the plan termination, participants are allowed to borrow a minimum of \$1,000 and a maximum of 50% of their vested Plan account balance or \$50,000, whichever is less. To be eligible, participants must be an active participant in the Plan and have a vested account balance of at least \$2,000. Loan terms are up to five years or up to ten years if the loan is to acquire a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time of the loan as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deduction.

Pursuant to the Plan's termination resolution, participants were prohibited from initiating new loans from the Plan as of the date of the Plan termination.

- G. Benefits - Prior to the plan termination, on termination of service due to death, disability, or retirement, a participant receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon any other termination of service event, a participant's vested balance will automatically be distributed directly to the participant or to a qualified individual retirement account ("IRA") if their vested balance is less than \$5,000.

Effective March 31, 2022, participants were required to request terminating distributions of the full amount of their vested account balances by June 30, 2022. Any liquidating distributions that were not processed by the Plan by June 30, 2022 were distributed to a trust account established by the Plan Sponsor. All liquidating distributions were processed by the Plan by June 30, 2022 as of July 31, 2022.

- H. Administrative expenses - Prior to the plan termination, all expenses of maintaining the Plan are paid by the Plan or the Sponsor as determined by the Sponsor.
- I. Forfeited Accounts - Prior to the plan termination, as of and for the period January 1, 2022 to July 31, 2022, unallocated forfeited accounts and forfeitures credited to participants during the period were not material to the financial statements.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

- A. Basis of Accounting - As a result of the termination of the Plan, the July 31, 2022 financial statements of the Plan are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. For the year ended December 31, 2021, the financial statements of the Plan are prepared on the accrual basis of accounting (ongoing). The liquidation basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of July 31, 2022 would be fair value. Management determined that the liquidation value of the Plan's investments approximated their fair value and did not result in any material changes to the July 31, 2022 financial statements as a result of the change under the liquidation basis of accounting.
- B. Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.
- C. Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive contracts which are valued at contract value, which approximates liquidation value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.
- Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.
- Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- D. Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.
- E. Contributions receivable - Participant deferrals and employer discretionary matching contributions due to the Plan at year end are recorded as contributions receivable and are credited to the individual participant accounts.
- F. Payment of Benefits - Benefits are recorded when paid.
- G. Risk of uncertainties - The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that

such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At July 31, 2022, there were no investments as the plan was terminated and all investments were sold. At December 31, 2021, four registered investment companies made up approximately 59% of the Plan total investments. As such, these are considered concentrations of credit risk.

NOTE 3 - INFORMATION CERTIFIED AND PROVIDED BY GREAT-WEST

The following is a summary of the Plan's asset information as of July 31, 2022 and December 31, 2021 and for the period January 1, 2022 to July 31, 2022 included throughout the Plan's financial statements that were prepared by or derived from information provided by Great-West Life and Annuity Insurance Company and Great-West Trust Company, LLC ("Great-West"), the Plan custodian and furnished to the Plan Administrator. The Plan administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets.

NOTE 4 - FAIR VALUE MEASUREMENTS

FASB ASC 820 provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 3, 2022 and December 31, 2021.

Registered investment companies: Valued at quoted market price which represent the net asset value (NAV) of the shares held by the Plan at year end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had no investments as of July 31, 2022.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional investment contract with Great-West. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the traditional investment contract at July 31, 2022 and December 31, 2021 was \$0 and \$27,991, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0% for the contract with Great-West. Such interest rates are reviewed on a quarterly basis for resetting. The contract does permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401 (a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501 (a) of the Internal Revenue Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

NOTE 6 - TAX STATUS

Effective April 4, 2016, the Plan adopted a standardized form of a prototype plan sponsored by Great-West Trust Company. The prototype plan has received an opinion

letter from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion has been relied upon by this Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are guaranteed interest account managed by affiliates of Great-West. Great-West is the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The administrative fees paid to Great-West and their affiliates amounted to \$26,710 for the period January 1, 2022 to July 31, 2022.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
