Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Hire Dynamics 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of July 31, 2022 and December 31, 2021 and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through July 31, 2022 and the related notes to the financial statements.

Note 1 - Description of plan:

The following description of the Hire Dynamics 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan sponsor was Hire Dynamics, LLC (the Company, Plan Sponsor or Plan Administrator). The Plan was a defined contribution plan covering substantially all employees of the Company who had completed at least one year of service as defined in the Plan document and had attained age 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator was responsible for oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Plan termination

The Company was acquired by Employment Solutions Management, Inc. on November 21, 2021, and due to the sale, the Company approved a termination of the Plan during November 2021, and all participant accounts became fully vested. Following the pay period related to the November 19, 2021 pay date, all contributions to the Plan were ceased. Approximately \$2,300,000 of participant accounts were distributed in 2021 due to the termination and the remaining participant accounts were distributed during the seven months ended July 31, 2022.

Contributions

Participants could contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan was restated effective January 1, 2021 to include overtime, bonuses, and commissions as eligible compensation for the calculation of participant and Company discretionary matching contributions. Due to the Company acquisition, there were no contributions to the Plan during the period from January 1, 2022 through July 31, 2022.

Participant accounts

For the period ended July 31, 2022 each participant's account was credited with an allocation of Plan earnings charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contributions and earnings thereon was based on years of continuous service.

Participants became vested in Company discretionary matching and discretionary profit sharing contributions in accordance with the following schedule:

Participants were immediately vested upon termination of the Plan. Forfeitures of terminated participants' non-vested accounts were used to pay Plan administrative expenses.

Forfeitures

At July 31, 2022 and December 31, 2021, there were no forfeited non-vested accounts. As such, no amounts were used during the period from January 1, 2022 through July 31, 2022.

Payment of benefits

A participant was entitled to receive a lump-sum amount equal to the vested value of his or her account upon attainment of age 59½, termination of service, retirement, disability, or death. A participant could request a withdrawal from the Plan while still under the employment of the Company from their rollover account or for reasons of financial hardship.

Notes receivable from participants

Due to the Company's acquisition and the termination of the Plan all notes became due, no new notes were allowed to be issued, and participants were unable to make note repayments through Company payroll, during the period from January 1, 2022 through July 31, 2022. Any outstanding notes upon final liquidation of the Plan were properly included in the distribution reported for the participant during the period from January 1, 2022 through July 31, 2022.

Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. The Company reserved the right to elect to pay, or have the Plan pay, administrative costs in the future. Investment related expenses were included in net depreciation in fair value of investments.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared under the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States (U.S. GAAP). Due to the acquisition by Employment Solutions Management, Inc. during November 2021, management determined that liquidation of the Plan's assets was imminent. As a result, the Plan's financial statements have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis is appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amount.

Note 2 - Summary of significant accounting policies - continued:

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers and Voya Retirement Insurance and Annuity Company (Voya). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in accordance with liquidation basis requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of July 31, 2022 or December 31, 2021. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a deemed distribution is recorded.

Recent legislative developments

In December 2019, Congress passed the SECURE Act which included numerous reforms to existing retirement law and allows plan sponsors to make certain immediate plan operational changes without formal amendment of the plan document.

In March 2020, Congress passed the CARES Act which included optional immediate changes to distribution and loan provisions without formal amendment of the plan document.

The Plan Sponsor operationally implemented various changes and timely amended the Plan for these changes.

Subsequent events

The Plan has evaluated subsequent events through May 15, 2023, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of July 31, 2022, have been incorporated into these financial statements.

Note 3 - Investments and information certified:

Voya was the custodian for the Plan. Voya held the Plan's investment assets and executed investment transactions. Management has determined that Voya is a qualified institution and the information prepared and certified by Voya meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at July 31, 2022 and December 31, 2021, and net depreciation in fair value of investments and interest and dividends for the period from January 1, 2022 through July 31, 2022, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification No. 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no significant changes in the methodologies used at July 31, 2022 and December 31, 2021.

- Shares of registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Units of participation in the guaranteed interest account are under a group annuity contract issued by Voya. Under the definition of fully benefit responsive investment contracts, the guaranteed interest account is considered non-benefit responsive. Thus, the Plan's investment in the guaranteed interest account is reportable at fair value. Balances are reported as the discontinuance value, which is the amount participants would receive currently if they were to withdraw or borrow funds from or transfer funds within the Plan. The interest rate for this portfolio investment contract is reset at least as frequently as annually. In determining the reasonableness of the discounted cash flow valuation methodology

used, the Plan Sponsor evaluates a variety of factors, including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the liquidation of the Plan, there were no assets held as of July 31, 2022.

Note 5 - Related-party transactions:

All Plan investments were shares of registered investment companies and a guaranteed interest account managed by Voya and, therefore, Plan investment transactions qualified as party-in-interest transactions and were exempt from the prohibited transaction rules. Fees incurred by the Plan for investment management services were included in net depreciation in fair value of investments.

Note 6 - Plan termination:

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company approved a liquidation of the Plan and participants became 100% vested in their accounts.

Note 7 - Tax status:

The underlying non-standardized prototype plan had received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan was qualified under Section 401(a) of the Internal Revenue Code (the Code), and therefore, the related trust was tax-exempt. The Plan Administrator has determined that it was eligible to and chose to rely on the IRS opinion letter. Once qualified, the Plan was required to operate in conformity with the Code to maintain its qualification. The Plan Sponsor believes the Plan was being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not have been sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Management has obtained certifications from a qualified institution as of July 31, 2022 and December 31, 2021, and for the period from January 1, 2022 through July 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the financial statements.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, management of the Plan approved a plan of liquidation effective November 2021, and management determined liquidation was imminent. As a result, the Plan used the liquidation basis of accounting used in presenting the 2021 and 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of plan:

The following description of the Hire Dynamics 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan sponsor was Hire Dynamics, LLC (the Company, Plan Sponsor or Plan Administrator). The Plan was a defined contribution plan covering substantially all employees of the Company who had completed at least one year of service as defined in the Plan document and had attained age 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator was responsible for oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Plan termination

The Company was acquired by Employment Solutions Management, Inc. on November 21, 2021, and due to the sale, the Company approved a termination of the Plan during November 2021, and all participant accounts became fully vested. Following the pay period related to the November 19, 2021 pay date, all contributions to the Plan were ceased. Approximately \$2,300,000 of participant accounts were distributed in 2021 due to the termination and the remaining participant accounts were distributed during the seven months ended July 31, 2022.

Contributions

Participants could contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan was restated effective January 1, 2021 to include overtime, bonuses, and commissions as eligible compensation for the calculation of participant and Company discretionary matching contributions. Due to the Company acquisition, there were no contributions to the Plan during the period from January 1, 2022 through July 31, 2022.

Participant accounts

For the period ended July 31, 2022 each participant's account was credited with an allocation of Plan earnings charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contributions and earnings thereon was based on years of continuous service.

Participants became vested in Company discretionary matching and discretionary profit sharing contributions in accordance with the following schedule:

Participants were immediately vested upon termination of the Plan. Forfeitures of terminated participants' non-vested accounts were used to pay Plan administrative expenses.

Forfeitures

At July 31, 2022 and December 31, 2021, there were no forfeited non-vested accounts. As such, no amounts were used during the period from January 1, 2022 through July 31, 2022.

Payment of benefits

A participant was entitled to receive a lump-sum amount equal to the vested value of his or her account upon attainment of age 59½, termination of service, retirement, disability, or death. A participant could request a withdrawal from the Plan while still under the employment of the Company from their rollover account or for reasons of financial hardship.

Notes receivable from participants

Due to the Company's acquisition and the termination of the Plan all notes became due, no new notes were allowed to be issued, and participants were unable to make note repayments through Company payroll, during the period from January 1, 2022 through July 31, 2022. Any outstanding notes upon final liquidation of the Plan were properly included in the distribution reported for the participant during the period from January 1, 2022 through July 31, 2022.

Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. The Company reserved the right to elect to pay, or have the Plan pay, administrative costs in the future. Investment related expenses were included in net depreciation in fair value of investments.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared under the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States (U.S. GAAP). Due to the acquisition by Employment Solutions Management, Inc. during November 2021, management determined that liquidation of the Plan's assets was imminent. As a result, the Plan's financial statements have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis is appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amount.

Note 2 - Summary of significant accounting policies - continued:

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers and Voya Retirement Insurance and Annuity Company (Voya). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in accordance with liquidation basis requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of July 31, 2022 or December 31, 2021. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a deemed distribution is recorded.

Recent legislative developments

In December 2019, Congress passed the SECURE Act which included numerous reforms to existing retirement law and allows plan sponsors to make certain immediate plan operational changes without formal amendment of the plan document.

In March 2020, Congress passed the CARES Act which included optional immediate changes to distribution and loan provisions without formal amendment of the plan document.

Recent legislative developments - continued

The Plan Sponsor operationally implemented various changes and timely amended the Plan for these changes.

Subsequent events

The Plan has evaluated subsequent events through May 15, 2023, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of July 31, 2022, have been incorporated into these financial statements.

Note 3 - Investments and information certified:

Voya was the custodian for the Plan. Voya held the Plan's investment assets and executed investment transactions. Management has determined that Voya is a qualified institution and the information prepared and certified by Voya meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at July 31, 2022 and December 31, 2021, and net depreciation in fair value of investments and interest and dividends for the period from January 1, 2022 through July 31, 2022, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification No. 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no significant changes in the methodologies used at July 31, 2022 and December 31, 2021.

- Shares of registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Units of participation in the guaranteed interest account are under a group annuity contract issued by Voya. Under the definition of fully benefit responsive investment contracts, the guaranteed interest account is considered non-benefit responsive. Thus, the Plan's investment in the guaranteed interest account is reportable at fair value. Balances are reported as the discontinuance value, which is the amount participants would receive currently if they were to withdraw or borrow funds from or transfer funds within the Plan. The interest rate for this portfolio investment contract is reset at least as frequently as annually. In determining the reasonableness of the discounted cash flow valuation methodology

used, the Plan Sponsor evaluates a variety of factors, including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the liquidation of the Plan, there were no assets held as of July 31, 2022.

Note 5 - Related-party transactions:

All Plan investments were shares of registered investment companies and a guaranteed interest account managed by Voya and, therefore, Plan investment transactions qualified as party-in-interest transactions and were exempt from the prohibited transaction rules. Fees incurred by the Plan for investment management services were included in net depreciation in fair value of investments.

Note 6 - Plan termination:

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company approved a liquidation of the Plan and participants became 100% vested in their accounts.

Note 7 - Tax status:

The underlying non-standardized prototype plan had received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan was qualified under Section 401(a) of the Internal Revenue Code (the Code), and therefore, the related trust was tax-exempt. The Plan Administrator has determined that it was eligible to and chose to rely on the IRS opinion letter. Once qualified, the Plan was required to operate in conformity with the Code to maintain its qualification. The Plan Sponsor believes the Plan was being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not have been sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
