### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of G5 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the six months ended June 30, 2022 and for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of G5 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2022 and December 31, 2021 and for the six months ended June 30, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

In performing an audit in accordance with generally accepted auditing standards, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.

## 1. Plan Description

The following description of G5 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

### General

The Plan was established on January 1, 2010, as a defined-contribution plan covering all eligible employees of G5 Search Marketing, Inc. (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's most recent restatement was effective September 9, 2021. The Plan terminated as part of a merger with RealPage 401(k) Retirement Plan effective June 30, 2022, subsequent to the sponsor's acquisition by RealPage in 2021.

There was no age or service requirement to participate in the Plan, and employees were eligible upon date of hire. Eligible participants entered the Plan the first day of the month after or coinciding with the fulfillment of these requirements.

### Contributions

Each year, participants may contribute pre-tax compensation or after-tax compensation up to the limits provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year are eligible to make additional pre-tax "catch-up" contributions. Participants may also contribute amounts representing rollover distributions from other qualified retirement plans.

For the year ended December 31, 2021, the Employer was required to make a nondiscretionary safe harbor matching contribution equal to 100 percent of participant deferrals up to 4 percent of compensation. There was no age or service requirement to be eligible for safe harbor matching contributions. Contributions to the plan ceased as of December 31, 2021 as a result of the merger with RealPage.

The Employer may also make discretionary matching or discretionary nonelective contributions. There is no age or service requirement to be eligible for matching contributions. To be eligible for discretionary nonelective contributions, an employee must complete at least one year of service and be an active participant on the last day of the Plan year. There were no discretionary matching or nonelective contributions during the six months ended June 30, 2022 and the year ended December 31, 2021.

### Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions and earnings on the specific investments held in the participant's account. Participant accounts are charged with an allocation of administrative expenses paid by the Plan, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their accounts into various mutual fund investments offered by Fidelity Management Trust Company.

**1. Plan Description, continued**

**Payments of Benefits**

On termination of service, death, disability, or retirement, a participant or beneficiary may elect to receive the vested value of his or her account in either a lump sum or direct rollover to an eligible retirement plan. The Plan allows in-service distributions of fully vested accounts for participants who have attained age 59½. In-service distributions for financial hardships are also available in the event of an immediate and heavy financial need, subject to the Plan's rules governing hardship withdrawals.

**Vesting**

Participants are immediately vested in their deferral, rollover, and nondiscretionary safe harbor matching contributions. Vesting in discretionary Employer matching and discretionary nonelective Employer contributions is based on years of service. Discretionary Employer matching and discretionary nonelective Employer contributions vest as follows:

3	75%
4	100%

The portion of an individual's account that is not vested at the time an employee terminates his or her employment is forfeited.

**Forfeitures**

Forfeitures are used to pay administrative expenses and reduce Employer contributions. Non-vested balances totaling \$14,180 and \$1,192 were forfeited for the six months ended June 30, 2022 and the year ended December 31, 2021, respectively. During the six months ended June 30, 2022 and the year ended December 31, 2021, \$1,526 and \$14,381, respectively, in forfeitures were used to pay administrative expenses or reduce employer contributions. \$21,726 in forfeitures were transferred to the RealPage 401(k) Retirement Plan as part of the plan merger on June 30, 2022.

**Notes Receivable from Participants**

Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The maximum number of loans that a participant may have outstanding at any one time is one. The loans are secured by the balance in the participant's account and bear a reasonable interest rate commensurate with local, prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of June 30, 2022 and December 31, 2021. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses and Fees**

Expenses of maintaining the Plan, including third-party administration and audit fees, are paid by the Employer and are therefore excluded from these financial statements. Administrative expenses may be paid from participant accounts at the Employer's election. Investment related expenses are included in net change in fair value of investments.

**3. Information Prepared and Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**4. Related Party and Party In Interest Transactions**

Certain Plan investments are shares of registered investment companies managed by an affiliate of the trustee. These transactions qualify as party in interest transactions as defined by ERISA. Administration fees paid directly to the trustee from Plan assets were \$31,897 and \$58,325 for the six months ended June 30, 2022 and the year ended December 31, 2021, respectively. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

**5. Plan Merger**

In 2022, as part of a 2021 acquisition of the Plan sponsor by RealPage, Inc., the Employer executed a Plan merger whereas all assets of the Plan were liquidated and merged into the RealPage 401(k) Retirement Plan with an effective date of June 30, 2022. Because the merger was executed as of the end of the day on June 30, 2022, the accompanying statements of net assets available for benefits and changes in net assets available for benefits as of and for the year ended June 30, 2022, reflect the merger and transfer and final liquidation of the Plan. The assets were received by the acquiring Plan and allocated to participants on July 1, 2022, after which date the Plan no longer exists.

**6. Tax Status**

The Plan was restated on September 9, 2021 to adopt a prototype plan through execution of an adoption agreement. The prototype plan adopted is the Volume Submitter Profit Sharing Plan. Fidelity Management & Research Co, the sponsor of the prototype plan, has received an opinion letter from the IRS dated June 30, 2020, that the adoption agreement and basic plan document satisfy IRC Section 401.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

## 7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2022 and December 31, 2021.

*Registered investment companies:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end. All mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are considered to have a readily determinable fair value.

*Common/collective trust:* Valued at the net asset value based on the market value of its underlying investments. Common/collective trust investments have not been classified in the fair value hierarchy. All common/collective trust investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

**7. Fair Value Measurements, continued**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
