### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed the audits of the financial statements of the Quest Global 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Quest Global 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank of similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520-103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements Section -

### ***Basis for Opinion***

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Quest Global 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Emphasis of Matter - Basis of Accounting and Plan Termination***

As described in Notes 1 and 2 to the financial statements, the Sponsor of the Quest Global 401(k) Retirement Plan ceased participant and matching contributions on July 13, 2022 and elected to terminate the Plan effective July 13, 2022 with the intention of liquidating the assets of the Plan and distributing them to the participants. As a result, the Plan changed its basis of accounting from the accrual basis of accounting to the liquidation basis of accounting on July 13, 2022. The Plan was fully liquidated in December 2022. Our opinion is not modified with respect to this matter.

### Note 1 - Description of plan:

The following description of the Quest Global 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The plan sponsor is Quest Global, Inc. (Quest). The Plan is a defined contribution plan covering substantially all employees of Quest (the Company, Plan Sponsor, or Plan Administrator).

Effective June 16, 2021, the Plan Sponsor adopted a new volume submitter document. The new document adopted is substantially the same as the previously existing document.

Employees must be at least 21 years of age and complete one year of service to participate in the Plan. Participants may begin participating in the Plan on the first day of each quarter after attainment of the eligibility requirements. Leased employees are eligible to participate in the Plan. Employees who are non-resident aliens with no U.S. source income, employees subject to collective bargaining, and independent contractors are not eligible to participate in the Plan. The Plan does not have an automatic enrollment provision. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan termination

Effective July 13, 2022, the Board of Directors of the Plan Sponsor elected to terminate the Plan. All participants became fully vested upon termination of the Plan. In accordance with the winding down of the Company, employees were transferred to the acquiring entity beginning on July 14, 2022. Upon their transfer to the acquiring entity, employees began participating in the acquiring entity's retirement plan. Contributions to the Plan ceased in July 2022 when the last of the Company's employees were transferred to the acquiring entity. Participants were given the option to take a lump sum distribution of their account, rollover their account balance to another eligible retirement plan, or rollover their account balance to an IRA account of their choice. Participants not making one of these elections had their account balance rolled over to an IRA account setup in the participant's name with Empower Trust Company, LLC. The Plan was fully liquidated in December 2022. See Notes 2 and 5.

#### Contributions

Participants may elect to contribute amounts up to current Internal Revenue Service (IRS) limitations through payroll deductions. Participants who have attained age 50 before the end of the Plan year are permitted to make catch-up contributions. Employer matching and profit-sharing contributions are at the discretion of the Plan Sponsor. Employer matching contributions are limited to a maximum of 3% of participant compensation with an annual matching contribution limit of \$2,496 per participant. Employer contributions, if any, are contributed on an annual basis. Participants must be employed on the last day of the Plan year and complete at least 1,000 hours of service during the Plan year to be eligible for employer matching and profit-sharing contributions. There were no employer matching or profit-sharing contributions for the 2022 Plan year.

#### Participant accounts

Each participant's account is credited with the participant's contributions, employer matching and profit-sharing contributions, if any, Plan expenses, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### Forfeited accounts

As of December 31, 2022 and 2021, forfeited non-vested accounts totaled \$0 and \$7,586, respectively, and are included in the group annuity contract investment. No forfeitures were used to pay Plan expenses or to reduce employer contributions during the year ended December 31, 2022. Forfeitures totaling \$8,888 were allocated to the accounts of eligible participants in conjunction with the termination and liquidation of the Plan.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in the Company's matching and profit-sharing contributions in accordance with the following vesting schedule:

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Company. Forfeitures of terminated participants' non-vested accounts may be used by the Plan for the payment of Plan expenses or to reduce employer contributions.

#### Payment of benefits

A participant is entitled to a distribution of the vested value of his or her account upon termination of service, disability, death, or retirement. Participants may take distributions as lump-sum payments, installments, or annuity payments. Hardship distributions are allowed from the Plan. If a participant's account balance is less than \$5,000 upon termination of service, a distribution of the participant's account may be made automatically in a single lump-sum cash distribution.

#### Notes receivable from participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are for a maximum of five years, except for notes for the purchase of a primary residence which may be up to 15 years. Participants may have one note outstanding at any given time. Notes are secured by the participant's account and bear interest at the Prime Rate plus 1%. Principal and interest are paid ratably through payroll deductions. Participants may prepay their note at any time. Participants may refinance their loan if they meet certain conditions.

#### Notes receivable from participants - continued

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

#### Administrative expenses

Administrative expenses of the Plan are paid by either the Company or the Plan, as determined by the Plan Sponsor. The Company pays a portion of administrative expenses of the Plan. Fees charged for processing participant distributions, as well as other account transaction fees, are charged directly to the accounts of applicable participants.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The 2021 financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Effective July 13, 2022, the Plan changed to the liquidation basis of accounting in conjunction with the termination of the Plan (see Note1). The change to the liquidation basis of accounting did not have a significant impact on the operations of the Plan.

#### Group annuity contract

The Plan has a group annuity contract with Great-West, LLC (Great-West) that invests contributions in the Great-West Key Guaranteed Portfolio Fund. The Great-West Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting interest rate may not be less than 0%. The interest crediting rate is reset quarterly. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount that would be received by participants if they

were to initiate permitted transactions under the terms of the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Great-West may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. Generally, a 60 day notice is required by either party to discontinue the contract. Great-West may elect to defer payment of the contract for up to 12 months after the contract is discontinued. Proper notification was given to Great-West regarding the termination of the Plan and the discontinuance of the contract. Great-west did not elect to defer payment of the contract as a result of the Plan termination.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include 1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options, 3) bankruptcy of the Plan Sponsor or other events that cause a significant withdrawal from the Plan, or 4) failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The termination of the Plan did not affect the Plan's ability to transact at contract value with participants.

### Investment valuation and income recognition

The Plan's registered investment company investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 and 2021.

Shares of registered investment companies are valued at the net asset value of shares held by the Plan at year end by obtaining quoted prices on nationally recognized securities exchanges.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### Payment of benefits

Benefits are recorded when paid.

#### Note 4 - Party-in-interest transactions:

The custodian and its affiliates perform services for the Plan, sell products to the Plan, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. Note 5 - Plan termination:

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective July 13, 2022, the Company elected to terminate the Plan. At that time, all participant accounts became fully vested. See Note 1 for additional information.

Note 6 - Tax status:

The underlying prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2019.
