Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed an audit of the financial statements of Diamonds Direct USA, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(c) ("ERISA Section 103(a)(3)(c) audit").

The financial statements comprise the statement of net assets available for benefits as of October 31, 2022, and December 31, 2021 and the related statement of changes in net assets available for benefits for the period ended October 31, 2022, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of Plan

Nature of Business

The following description of the Diamonds Direct USA, Inc. (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement, as amended and restated, for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 2017, as a way for the Company to improve their overall benefits package. The Plan was a defined contribution plan covering substantially all employees of the Company who are age twenty-one (21) or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Plan entry dates for eligible employees were the first day of each month following eligible entry date.

On October 31, 2022, the Plan merged into the Signet Jewelers Retirement Savings Plan. Assets of \$6,711,195 were merged and the Plan was terminated.

Administration

The Company serves as the plan sponsor and plan administrator. The plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions which may affect eligibility for benefits.

Newport Trust Company ("Newport" or "Trustee") served as trustee of the Plan for the period ended October 31, 2022. PNC Bank, N.A. served as trustee of the Plan for the year ended December 31, 2021. Newport received all contributions made under the Plan, held Plan assets, and paid benefits as directed by the plan administrator.

Contributions

Each year, participants may defer a portion of their pretax compensation to the Plan, not to exceed certain Internal Revenue Code ("IRC") limitations. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Employee contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings. The Company may make matching contributions equal to a discretionary percentage, determined by the Company, of the participant's elective deferrals to the Plan. The Company matched 25% of the first 6% of eligible wages per pay period that employees contributed to the Plan. The Company may make additional contributions at its discretion; however, no additional contributions were made for the period ended October 31, 2022. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, if any, and plan earnings. Each participant's account is charged with withdrawals, and an allocation of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions including rollovers, if any, plus actual earnings thereon. Vesting in the remainder of the participant's account is based on the following schedule:

Investment Options

Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan offered mutual funds and a common collective trust fund as investment options for participants.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount of various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59 ½. Participants receive distributions of their accounts in a single lump sum as early as possible following the date of termination if the account balance is less than \$5,000. If the vested amount exceeds \$5,000, the participant must elect to receive the benefit. An election to defer payment can be made.

Notes receivable from Participants

Participants may borrow from the vested portion of their participant account. Loans may be taken for a minimum of \$1,000 and a maximum of the amount equal to the lesser of 50% of the participant's vested balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. All outstanding loans were merged into the Signet Jewelers Retirement Savings Plan. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Forfeitures of nonvested participant account balances were used to pay plan expenses or to reduce amounts otherwise required to be contributed to the Plan. At October 31, 2022 and December 31, 2021, there were \$0 and \$651 of forfeited nonvested accounts available to pay plan expenses or to reduce future employer contributions. During the period ended October 31, 2022, forfeitures of \$3,040 were used to pay plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investment securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance. Delinquent participant loans were reclassified as distributions in accordance with the terms of the plan document.

Payment of Benefits

Benefits were recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses were paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions were performed by employees of the Company. No such employee received compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) were charged directly to the participants' account.

Subsequent events

The Plan has evaluated subsequent events through May 17, 2023, the date the financial statements were available to be issued.

3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Common collective trust fund

These funds are valued at the Net Asset Value ("NAV") of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. The common collective trust fund is not required to be classified within a level on the fair value hierarchy.

5. Exempt Party-In-Interest Transactions

Certain plan investments are managed by the Trustee and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the Trustee by the Plan for administrative services for the period ended October 31, 2022 was \$49,744.

6. Plan Termination

Effective October 31, 2022, the Plan was terminated and assets were merged into the Signet Jewelers Retirement Savings Plan. Participants became 100% vested in their accounts at the time of Plan merger.

7. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the trustee by a letter dated March 31, 2014 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
