INDEPENDENT AUDITOR'S REPORT

To the Plan Participants and Plan Administrator of
McVeigh & Mangum Engineering, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We were engaged to perform an audit of the financial statements of **McVeigh & Mangum Engineering, Inc. 401(k) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management has obtained a certification from a qualified institution as of July 31, 2022 and December 31, 2021, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion on the Financial Statements

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the certified information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Note A – Description of Plan

The following description of McVeigh & Mangum Engineering, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution safe harbor plan covering employees of McVeigh & Mangum Engineering, Inc. (the “Company” or “Employer”). The Plan was formed and adopted on January 1, 2007 and most recently amended effective January 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan merged into the IMEG 401(k) Plan (“New Plan”) effective August 1, 2022, transferring all assets and liabilities into the New Plan.

Employees who had attained the age of 21 were eligible to participate in the Plan after completing three consecutive months of service. Eligible employees were permitted to enter the Plan on the first day of the month coinciding with or next following the date eligibility requirements were met. Union, nonresident aliens, and part-time or temporary employees who had completed less than 1,000 hours of service were excluded from participating in the Plan.

Administration of the Plan

The accounting records from January 1, 2022 to July 31, 2022 were maintained by the Company. The Plan’s assets were held and managed by Transamerica Life Insurance Company (the “Custodian”). Contributions were held by the Custodian, who invested cash received, interest and dividend income, as directed by the participant, and made distributions to participants.

Contributions

Participants were permitted to contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. The maximum participant deferral for the period from January 1, 2022 to July 31, 2022 was \$20,500. A participant who had attained the age of 50 was also permitted to make catch up contributions, subject to Internal Revenue Service (“IRS”) limitations of \$6,500 for the period January 1, 2022 to July 31, 2022. Participants were also able to make Roth deferrals and contribute amounts representing distributions from other qualified plans.

Under the terms of the Plan, the Company made safe harbor matching contributions equal to 100% of elective deferrals that did not exceed 3% of compensation plus 50% of elective deferrals between 3% and 5% of compensation.

Each year, the Company could also elect to make a discretionary matching contribution to the Plan in an amount not to exceed 4% of compensation. Participants were eligible for a discretionary matching contribution regardless of the amount of service completed. For the period from January 1 to July 31, 2022, the Company did not make a discretionary matching contribution.

Each Plan year, the Company could also elect to make a discretionary profit sharing contribution. In order to share in Employer profit sharing contributions, participants must have been employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year. For the period from January 1 to July 31, 2022, the Company did not make a discretionary profit-sharing contribution.

Participants directed the investment of their contributions and Employer contributions into various investment options offered by the Plan.

Participant Accounts

Each participant’s account was credited with the participant’s contribution and the Company’s matching contribution, if applicable. Each participant’s account was allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations of Plan earnings or losses were based on each participant’s investment fund balance in proportion to the total investment fund balance

Vesting

Participants were immediately vested in their voluntary contributions, as well as any rollover contributions, and Company safe harbor contributions plus actual earnings thereon. Vesting in any discretionary matching and profit sharing contributions was based on years of service. A participant was fully vested in Company nonelective contributions plus actual earnings thereon after 5 years of credited service as follows:

A participant who reached normal retirement age 65, became totally disabled, or died, whichever comes first while under the Company's employment, was 100% vested on such date.

Notes Receivable from Participants

Participants were permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant was only permitted to have a maximum of one loan outstanding at any given time. The notes were secured by the balance in the participant's account, or other acceptable collateral, and bore interest at a rate equal to 1% above the Prime rate. The maximum note repayment period was five years unless the note was for the purchase of a primary residence in which case the repayment schedule may be for a term in excess of five years. Principal and interest payments with respect to the notes were credited solely to the account of the borrowing participant from which the note was made.

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. In the event of default, the unpaid portion of the participant's loan was treated as a taxable distribution as of the first day of the second calendar quarter following the calendar quarter in which the participant failed to make a required installment payment.

Distribution of Benefits

In the event of termination of service, death, disability or retirement, a participant was permitted to elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals or installments paid over various periods as defined in the Plan agreement, less any applicable taxes. If a participant's vested balance is \$5,000 or less, the Company could distribute the entire vested account balance to the participant without their consent. Participants were permitted to request in-service distributions at age 59 1/2 or as a qualified reservist. Benefits could be received when a participant demonstrates a situation of financial hardship as defined in the Plan.

Forfeitures

Non-vested benefits of terminated participants were forfeited on the date the participant receives a complete distribution of vested benefits. Forfeitures were used to reduce current year Employer contributions. During the period from January 1, 2022 to July 31, 2022, the Plan utilized \$11,000 of forfeitures from participant accounts for Plan expenses. As of July 31, 2022 and December 31, 2021, forfeited non-vested accounts totaled approximately \$0 and \$7,000, respectively.

Note B – Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“US GAAP”).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

Valuation of Investments

The Plan’s investments are stated at fair value. Fair value is based on quoted market prices at year-end as reported by the Custodian. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the period from January 1 to July 31, 2022, and Plan year December 31, 2021.

Fair Value Measurements

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at July 31, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2022 to July 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution. As of July 31, 2022 and December 31, 2021, and for the period from January 1, 2022 to July 31, 2022, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note D – Income Tax Status

The Plan received a determination letter from the IRS dated March 31, 2014 for its prototype plan stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended and the Plan Administrator believed the Plan was being operated in compliance with the applicable requirements of the IRC.

Note D – Income Tax Status (continued)

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2020.

Note E – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or participants of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are managed by the Custodian. Transactions related to these investments qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$29,000 during the period from January 1, 2022 to July 31, 2022.

Note F – Subsequent Events

Subsequent events have been evaluated through May 8, 2023, which is the date the financial statements were available to be issued.
