## **Report of Independent Auditors**

To the Administrator of Granular, Inc. 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of Granular, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

### NOTES TO THE FINANCIAL STATEMENTS AS OF DECEMBER 31, 2022 AND 2021 AND FOR THE YEAR ENDED DECEMBER 31, 2022

#### NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the Granular, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

##### **General**

The Plan of EIDP, Inc., formerly known as E.I. du Pont de Nemours and Company, ("EIDP" or "Plan Sponsor" or "Plan Administrator") was adopted as of January 1, 2019. The Plan is a tax qualified defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The purpose of the Plan is to enable eligible employees to save for retirement. In addition to retirement benefits, the plan provides certain benefits in the event of death, disability, or other termination of employment. The Plan is for the exclusive benefit of eligible employees and their beneficiaries.

Due to the number of employee terminations that occurred in 2022, it was determined that a partial plan termination occurred and as a result, action was taken to auto-vest 12 participants who terminated employment in 2022.

On August 22, 2022, the Plan Sponsor approved the merger of the Plan into the Retirement Savings Plan ("RSP") effective December 30, 2022 ("Effective Date"). As a result, the Plan's total assets of \$38,971,594, which consisted of \$38,811,400 in investments and \$160,194 in loans, were transferred to the RSP on the Effective Date.

##### **Plan Administration**

Fidelity Management Trust Company ("Fidelity") is the Plan's trustee. EIDP, as the Plan Administrator, is responsible for providing employees and their beneficiaries with information regarding their rights and benefits under the Plan. The Plan Administrator has responsibility for selecting and overseeing the Plan investments and determining the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance companies.

##### **Plan Participation**

All employees of Granular, Inc. ("Granular" or "the Company") or any other employer who has adopted the Plan are eligible to participate, except: (i) employees who reside in Puerto Rico; (ii) leased employees; (iii) employees of the Plan Sponsor; (iv) temporary employees; (v) people who are receiving severance pay, retainers, commissions, or fees under contract; (vi) individuals who are not classified by a participating employer as common law employees; (vii) non-common law employees; (viii) interns; or (ix) individuals who are signatories to a contract, letter of agreement, or other document that acknowledges their status as an independent contractor.

##### **Contributions**

Participants may elect to make before-tax, Roth 401(k) or after-tax contributions of 1% to 90% of eligible compensation, as defined. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants can roll over into the Plan part of or all of an eligible rollover distribution received from a qualified retirement plan.

Participants are automatically enrolled in the Plan at a 6% before-tax savings rate and increased annually up to a maximum of 15% of pay, if no action is taken by the employee within 30 days from the hire date. Dependent on their age, participants are automatically enrolled into the American Funds Target Date Retirement Fund Class R-6 2010 through 2060. The participant may elect not to participate in the Plan at any time.

The Company makes a matching contribution equal to 100% of a participant's contribution, up to 6% of eligible compensation ("Company's matching contribution"). In addition, the Company makes a contribution ("Retirement Savings Contribution") to each eligible employee account, currently equal to 3% of eligible pay, regardless of the employee's contribution election. Contributions to the Plan are subject to certain limits imposed by the U.S. Internal Revenue Service ("IRS") and the Plan terms.

**Participant Accounts**

The Plan's recordkeeper maintains an account in the name of each participant to which each participant's contributions, Company's matching contributions, Retirement Savings Contributions and allocations of Plan net earnings and losses, if any, are recorded. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

The Plan currently offers various investment options for participants to direct their investments. Participants may allocate their contributions and Company's contributions among the various investment options at their discretion.

**Vesting**

Participant contributions and the Company's matching contributions are fully and immediately vested. Retirement Savings Contributions are fully vested after any of the following circumstances:

- The participant has completed at least three years of service with the Company;
- The participant reaches age 65 while working for the Company;
- The participant terminates employment with the Company due to becoming totally disabled while working for the Company;
- The participant's job with the Company is eliminated;
- The participant dies while actively employed by the Company;
- The participant terminates employment with the Company due to a business divestiture or business sale;
- The participant terminates employment with the Company due to involuntary layoff or business acquisition.

**Withdrawals**

Participants may apply for hardship withdrawals to satisfy specific and heavy financial needs once they have exhausted all other assets reasonably available to them. The minimum hardship withdrawal is \$500.

**Payment of Benefits**

Should a participant become disabled or terminated from employment, the portion of their Plan account upon which they are vested will be available for distribution as soon as administratively possible after the participant's retirement date, the date they became disabled or their termination date. Upon reaching normal retirement age, a participant may elect to withdraw all or a portion of their entire vested Plan account while still employed by the Company or delay distributions until their retirement date. Required minimum distributions will begin in April of the calendar year following the later of the year in which the participant attains the required minimum distribution age based on date of birth or the year following retirement or termination of employment. Terminated participants must begin taking minimum distributions in April of the year following the year they turn age 72. Beneficiaries must receive the participant's entire vested account balance no later than the December 31 of the calendar year containing the 10th anniversary of the participant's death, unless the beneficiary is an "eligible designated beneficiary". An "eligible designated beneficiary" is (a) surviving spouse, (b) minor child, (c) disabled, (d) a chronically ill individual, or (e) an individual who is not more than 10 years younger than the participant.

**Note Receivable from Participants**

Participants may borrow up to one-half of their non-forfeitable account balances subject to a \$1,000 minimum and up to a maximum equal to the lesser of \$50,000 (less the participants highest outstanding loan balance during the previous 12 months) or 50% of their account balance. The loans have a maximum term of 5 years unless it is for the purchase of a primary residence in which case the loan can have a maximum term of 10 years. The rate of interest on loans remains fixed for the life of the loan. Interest rates are updated through the Loan Interest Rate Update Service ("LIR") based upon the prime rate as reported. Each loan is subject to a \$75 set up fee paid by the participant. There is an additional \$25 maintenance fee deducted from the participant's account annually. The loans are repaid over the term in installments of principal and interest by deduction from pay. A participant also has the right to repay the loan in full, at any time, without penalty.

**Forfeitures**

The Plan provides that forfeitures of nonvested Retirement Savings Contributions, if any, shall be applied to reduce employer contributions and, thereafter, to pay for plan expenses. As of December 31, 2021, forfeited accounts totaled \$24,545. Forfeited accounts of \$359,908 were transferred out of the Plan on December 30, 2022. Forfeited accounts of \$138,152 were used to offset employer contributions for the year ended December 31, 2022. No forfeitures were used during 2022 to pay Plan expenses.

**Revenue Sharing**

The Plan earns a fixed percentage from the recordkeeper on an annual basis. Any revenue produced from the plan is passed back to the plan participants invested in those funds.

**NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES****Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of Estimates in the Preparation of Financial Statements**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investments Valuation and Income Recognition**

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought, during the year, and sold as well as held at the end of the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Initiation and maintenance fees associated with loans are deducted from the individual participant accounts.

**Payments of Benefits**

Benefits are recorded when paid.

**Plan Fees**

Fees related to the administration of investments are included in “Plan Fees,” including fees related to investment management of accounts, and investment advisor fees. Certain expenses of maintaining the Plan such as legal counseling, broker advisor, audit fees, etc. are paid directly by the Company or from forfeitures or revenue sharing as available. Expenses paid by the employer on behalf of the Plan in 2022 totaled \$84,835.

**Subsequent Events**

The Plan has evaluated subsequent events through May 23, 2023, the date the financial statements were available to be issued, and has determined no material events occurred which require recognition or disclosure in the financial statements.

### NOTE 3 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1, which refers to inputs to the valuation methodology which are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date; Level 2, which refers to inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; Level 3, which refers to inputs to the valuation methodology that are based on prices or valuations that include unobservable measurements, and include situations where there is little, if any, market activity for the asset.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are considered to be actively traded and are classified as Level 1.

#### Common Collective Trusts

The Plan has investments in the Stable Value Fund which is a common collective trust composed of investment contracts. The fund is valued at the net asset value (NAV) per share of the fund as a practical expedient. The practical expedient would not be used if it is determined to be probable that the fund would sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The fund's units are issued and redeemed daily at the constant NAV of \$1 per unit.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 — INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee, has certified that the following data included in the accompanying financial statements and Supplemental Schedule of Assets (Held at End of Year) as of December 31, 2022, the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

**NOTE 5 — RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares in mutual funds managed by Fidelity. Fees paid by Plan participants to Fidelity for investment management services amounted to \$23,460 for the year ended December 31, 2022. Dividend income from Fidelity affiliated funds amounted to \$256,911 for the year ended December 31, 2022. For the year ended December 31, 2022, interest income related to notes receivable from participants amounted to \$10,347. These transactions qualify as party-in-interest transactions permitted under the provisions of ERISA.

Certain administrative functions are performed by officers or employees of the Plan Sponsor who may also be participants in the Plan. These actions qualify as permitted party-in-interest activities. No such officer or employee receives compensation from the Plan. Refer to Note 2 for a description of fees paid by the Plan Sponsor.

**NOTE 6 — PLAN TERMINATION**

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. All assets of the Plan were merged into the Retirement Savings Plan as of December 30, 2022 and the Plan ceased to exist as a separate plan after that date.

**NOTE 7 — TAX STATUS**

The Plan is a volume submitter profit sharing plan that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and, therefore, the related trust is tax-exempt. In accordance with Revenue Procedure 2010-6 and Announcement 2005-16, the Company has determined that it is eligible to and has chosen to rely on the current IRS volume submitter plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps to maintain the Plan's qualified status. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that Plan is qualified and; therefore, the related trust is exempt from taxation. Accordingly, no provisions for taxes have been reflected in the financial statements of the Plan.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022 and December 31, 2021, there were no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. At December 31, 2022, the years 2019 and thereafter remain subject to examination.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of assets available for benefits. Individual participants' accounts bear the risk of loss resulting from fluctuations in investment values.
