Accordingly, the Plan has changed its basis of accounting to the liquidation basis of accounting used in presenting the Plan's 2022 financial statements. Our opinion is not modified with respect to this matter.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – Description of Plan

The following description of Hacienda Post Acute, Inc. 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan was a defined contribution plan covering substantially all employees of Hacienda Post Acute, Inc. (the Company) except for leased employees. Employees were eligible to participate in the Plan after completing one year of service (including at least 1,000 hours) and attaining the age of 21. All participants were eligible to receive employer matching contributions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination – During 2022, the Shareholders and Board of Directors of Hacienda Post Acute, Inc., the Plan Sponsor, approved the termination of the Plan with an effective termination date of May 1, 2022. The termination results in all participants becoming fully vested as of May 1, 2022. The termination required all accounts to be distributed by participant direction, distributed in accordance with the force out process as defined in the Plan document, or to be rolled into an Individual Retirement Account. All balances were distributed as of August 12, 2022. As a result of the liquidation, the 2022 financial statements have been presented on the liquidation basis of accounting. No liabilities were recognized in connection with the termination.

Contributions – Each year participants could contribute to the Plan by electing to defer a portion of their total annual earnings. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Pre-tax 401(k) contributions were allowed up to the maximum limit allowed by the Internal Revenue Service. At the option of the Company, the Company could elect to contribute a discretionary matching contribution to the Plan. During the period ended August 12, 2022, the Company did not make any matching contributions to the Plan.

Investment Options – Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan offered pooled separate accounts.

Participant Accounts – Each participant's account would be credited with the participant's contribution, the Company's discretionary matching contribution, if any, and an allocation of Plan earnings. Plan earnings were allocated based on a ratio of the participant's account balance to the total investment account balance. The benefit to which a participant was entitled was the vested amount in his or her individual account.

Vesting – Participants were immediately vested in their elective deferral contribution plus actual earnings thereon. If a participant terminated employment prior to normal retirement age (65) for reasons other than death or disability, the portion of the matching contribution was vested based on years of eligible service. Vesting in benefits derived from employer contributions, plus earnings thereon, were based on years of continuous eligible service, in accordance with the following graduated scale:

Payment of Benefits – Upon death, disability or retirement, participants elected to receive benefits as a lump-sum or in installment payments. Account balances under \$5,000 were automatically disbursed as lump-sum distributions. Upon termination of service, the participants' elective deferral contributions, plus any vested portion of the Company's contributions were disbursed to the participants, unless they had a balance of at least \$5,000 and elect to remain in the Plan. Benefits were recorded when paid.

Hardship Withdrawals – The Plan allowed for hardship withdrawals, limited to the participant's elective deferral account balance.

Notes Receivable from Participants – Participants could borrow from their fund accounts a maximum of \$50,000 or 50 percent of their vested account balance and a minimum of \$1,000. Participants could only have one outstanding loan at any time. Loan terms ranged to a maximum of five years, with exceptions for the purchase of a primary residence, in which the maximum loan term was 15 years. Loan payments were made through a payroll deduction, with payments not less frequently than quarterly. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the Plan trustees.

Trustees of Plan Assets – The Plan Administrator was the Company. The Plan trustees were employees of the Company. The Plan Administrator entered into a service contract with John Hancock Life Insurance Company (John Hancock), the custodian of the Plan. Under the terms of the contract, John Hancock held the Plan's investment assets and executed investment transactions. As permitted by Department of Labor regulations, John Hancock has certified certain financial information contained in the statements of net assets available for benefits and the statement of changes in net assets available for benefits to be complete and accurate.

Operating Expenses – As provided in the Plan agreement, administrative expenses could be paid by either the Plan or by the Company. Fees paid by the Company were excluded from these financial statements.

Forfeitures – A forfeiture is a non-vested portion of the participant's account that the participant loses upon termination of employment. Forfeitures could be used to reduce the employer matching contributions, restore forfeited account balances, or pay Plan expense in the Plan year in which the forfeiture occurred. There were no forfeitures available for the period ended August 12, 2022 or the year ended December 31, 2021.

NOTE 2 – Summary of Significant Accounting Policies

Basis of Accounting – The financial statements have been prepared on the liquidation basis of accounting as of August 12, 2022 and for the period then ended in accordance with accounting principles generally accepted in the United States of America. The financial statements have been prepared on the accrual basis of accounting as of December 31, 2021 in accordance with accounting principles generally accepted in the United States of America.

Investment Accounts – Investments were maintained in pooled separate accounts.

NOTE 2 – Summary of Significant Accounting Policies (continued)

Investment Valuation – Investments were stated at fair value. The Plan’s custodian, John Hancock, certified the value of the pooled separate accounts.

Purchases and sales of securities were recorded on trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan’s gains and losses on investments bought and sold, as well as held during the period. Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e. the “exit price”) in an orderly transaction between market participants at the measurement date.

Pooled separate account – Each pooled separate account invested its assets solely in the shares or units of an underlying mutual fund and the investment objective of each sub-account corresponds to the investment objective of the underlying fund. The NAV practical expedient was based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. There were no restrictions related to redemption frequency or requirements of redemption notice.

There were no changes in the methodologies used at August 12, 2022 or December 31, 2021. At August 12, 2022 and December 31, 2021, the fair value of the pooled separate accounts was \$0 and \$400,173, respectively.

Notes Receivable From Participants – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as deemed distributions based upon the terms of the plan document.

Temporary Plan Provisions – On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was passed by Congress. The CARES Act contains several provisions that temporarily impacted retirement plans, including the waiver of required minimum distributions, a new hardship withdrawal option, increased loan limits, and a pause option for loan payments. The provisions of the CARES Act could be effective and operationalized immediately, prior to amending the plan document. These provisions were implemented and operational during the 2020 Plan year; thereafter, the Plan document was formally amended during the 2022 Plan year.

Plan Amendment – During the 2022 Plan year, the Plan was formally amended to add provisions for hardship distributions. Such provisions included making earnings on all elective deferrals available for hardship distributions, the elimination of the six-month suspension period, the elimination of the requirement for a participant to first take a Plan loan, added criteria for satisfying an immediate and heavy financial need, and added safe harbor financial needs criteria. The effective date of the amendment was January 1, 2020.

NOTE 3 – Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that can affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reported period. Actual results could differ from those estimates.

NOTE 4 – Information Certified by the Custodian of the Plan

The Plan trustees have elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of August 12, 2022 and December 31, 2021;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period ended August 12, 2022;
- Investment information included in the footnotes as of August 12, 2022 and December 31, 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

NOTE 5 – Notes Receivable from Participants

The Plan made loans to participants secured by their vested account balances. Participants could borrow from their fund accounts a maximum of \$50,000 or 50 percent of their vested account balance and minimum of \$1,000. Participants could only have one outstanding loan at any time. Loan terms ranged to a maximum of five years, with exceptions for the purchase of a primary residence, in which the maximum loan term was 15 years. Loan payments are made through a payroll deduction, with payments not less frequently than quarterly. Loans were secured by the vested account balance of the participant, but not in excess of 50% of such vested account balance at the time the loan was granted.

NOTE 6 – Plan Termination

The Shareholders and Board of Directors of Hacienda Post Acute, Inc., the Plan Sponsor, of the Plan approved the termination of the Plan with an effective termination date of May 1, 2022. The termination results in all participants becoming fully vested as of May 1, 2022. The termination required all accounts to be distributed by participant direction, distributed in accordance with the force out process as defined in the Plan document, or to be rolled into an Individual Retirement Account. All balances were distributed as of August 12, 2022.

NOTE 7 – Income Tax Status

The Plan had adopted a non-standardized plan and trust sponsored by All Valley Administrators, LLC. In a letter dated March 31, 2014, the Internal Revenue Service notified the sponsor that the Plan was qualified, and the trust established under the Plan was tax-exempt under the appropriate sections of the Internal Revenue Code. The Plan had been amended to incorporate provisions of law changes since receiving the original designation letter. The Plan trustees believed that the Plan was designed and operating in compliance with the applicable requirements of the Internal Revenue Code.

In accordance with the guidance on accounting for uncertainty in income taxes, the Plan trustees evaluated the Plan's tax positions and did not believe the Plan had any uncertain tax positions that required disclosure in or adjustment to the financial statements. The Plan was subject to routine audits by taxing jurisdictions. There is currently an IRS examination in progress for the tax period ended December 31, 2020.

NOTE 8 – Related Party and Party-in-Interest Transactions

Certain Plan investments were held in investment vehicles managed by John Hancock, a party-in-interest. These transactions qualified as party-in-interest transactions. The Plan had a number of service providers. Such providers were parties-in-interest under ERISA. Fees for the Plan amounted to \$1,099 for the Plan period ended August 12, 2022 and are considered party-in-interest transactions.

NOTE 9 – Subsequent Events

The Plan did not have any subsequent events through May 22, 2023, which is the date the financial statements were issued, requiring recording or disclosure in the financial statements for the period from January 1, 2022 through August 12, 2022.


