***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Home Products International - North America, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits in liquidation as of October 31, 2022 (date of liquidation) and the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits in liquidation for the ten months ended October 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2022 and December 31, 2021, and for the ten months ended October 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Plan Termination and Liquidation***

As described in Note 3, as a result of Home Products International - North America, Inc. (the Plan Sponsor) filing bankruptcy in June 2022, the Administrative Committee approved the termination of the Plan effective June 3, 2022, and a plan of liquidation was developed shortly thereafter. All net assets were distributed during the ten months ended October 13, 2022. Our opinion is not modified with respect to this matter.

### ***Liquidation Basis of Accounting***

As discussed in Note 1 to the financial statements, the Administrative Committee approved a plan of liquidation on June 3, 2022, and the Plan determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis to a liquidation basis. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit;
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements;
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed;
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements; and
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

***Auditors' Responsibilities for the Audit of the Financial Statements (continued)***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTES TO FINANCIAL STATEMENTS**

OCTOBER 31, 2022 (DATE OF LIQUIDATION) AND DECEMBER 31, 2021

**NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - The accompanying financial statements of Home Products International - North America, Inc. Retirement Savings Plan (the Plan) have been prepared using the accrual basis of accounting. The Administrative Committee approved termination of the Plan and implemented a plan of liquidation as of June 3, 2022, and the Plan determined liquidation to be imminent. Generally accepted accounting principles require that an entity in liquidation measure assets to reflect the estimated amount of cash or other consideration that it expects to collect in settling or disposing of those assets in carrying out its plan for liquidation, and to adjust its liabilities to reflect changes in assumptions that are a result of the entity's decision to liquidate.

**Investments** - The investments of the Plan were reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments were reflected on a trade-date basis.

Dividend income was recorded on the ex-dividend date. Interest income was recorded on the accrual basis.

**Notes Receivable from Participants** - Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses had been recorded as of December 31, 2021. Delinquent participant loans were recorded as distributions based upon the terms of the Plan document.

**Payment of Benefits** - Distributions to participants were recorded when paid. There were no participants who elected a withdrawal from the Plan but were not yet paid at December 31, 2021.

**Expense Offset Arrangement** - Fees incurred by the Plan for investment management services were included in net (depreciation) in fair value of investments, as they were paid through revenue sharing, rather than a direct payment.

**Expenses** - Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by Home Products International - North America, Inc. (the Company). Expenses paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses.

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

## **NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Subsequent Events** - Subsequent events have been evaluated through May 24, 2023, which is the date the financial statements were available to be issued.

## **NOTE 2. DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan was a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan were not insured by the Pension Benefit Guaranty Corporation. The Plan covered all full-time non-union employees of the Company. Prior to its termination as described in Note 3, participation in the Plan was open to employees who had 30 days of service and were at least 18 years of age.

John Hancock Trust Company, LLC was engaged as the Trustee of the Plan, and John Hancock Retirement Plan Services, LLC provided participant recordkeeping.

Prior to its termination as described in Note 3, each year, participants contributed up to 50% of pre-tax annual compensation, as defined by the Plan and subject to certain limitations. Employees who did not decline participation upon eligibility were automatically enrolled in the Plan at a set deferral rate of 4%, subject to annual escalations to a maximum of 6%, of eligible compensation, as defined by the Plan. Rollover contributions from other qualified plans were also allowed.

Prior to its termination as described in Note 3, the Company contributed 50% of the first 6% of an employee's base compensation contributed to the Plan. Effective with the April 30, 2021 payroll, the Company match was suspended and not reinstated. The Plan provided that additional amounts be contributed at the option of the Company's Board of Directors as discretionary profit sharing contributions. Allocations of contributions were subject to certain limitations. Participants must have been employed as of the last day of the Plan year to be eligible for an allocation of the discretionary profit sharing contribution made for the Plan year. There were no discretionary contributions made during the ten months ended October 31, 2022.

Prior to its termination as described in Note 3, upon enrollment in the Plan, participants directed contributions in varying increments into any of the available investment options. In the absence of participant direction, contributions were invested in accordance with default investment alternatives established under the Plan. Participants were allowed to change their investment options daily.

Prior to its termination as described in Note 3, each participant's account was credited with the participant's contribution and allocations of the Company's contributions and Plan earnings, and were charged with an allocation of administrative expenses, if any. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

## NOTE 2. DESCRIPTION OF THE PLAN (CONTINUED)

Prior to its termination as described in Note 3, participants were immediately vested in their contributions plus actual earnings thereon. Through April 2016, vesting in the Company's matching and discretionary contribution portion of participant accounts plus actual earnings thereon was based on years of continuous service, as follows:

Effective May 1, 2016, the Plan was restated, and participants were immediately fully vested in the Company's matching and discretionary contribution portion of participant accounts plus actual earnings thereon.

Pursuant to Plan termination as described in Note 3, all participants became fully vested in their account balance.

The amount of forfeited nonvested account balances at December 31, 2021 was \$31,915. Forfeited nonvested account balances were available to reduce future Company contributions or pay Plan administrative expenses. Forfeitures used to pay Plan administrative expenses for the ten months ended October 31, 2022 totaled \$32,303.

Under provisions of the Plan prior to its termination, upon termination of service due to death, disability or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in the account, or annual periodic installments if the participant's account balance exceeds \$5,000. For termination of service due to other reasons, a participant could receive the value of the vested interest in the account as a lump-sum distribution. Participants in service were allowed to make hardship withdrawals from their vested contributions upon demonstrating immediate and heavy financial need, as allowed under federal rules.

Under provisions of the Plan prior to its termination, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at a rate commensurate with the local prevailing rate. Loans were required to be paid back within five years; however, this period was allowed to be extended to ten years if the loan was used for the acquisition of a primary residence. Interest rates on outstanding notes receivable from participants as of December 31, 2021 ranged from 4.25% to 6.50%. Principal and interest were generally repaid ratably through payroll deductions.

**NOTE 2. DESCRIPTION OF THE PLAN (CONTINUED)**

The Plan failed to pass the Average Deferral Percentage (ADP) test and the Actual Contribution Percentage (ACP) test for both 2022 and 2021. Excess participant contributions of approximately \$2,000 were distributed back to the participants in June 2022. Excess contributions of approximately \$14,000 as of December 31, 2021 were distributed back to the participants in March 2022. Due to the immaterial nature of the amount of corrections, the contribution refunds payable at December 31, 2021 was not recorded as a liability in the accompanying financial statements.

Participants should refer to the summary plan description for more complete information.

**NOTE 3. PLAN TERMINATION**

On June 2, 2022, the Company filed for bankruptcy and permanently ceased operations. As a result, the Company instructed John Hancock, the Trustee and recordkeeper of the Plan, that the Plan was terminated effective June 3, 2022. Participant accounts became fully vested as of that date. Pursuant to termination of the Plan, John Hancock initiated a blackout period to allow for the processing of final contributions, reconciliation and required compliance tests. The final distribution of assets was made on October 13, 2022.

There were no items not previously recognized by the Plan that it expected to use to settle liabilities, nor any costs to dispose of assets pursuant to liquidation. No adjustments to the Plan's carrying amounts of any assets or liabilities were necessary in order to conform to the liquidation basis of accounting.

**NOTE 4. TAX STATUS**

The Internal Revenue Service determined that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code. The Plan was amended since the date of this determination. The Plan Administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan was qualified and the related trust was tax-exempt through the date of termination.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## NOTE 5. FAIR VALUE MEASUREMENTS

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

### Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following table sets forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2021. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in these funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

Measurements Using Net Asset Value as a Practical Expedient

The collective investment funds are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The collective investment funds are direct filing entities (DFEs) and file a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions are available on a daily basis without notice.

Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.
