REPORT OF INDEPENDENT AUDITORS

To the Management and Participants of
HPI Chicago Union Employees'
Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of HPI Chicago Union Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits in liquidation as of October 31, 2022 (date of liquidation) and the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits in liquidation for the ten months ended October 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2022 and December 31, 2021, and for the ten months ended October 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation

As described in Note 3, as a result of Home Products International - North America, Inc. (the Plan Sponsor) filing bankruptcy in June 2022, termination of the Plan was approved effective July 29, 2022, and a plan of liquidation was developed shortly thereafter. All net assets were distributed during the ten months ended October 31, 2022. Our opinion is not modified with respect to this matter.

Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Company approved a plan of liquidation on July 29, 2022, and the Plan determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis to a liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed;
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements; and
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Auditors' Responsibilities for the Audit of the Financial Statements (continued)

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

OCTOBER 31, 2022 (DATE OF LIQUIDATION) AND DECEMBER 31, 2021

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements of HPI Chicago Union Employees' Retirement Plan (the Plan) have been prepared using the accrual basis of accounting. The Plan sponsor approved termination of the Plan and implemented a plan of liquidation as of July 29, 2022, and the Plan determined liquidation was imminent. Generally accepted accounting principles require that an entity in liquidation measure assets to reflect the estimated amount of cash or other consideration that it expects to collect in settling or disposing of those assets in carrying out its plan for liquidation, and to adjust its liabilities to reflect changes in assumptions that are a result of the entity's decision to liquidate.

Investments - The investments of the Plan were reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments were reflected on a trade-date basis.

Dividend income was recorded on the ex-dividend date. Interest income was recorded on the accrual basis.

Notes Receivable from Participants - Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses had been recorded as December 31, 2021. Delinquent participant loans were recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits - Benefit payments were recorded upon distribution. There were no participants who elected a withdrawal from the Plan but were not yet paid at December 31, 2021.

Expense Offset Arrangement - Fees incurred by the Plan for investment management services were included in net (depreciation) in fair value of investments, as they were paid through revenue sharing rather than a direct payment.

Expenses - Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by Home Products International - North America, Inc. (the Company). Expenses paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Subsequent Events - Subsequent events have been evaluated through May 24, 2023, which is the date the financial statements were available to be issued.

NOTE 2. DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan was a defined contribution retirement plan covering all eligible employees of the Company primarily employed in the Chicago metropolitan area and included in the unit of employees covered by the collective bargaining agreement between the Company and Plastic Workers Union Local No. 18. Eligible employees must also have been at least 18 years of age with 30 days of employment or have completed 1,000 hours of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan were not insured by the Pension Benefit Guaranty Corporation.

John Hancock Trust Company, LLC was engaged as Trustee of the Plan, and John Hancock Retirement Plan Services, LLC provided participant recordkeeping.

Under provisions of the Plan prior to its termination as described in Note 3, participants made voluntary pre-tax or after-tax contributions. Rollover contributions from other qualified plans were also allowed, provided that such contributions satisfied all applicable requirements for rollover treatment. Monthly Company contributions to the Plan were equal to \$92 per participant. Participants must have been at least 18 years of age and have completed one year of eligible service to be eligible for Company contributions.

Under provisions of the Plan prior to its termination as described in Note 3, participants could elect to contribute up to a maximum of 100% of their pre-tax compensation, as defined by the Plan and subject to certain limitations. Participants directed contributions to various investment options offered by the Plan. In the absence of participant direction, contributions were invested in accordance with the default investment alternatives established under the Plan

Individual accounts were maintained for each participant to reflect the participant's and Company contributions, as well as allocations of investment earnings and administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

NOTE 2. DESCRIPTION OF THE PLAN (CONTINUED)

Under provisions of the Plan prior to its termination described in Note 3, participants were immediately 100% vested in their voluntary and rollover contributions plus actual earnings thereon. All Company contributions made on or before November 1, 2013 became 100% vested. Subsequent to November 1, 2013 through August 15, 2017 and prior to the Plan's termination as described in Note 3, participants became vested in the Company contribution portion of their accounts plus actual earnings thereon based on years of continuous service, as follows:

Subsequent to August 15, 2017 and prior to the Plan's termination as described in Note 3, participants become vested in the Company contribution portion of their accounts plus actual earnings thereon based on years of continuous service, as follows:

Pursuant to the Plan's termination as described in Note 3, all participants became fully vested in their account balance.

Under provisions of the Plan prior to its termination as described in Note 3, upon termination of service due to death, disability or retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's account. For termination of service due to other reasons, a participant could also receive the value of the vested interest in the account as a lump-sum distribution. A participant who had attained the later of normal retirement or age 62 and whose account balance exceeded \$5,000 could elect to take partial withdrawals or installments but only with respect to lifetime minimum required distributions over a period of not more than the participant's (or the participant's and participant's beneficiary's) assumed life expectancy.

Forfeited nonvested account balances were available to pay administrative expenses, reduce Company contributions, or to be reallocated to the remaining participants' accounts. No forfeitures were incurred for the ten months ended October 31, 2022. There were no forfeited non-vested account balances at December 31, 2021.

Under provisions of the Plan prior to its termination as described in Note 3, participants could borrow from their accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at a rate commensurate with the local prevailing rate as determined by the Plan Administrator. Loans were required to be paid back within five years; however, this period was allowed to be extended to 15 years if the loan was used for the acquisition of a primary residence. Interest rates on outstanding notes receivable from participants as of December 31, 2021 ranged from 4.25% to 7.00%. Principal and interest were generally repaid ratably through payroll deductions.

Participants should refer to the summary plan description for more complete information.

NOTE 3. PLAN TERMINATION

On June 2, 2022, the Company filed for bankruptcy and permanently ceased operations. As a result, the Company instructed John Hancock, the Trustee and recordkeeper of the Plan, that the Plan was terminated effective July 29, 2022. Participant accounts became fully vested as of that date. Pursuant to termination of the Plan, John Hancock initiated a blackout period to allow for the processing of final contributions, reconciliation and required compliance tests. The final distribution of assets was made on October 27, 2022.

There were no items not previously recognized by the Plan that it expected to use to settle liabilities nor any costs to dispose of assets pursuant to liquidation. No adjustments to the Plan's carrying amount to any assets or liabilities were necessary in order to conform to the liquidation basis of accounting.

NOTE 4. TAX STATUS

The Internal Revenue Service determined that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code. The Plan was amended since receiving its determination. The Plan Administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan was qualified and the related trust was tax-exempt through the date of termination.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5. FAIR VALUE MEASUREMENTS

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

The following table sets forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2021. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of net assets available for benefits.

Level 1 Measurements

The fair values of the mutual funds are determined by reference to the underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

Measurements Using Net Asset Value as a Practical Expedient

The collective investment funds are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The collective investment funds are direct filing entities (DFEs) and file a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions are available on a daily basis without notice.

NOTE 6. INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The following information regarding the Plan's investments and investment income as of December 31, 2021 and for the ten months ended October 31, 2022, was obtained by management and agreed to or was derived from information certified as complete and accurate by John Hancock Trust Company, LLC, the Trustee of the Plan:

NOTE 7. CONCENTRATION OF INVESTMENTS

As of December 31, 2021, the Plan held a significant portion of its assets in three investment funds with a fair value of \$1,763,472, which represented approximately 84% of net assets available for benefits. These investment funds were broadly diversified through their investments in various equity and fixed income index funds and exchange-traded funds.
