## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Jay Packaging Group, Inc. 401(k) Retirement Plus Plan:

### **Opinion**

We have audited the accompanying financial statements of the Jay Packaging Group, Inc. 401(k) Retirement Plus Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the Statements of Net Assets Available for Plan Benefits as of August 15, 2022 and December 31, 2021, and the related Statement of Changes in Net Assets Available for Plan Benefits for the period January 1, 2022 to August 15, 2022, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of August 15, 2022 and December 31, 2021, and the changes in its net assets available for benefits for the period January 1, 2022 to August 15, 2022, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### **Emphasis of Matter**

As discussed in Note 7, the Plan was merged into another plan on August 15, 2022. As a result, all investments were transferred from the Plan on that date.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**1. Description of the Plan**

The following description of the Jay Packaging Group, Inc. 401(k) Retirement Plus Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution plan covering all employees of Jay Packaging Group, Inc. (the Employer or Plan Sponsor), who are eighteen years old or older and have completed at least six months of service. The Plan is administered by a three-member administrative committee (Plan Administrator), appointed by the Board of Directors of the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In 2022, the Board of Directors approved the merger of the Plan into the Rohrer Corporation Amended and Restated Profit-Sharing Plan and Trust (Rohrer Plan). All assets of the Plan were transferred to the Rohrer Plan on August 15, 2022. See Note 7 for additional details.

***Contributions***

Eligible employees may elect to contribute any percentage of their eligible compensation, not to exceed annual limitations as provided by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Participants may also contribute to the Plan amounts representing distributions from other qualified plans (rollover contributions).

The Employer can elect to contribute a discretionary matching contribution as determined by the Employer's Board of Directors. Employer discretionary matching contributions are allocated to the accounts of the individuals who are participants in the Plan at month-end for which such contributions are made and who meet the eligibility requirements, as defined. Employer discretionary matching contributions are allocated based on the participant's elective deferral and wages. No Employer discretionary matching contributions were made to the Plan during 2022.

The Employer, at its discretion, may also elect to make a discretionary profit-sharing contribution as determined by the Employer's Board of Directors. Discretionary profit-sharing contributions are allocated to the accounts of the individuals who are participants and employed by the Employer on the last day of the Plan's year for which such contributions are made and who have completed 1,000 hours of service during the Plan year. In the event that a participant left the Employer within the Plan year because of retirement, death or total and permanent disability, the participant will receive a share of the Employer's discretionary profit-sharing contribution, regardless of hours of service. Discretionary contributions are allocated based on the compensation of all eligible participating employees. No discretionary profit-sharing contributions were made to the Plan during 2022.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution and Plan earnings and losses. The allocation of earnings and losses is performed based on individual participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions (including rollover contributions) plus actual earnings on those contributions. Participants become fully vested in the Employer contributions and earnings on those contributions after three years of service. Upon death, disability or attainment of normal retirement age, a participant will become fully vested in their accounts.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from 1 to 5 years, or up to 15 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 2% as determined at the date of inception. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits and Withdrawals***

On retirement, death, disability or termination of service, participants (or participant's beneficiary in the event of death) may receive the value of their vested account in a lump-sum amount or substantially equal installments. Alternatively, participants may elect to defer the distribution. If a participant terminates employment for any reason and their vested account balance does not exceed \$1,000, the Plan Administrator may distribute such amount as a lump-sum payment. If a participant has reached age 59½, distributions may be made, at the participant's election while still employed by the Plan Sponsor.

Hardship withdrawals from the Plan are not permitted.

***Forfeitures***

Participants in the Plan who leave the employment of the Employer before completing the applicable vesting requirements forfeit the non-vested portion of Employer contributions to their accounts. Forfeitures may be used to pay administrative expenses, reduce Employer contributions and/or be allocated as an additional Employer contribution to the Plan. As of December 31, 2021, forfeited non-vested accounts totaled \$19,625. Forfeited non-vested accounts totaling \$21,624 were included in the transfer of assets to the Rohrer Plan completed on August 15, 2022 (Note 7).

***Plan Termination***

The Employer was purchased by Rohrer Corporation on December 16, 2021. The Board of Directors voted to terminate the Plan, and on August 15, 2022 all Plan assets were transferred to the Rohrer Plan.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document. No allowance for credit losses was recorded as of December 31, 2021.

***Contributions***

Contributions from employees are recorded weekly when the Employer remits the payroll deductions for investment into the Plan. Employer matching contributions are recorded monthly, if applicable. Employer discretionary profit-sharing contributions are recorded at the end of the year, if applicable.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess amounts allowed by the Internal Revenue Service (the “IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants subsequent to year end.

***Administrative Expenses***

Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

***Financial Instruments with a Concentration of Credit Risk***

For the period January 1, 2022 to August 15, 2022, the Plan’s investments were held by a single custodian. The Plan’s exposure to credit risk is associated with the outside entity’s non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

The Plan Administrator has evaluated subsequent events through May 18, 2023, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Money Market Fund:* The carrying amount of the money market fund is deemed to be a reasonable estimate of fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As a result of the plan merger, there are no investment balances at August 15, 2022 (Note 7).

**4. Income Tax Status**

The Plan has been designed using a Non-Standardized Pre-Approved Profit Sharing Plan With CODA document designed by The Angell Pension Group, Inc. The Angell Pension Group, Inc. received an advisory letter dated June 30, 2020, in which the IRS stated that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA satisfies the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter in order to comply with the latest applicable tax laws and regulations. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of August 15, 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**6. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Empower Retirement, LLC (Empower). Therefore, transactions with Empower qualify as party-in-interest transactions. The Plan made direct payments to Empower for administrative services of \$713 for the period January 1, 2022 to August 15, 2022. Participant notes receivable also qualify as party-in-interest transactions.

**7. Plan Merger**

The Plan Administrator adopted a resolution to merge the Plan into the Rohrer Plan on August 15, 2022. As a result, all participant balances were transferred to the Rohrer Corporation Amended and Restated Profit Sharing Plan and Trust on that date. The assets transferred from the Plan totaled \$8,067,451, including participant notes receivable of \$141,339. On August 15, 2022, the Plan was formally terminated.

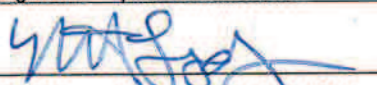
