INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
of **McGuyer Homebuilders, Inc. Savings Plan**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the McGuyer Homebuilders, Inc. Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 2, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through March 2, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 2, 2022 and December 31, 2021, and for the for the period from January 1, 2022 through March 2, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Merger

As further discussed in Note 1 to the financial statements, effective January 1, 2022, the Plan merged into the Dream Finders Homes 401(k) Plan, resulting in all assets being transferred out of the Plan by March 2, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan

General

The McGuyer Homebuilders, Inc. Savings Plan (the Plan) is a defined contribution plan established on January 1, 1993 for employees of McGuyer Homebuilders, Inc. (the Company). In addition to the employees of the Company, the Plan also covers the employees of MHI Partnership, Ltd. and Homeco Purchasing Company, both of which share common ownership with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

In October 2021, the assets of the Company were acquired by Dream Finders Homes, LLC. In connection therewith, the Plan was merged into the Dream Finders Homes 401(k) Plan (Dream Finders Homes Plan) effective as of January 1, 2022, resulting in all assets being transferred out of the Plan by March 2, 2022.

The following description of the Plan provides only general information as it relates prior to the merger. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

Administration

The Plan Sponsor and named Plan Administrator is the Company. The Plan Administrator is responsible for oversight of the Plan. The Plan Retirement Committee (the Committee), appointed by the Board of Directors of the Company, determines the appropriateness of investment performance and fees. State Street Bank and Trust Company serves as the Trustee and holds all of the Plan's assets and executes all of the Plan's transactions. Transamerica Retirement Solutions, LLC performs the record keeping for the Plan.

Eligibility

All employees are eligible to participate in the Plan on the first of the month coincident with or next following the completion of 60 days of services and the attainment of 18 years of age.

Participant Contributions

Each year, participants may make salary deferral and Roth contributions of up to 90% of pretax annual compensation, as defined in the Plan agreement. Participants age 50 or older during the Plan year may also elect to make a "catch-up" contribution. The Plan includes a provision whereby eligible employees are automatically enrolled in the Plan at a contribution rate of 3% of eligible compensation, unless they opt out. Thereafter, the auto-enrolled participants have incremental contribution rate increases of 1% per year for seven years, or until the contribution rate has been increased to 10% of eligible compensation, after which no other increases are made unless directed by the participant. Participants may change their contribution rates or may suspend contributions at any time.

Participant Contributions (Continued)

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans and other types of sources including certain annuity contracts, certain Individual Retirement Accounts and certain plans maintained by a state or a political subdivision thereof. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Employer Contributions

The Company may make discretionary matching contributions and non-elective contributions. Contributions are subject to certain IRS limitations.

Participant Accounts

Participants direct the investment of both their individual contributions plus their share of employer contributions into the various investment options offered by the Plan. The employer contributions are allocated in the same manner as that of the participant's elective contributions. Each participant's account is credited with the participant's contributions and the allocation of the employer contributions, Plan earnings, and administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the balance of his or her vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of (a) \$50,000 or (b) 50% of their vested account balance. A participant may only have three loans outstanding at any time. Loan terms range from one to five years, or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate, plus 1%. Principal and interest are generally paid through payroll deductions; however, the Plan does have a provision in place to allow terminated employees to continue making payments on unpaid notes.

Payment of Benefits

A participant is eligible for a distribution of their vested account balance following termination of employment, attaining age 59 ½, normal retirement, death or disability. Distributions are made in the form of lump sum payments or installment payments in accordance with the Plan agreement. Terminated participant are allowed to leave their funds in the Plan indefinitely if their account balance exceeds \$5,000. If the vested account balance is \$5,000 or less, the account will be distributed to the participant as a lump-sum distribution. In-service distributions may be made to a participant who has not separated from service and has attained age 59 ½ provided the amount being withdrawn has accumulated in the Plan for at least two years. Hardship withdrawals are available to participants after the participant has met the hardship withdrawal requirements stated in the Internal Revenue Code (IRC).

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. A participant vests in the Company contributions, plus actual earnings thereon, based on a graded scale, with full vesting occurring after six years of credited service. Participants also become 100% vested upon death, disability, or attainment of normal retirement age.

Forfeited Accounts

Forfeitures may be used to offset employer match contributions or pay administrative expenses. As of December 31, 2021, the balance in the forfeiture account totaled \$1,624.

Administrative Expenses

All expenses related to the administration of the Plan may be paid from the Plan, if not paid by the Company. The Plan maintains an Expense Budget Account (EBA) that is used to pay qualified Plan related expenses. The EBA is credited monthly with a percentage (0.10%) of the participants' account balances in each investment option. At December 31, 2021, the balance available in the EBA was \$41,035. The Plan has entered into a revenue sharing agreement with the recordkeeper, with such amounts allocated to participants for administrative expenses paid from participant accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting and present the net assets available for benefits and changes in those net assets in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded. If a participant ceases to make repayments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance on the note receivable from the participant is reclassified to benefits paid to participants.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. The administrative expenses reflected in the financial statements include the expenses paid from the EBA account as well as loan fees, withdrawal fees and investment fees.

Investment fees paid to the Trustee are deducted directly from the participants' accounts based on the stated plan service fees associated with the particular funds in which the participants had invested. During 2022, \$5,643 in such fees were deducted from the participants' accounts and are included in administrative expenses.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including June 6, 2023, which is the date the financial statements were available to be issued.

Note 3 - Unaudited Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520-103-8 of the Department of Labor's Rules and Regulations for Reporting under ERISA. As permitted under such election, the following information has been certified by State Street Bank and Trust Company as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors, except for comparing such information with the related information included in the financial statements:

- All investment balances reflected in the accompanying statements of net assets available for benefits as of March 2, 2022 and December 31, 2021,
- All investment income reflected in the statement of changes in net assets available for benefits for the period from January 1, 2022 through March 2, 2022, and
- Notes receivable from participants as of March 2, 2022 and December 31, 2021, and the related interest income on notes receivable from participant for the period from January 1, 2022 through March 2, 2022.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at March 2, 2022 and December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts consist of mutual funds that are valued on the basis of readily determinable market prices.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Investment Contract with Insurance Company

Prior to the merger disclosed in Note 1, The Plan participated in a fully benefit-responsive investment contract (FBRIC) with New York Life Insurance Company (New York Life). This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the FBRIC was \$2,564,368 as of December 31, 2021.

The Plan Administrator adhered to the terms of the FBRIC when notifying New York Life of its intent to terminate the contract in connection with the Plan's merger. Accordingly, the FBRIC was liquidated at contract value and the resulting cash was transferred to the Dream Finders Homes Plan during the period January 1, 2022 through March 2, 2022.

Note 6 - Tax Status

The Plan has adopted the Transamerica Retirement Solutions, LLC Volume Submitter 401(k) Profit Sharing Plan (the Volume Submitter Plan). On March 31, 2014, the Volume Submitter Plan received an advisory letter from the Internal Revenue Service (IRS) which stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the letter, the Plan Administrator believes that the Plan is designed, and as of March 2, 2022 and December 31, 2021, was being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 2, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Related Party and Party-in-Interest Transactions

The Plan paid fees and expenses for recordkeeping services and investment services to various service providers. These transactions are considered party-in-interest transactions as defined by ERISA; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. Certain costs of administering the Plan are borne directly by the Company.
