The plan administrator has obtained certification from Great-West Life and Annuity Insurance Company and Great-West Trust Company, LLC as of February 27, 2015 and December 31, 2014 and for the period January 1, 2015 through February 27, 2015 that the information provided to the plan administrator by Great-West Life and Annuity Insurance Company and Great-West Trust Company, LLC is complete and accurate.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Scandia Plastics, LLC 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: Scandia Plastics, LLC (the "Company") established the Plan on December 1, 1980. The Plan is a defined contribution plan covering substantially all full-time employees of the Company who are at least age 18 and have completed one year of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Transfers to Other Plan: Effective February 27, 2015, the Plan was merged into the Comar, LLC 401(k) Plan, pursuant to Comar, LLC's acquisition of the Company in October 2014. As a result of the acquisition, no new participants entered the Plan during 2015, no contributions were made to the Plan by participants or the employer during 2015 and participants became participants of the Comar, LLC 401(k) Plan effective January 1, 2015.

Contributions: Each year participants may contribute up to 75% of compensation, as defined by the Plan up to \$17,500 for 2014 of pre-tax earnings (\$22,500 for participants 50 years of age or older). Participants over 50 may make additional catch-up contributions to the Plan. Annual discretionary matching contributions may be made by the Company. The Plan is a participant-directed plan, whereby participants were allowed to contribute into a variety of mutual funds.

The Company may make matching contributions equal to a discretionary percentage that is to be determined by the Company, and may also make other discretionary contributions in an amount determined by the Company. The Company made no contributions to the Plan for the period ended February 27, 2015.

The employer match and discretionary contributions were allocated to participants who had completed at least 1,000 hours of service during the plan year and who were employed with the Company on the last day of the plan year.

Participant Accounts: Each participant's account was credited with the participant's contribution, the Company's matching contributions and with allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. All amounts in participant accounts are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participant contributions and earnings thereon are vested immediately. Vesting in the Company's discretionary matching contributions plus actual earnings thereon is based on years of service according to the following schedule:

A participant can also become 100% vested if the Company terminates the Plan.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect either a lump-sum distribution equal to the value of the participant's vested interest in his or her account or distributions in various annuity forms. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures: The non-vested portion of terminated participants' accounts plus earnings thereon are forfeited and are used by the Plan to pay administrative expenses or to reduce future Company contributions.

Investments: Upon enrollment in the Plan, participants had the option to invest their contributions, rollover contributions, and the Company's matching contributions into any of the investment funds offered by the Plan through Great-West Life and Annuity Insurance Company and Great-West Trust Company, LLC.

Hardship Withdrawals: Participants may withdraw their vested contribution in the event of hardship as defined in the Plan agreement.

Plan Termination: Although it has expressed no intent to do so, the Company has the right to terminate the Plan at any time and discontinue contributions to the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Presentation: The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Adoption of New Accounting Standards: In July 2015, the Financial Accounting Standards Board (FASB) amended existing guidance related to the measurement, reporting and disclosure of fully benefit-responsive investment contracts (FBRICs), and in May and July 2015 the FASB amended various other disclosure requirements applicable to investments held by defined contribution pension plans. The new guidance requires FBRICs to be measured, presented, and disclosed only at contract value. The new guidance also eliminates or simplifies various disclosure requirements applicable to plan investments. Adoption of the new guidance resulted in removal of FBRICs from the fair value hierarchy, the reporting of investments within the fair value hierarchy by general type rather than by classes of investments, and other changes in investment disclosure requirements. The Plan elected to early adopt these standards, each of which requires retrospective application to all periods presented. The adoption of these standards had no effect on the Plan's net assets available for benefits or changes therein. However, Investments, at fair value was reduced by \$940,405 from the amount previously reported as of December 31, 2014 and this amount is now reported as Investments, at contract value.

Investment Valuation and Income Recognition: The Plan's investments, other than the fully benefit responsive investment contract held as of December 31, 2014, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or more advantageous market for the asset or liability. For the contract held at December 31, 2014, contract value is the relevant measure for the Plan's fully benefit -responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Expenses: Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are borne by the Company, to the extent they are not paid by the Plan.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual funds:* The fair values of mutual fund investments held at December 31, 2014 are determined by obtaining quoted prices on nationally recognized securities exchanges. (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – UNAUDITED INFORMATION - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Substantially all information pertaining to the Plan's investments and notes receivable from participants included in the financial statements, including the associated investment income (loss) and interest earned on notes receivable from participants, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Great-West Life and Annuity Insurance Company and Great-West Trust Company, LLC. This information has not been audited by independent accountants.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan held an investment contract issued by Great-West Life and Annuity Insurance Company which qualified as party-in-interest transactions. Administrative fees paid by the Plan to Great-West Life and Annuity Insurance Company and Great-West Trust Company, LLC totaled \$74 for the period ended February 27, 2015 and were considered party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Notes receivable from participants also reflected party-in-interest transactions.

**NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

Traditional Guaranteed Investment Contract: The Plan held a fully benefit-responsive investment contract with Great-West Life and Annuity Insurance Company ("Great-West"; Issuer) as of December 31, 2014. Great-West maintained the contributions in its general account. The issuer guaranteed the Plan a return of principal and interest under the terms of the contract. The interest crediting rate was updated quarterly based on contract provisions and it may not have been less than 0%. The Plan's general account was credited with earnings on the underlying investments and was charged for participant withdrawals and administrative expenses. Participant may have ordinarily directed the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specified certain conditions under which distributions from the contract would have been payable at amounts below contract value. Such circumstances included Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limited the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract included the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to have occurred, the Issuer could have terminated the contract at an amount less than contract value. The Plan merger disclosed in Note 1 had no impact on the Plan's ability to transact at contract value.

**NOTE 7 - TAX STATUS OF PLAN**

The Internal Revenue Service has determined and informed the Plan by a letter dated March 31, 2014 that the Plan and related trust are designed and being operated in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 27, 2015 and December 31, 2014, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through March 1, 2023, which is the date the financial statements were available to be issued.
