Opinion

We have audited the accompanying financial statements of the Wittichen Retirement Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of January 31, 2023 and October 31, 2022, and the related statements of changes in net assets available for benefits for the period from November 1, 2022 to January 31, 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Wittichen Retirement Trust as of January 31, 2023 and October 31, 2022, and the changes in its net assets available for benefits for the period from November 1, 2022 to January 31, 2023, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Wittichen Retirement Trust (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Wittichen Supply Company, LLC (“the Company”) who have completed one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger

The Company’s Board of Directors adopted a resolution effective January 1, 2023 to merge the Plan into and with the Heritage Distribution Holdings 401(k) Plan (“the Heritage Plan”). In accordance with the merger resolution, no new participants were permitted to begin participation in the Plan after December 31, 2022, no employee or employer contributions relating to periods after December 31, 2022 were permitted to be made to the Plan, and all active participants employed with the Company on December 31, 2022 became 100 percent vested in the Company’s contribution portion regardless of years of credited service. On January 30, 2023, the Plan, including all assets and liabilities, were merged into and with the Heritage Plan with participants of the Plan becoming participants in the Heritage Plan.

Contributions

The Company makes a profit sharing contribution at the discretion of the Board of Directors. The amount contributed for the period from November 1, 2022 to December 31, 2022, was 15 percent of the eligible compensation of participants. Contributions are subject to certain limitations and are allocated to various investment vehicles at the discretion of the Company. Participants may also contribute amounts representing qualified rollover distributions from other qualified plans.

Participant Accounts

Each participant’s account is credited with allocations of the Company’s profit sharing contribution, Plan earnings, and forfeitures of terminated participants’ nonvested accounts. Allocations of contributions and forfeitures are based upon the ratio of each participant’s compensation to the total compensation of all participants entitled to share in such contributions and forfeitures. Allocations of earnings are based upon the ratio of each participant’s share of the plan to the total value of the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Prior to the Plan merger, vesting in the Company's contributions was based on years of service. A participant is 100% vested after six years of credited service. Effective with the Plan merger, all active participants became 100 percent vested in the Company's contribution portion regardless of years of credited service.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or annual installments over a fixed reasonable period of time.

Forfeited Accounts

Forfeitures shall be used to reduce Company contributions, reallocated to the participant accounts as a Company contribution, or used to pay reasonable Plan expenses. At January 31, 2023 and October 31, 2022, there were no non-vested accounts remaining. During the period ended January 31, 2023, \$12,779 from forfeited non-vested accounts was reallocated to the participant accounts as a Company contribution.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition

Investments in money market accounts, mutual funds, common stocks, and U. S. Treasuries are stated at fair value, based on quoted market prices. Investments in government obligations, mortgage pools, and corporate bonds are stated at the fair value of the underlying assets. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Evaluation of Subsequent Events

Management has evaluated subsequent events through the date of the Independent Auditors' Report, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following table sets forth by level, within the fair value hierarchy, the fair value of the Plan's assets as of October 31, 2022. Due to the Plan Merger, there were no investments outstanding as of January 31, 2023.

NOTE 5 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.


