Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of McCullough-Hyde Memorial Hospital, Inc. Management has obtained certifications from qualified institutions as of August 2, 2022 and December 31, 2021 and for the period from January 1, 2022 to August 2, 2022, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of McCullough-Hyde Memorial Hospital, Inc., the Plan's sponsor, voted on December 6, 2021 to terminate the Plan and management determined liquidation was imminent. As a result, the Plan has used the liquidation basis of accounting in presenting the 2022 and 2021 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS
AUGUST 2, 2022 AND DECEMBER 31, 2021

1. Plan description

The following description of the McCullough-Hyde Memorial Hospital, Inc. Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Plan Termination

Effective December 31, 2020, the Plan was frozen. At that time, all employee and employer contributions ceased and all participants became 100% vested in their account balances. Participants with account balances could continue to take loans and distributions from the Plan. On December 6, 2021, the Board of Directors of McCullough-Hyde Memorial Hospital, Inc., the Plan's sponsor, voted to terminate the Plan effective March 31, 2022. Liquidation of assets through distributions to participants or transfers to the TriHealth 401(k) Retirement Savings Plan took place starting April 1, 2022 and was completed by August 2, 2022.

General

The Plan was a defined contribution 403(b) plan covering all employees of McCullough-Hyde Memorial Hospital, Inc. (the Plan Sponsor). Prior to the Plan freeze, employees were eligible to participate in the Plan immediately upon hire. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Prior to the Plan freeze, each year participants could contribute a percentage or dollar amount of their annual compensation to the Plan, as defined in the plan document. Unless specifically instructed by the employee, new employees were automatically enrolled in the Plan, deferring 3% of their pre-tax compensation. This percentage increased annually by 1%, up to a maximum deferral of 10%. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also roll over amounts representing distributions from other qualified defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan, including mutual funds, variable annuity funds, and fully benefit-responsive investment contracts.

The Plan Sponsor matched 100% of a participant's elective deferrals that did not exceed 1% of their compensation, subject to IRS limitations. The Plan Sponsor also made a non-elective contribution of 1.5% of compensation for each participant eligible to receive the contribution. In order to receive the non-elective contribution, participants had to be employed on the last day of the plan year and have completed at least 1,000 hours of service during the plan year. The Plan Sponsor matching and non-elective contributions were allocated amongst investment options based on the participant's selected allocation percentages.

Participant accounts

Each participant's account was credited with the participant's contributions and allocations of (a) the Plan Sponsor's matching and non-elective contributions prior to the plan freeze and continues to be credited with (b) plan earnings, and charged with (a) an allocation of administrative fees and expenses paid out of the Plan and (b) decreases in investment value. Allocations of non-elective contributions were based on participant's compensation, allocations of matching contributions were based on participant's contributions, and allocations of plan earnings are based on account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

With the plan freeze, participants became fully vested in all contribution types and earnings thereon.

Notes receivable from participants

Up until March 31, 2022, participants could borrow a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balance, whichever is less. The loans were secured by the balance in the participant's account and bore interest at market rates as determined on the date the loan is issued. Principal and interest were paid ratably through payroll deductions.

Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the plan document.

Expenses of the Plan

The Plan paid certain administrative expenses. The Plan Sponsor provided other administrative services at no cost to the Plan, which are excluded from these financial statements.

Forfeited accounts

Participant forfeitures of Plan Sponsor matching and non-elective contributions were used to pay plan expenses or to offset the Plan Sponsor matching and non-elective contributions. At August 2, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$2,853, respectively. During 2022, forfeited non-vested accounts of \$2,853 were used to pay plan expenses.

Payment of benefits

On termination of service due to death, disability or retirement, or any other reason, a participant could elect to receive either a lump-sum or various annuity options equal to the value of the participant's vested balance in his or her account. Participants could also elect to receive an in-service withdrawal upon attaining age 59½ or apply for hardship withdrawals, subject to approval by the plan administrator.

2. Summary of accounting policies

Basis of accounting

As discussed in Note 1, the plan sponsor terminated the Plan effective March 31, 2022. As a result, the Plan changed its basis of accounting for all periods subsequent to December 31, 2020 from accounting principles generally accepted in the United States of America to the liquidation basis.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Benefits

Benefit payments were recorded when paid.

3. Transactions with related parties

The Plan permitted the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Additional administrative expenses of the Plan could be paid for by the Company. Expenses relating to specific participant transactions (i.e., distribution request, loan setup, etc.) were charged directly against the appropriate participant's account.

Certain plan investments were managed by The Variable Annuity Life Insurance Company (VALIC), a trustee for the Plan. Therefore, these transactions qualified as party-in-interest transactions.

4. Tax status

The Plan was designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan were prepared to conform to sample language provided by the IRS in Revenue Procedures 2007-71. The IRS does not have a determination letter program for 403(b) plans and, therefore, the Plan did not apply for a determination letter. The Plan was required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

5. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable annuity funds: Valued using the practical expedient of NAV. These funds invest primarily in mutual funds measured based on outside pricing data. Transfers out of a variable annuity fund are allowed at any time, with no advance notice.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

(a) Certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. 6. Fully benefit-responsive investment contracts

The Plan invested in unallocated guaranteed fixed annuity contracts with VALIC. These contracts met the fully benefit-responsive investment contract criteria and therefore were reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

For these contracts, VALIC was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer, but could not be less than 3%. The crediting rate was reviewed on an annual basis for resetting. Although the Plan was terminated effective March 31, 2022, the Plan was able to transact at contract value with the contract issuer and participants.

7. Reportable transactions

No reportable transactions were noted in 2022 or 2021.

8. Information certified by the Plan’s trustees

The plan administrator has elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Great-West Life & Annuity Insurance Company (GWLAIC) and VALIC, the trustees of the Plan, have certified that the following information included in the accompanying financial statements is complete and accurate:

- Investments, fully benefit-responsive investment contracts, and notes receivable from participants, as shown in the Statement of Net Assets Available for Benefits in Liquidation as of August 2, 2022 and December 31, 2021
- Interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits in Liquidation for the period from January 1, 2022 to August 2, 2022

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information included in the financial statements.

9. Fidelity bonding requirements

The Plan was covered by a \$500,000 bond during 2022 and 2021.

11. Subsequent events

The plan administrator has evaluated subsequent events through June 9, 2023, the date the financial statements were available to be issued. The plan administrator is not aware of any subsequent events that would require recognition or disclosure in the Plan’s financial statement.
