### Note 1 - Plan Description

The following description of Graymont Medical Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan adoption agreement (the "Agreement") for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering employees of Graymont Medical Equipment LLC and Affiliates (the "Company") who have completed three months of service and are age 18 or older. Leased employees, union employees, and nonresident alien employees are excluded from plan eligibility. Employees who regularly complete less than 1,000 hours of service over any 12-month period are also excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On August 2, 2022, the Plan was amended to merge into the Vensure Employer Services, Inc. 401(k) Profit Sharing Plan. Prior to the date of the merger, plan contributions were frozen on June 7, 2022. As a result of the merger, the assets of the Plan are shown as a transfer out of \$3,146,788 on the accompanying statement of changes in net assets available for benefits for the period ended August 2, 2022. The Plan ceased operations on August 2, 2022.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation, as defined in the Agreement, subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). In addition, the Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis (Roth contributions). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. The sum of tax-deferred and Roth contributions may not exceed certain IRC annual aggregate contribution limits. Participant contributions ceased on June 7, 2022.

The Plan provides for employer safe harbor matching contributions of 100 percent of a participant's contributions that are not in excess of 3 percent of the participant's plan compensation, plus 50 percent of the participant's contribution that exceeded 3 percent of the participant's plan compensation, but not to exceed 5 percent of the participant's plan compensation. Employer safe harbor matching contributions ceased on June 7, 2022.

The Company may also make annual nonelective discretionary contributions. Participants of the Plan will be eligible to receive an allocation of the Company's discretionary contribution if they have completed 1,000 hours of service during the year and are employed on the last day of the plan year. There were no discretionary nonelective contributions made to the Plan in 2022.

#### **Participant Notes Receivable**

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Agreement and in the Internal Revenue Code. Notes receivable bear interest at a market rate. Participant notes receivable were included in assets transferred out to the Vensure Employer Services, Inc. 401(k) Profit Sharing Plan on August 2, 2022.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's matching contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Vesting***

Participants are immediately 100 percent vested in employee salary, rollover contributions, and safe harbor matching contributions and any income or loss thereon. If a participant is not fully vested in his or her account on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Party-in-interest Transactions***

Certain plan assets were in investment funds managed by Capital Bank and Trust Company or its affiliates. Capital Bank and Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Agreement and ERISA. See disclosures above for information related to the Plan's merger into the Vensure Employer Services, Inc. 401(k) Profit Sharing Plan effective August 2, 2022.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value based on quoted market values. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including June 7, 2023, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Capital Bank and Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

The Level 1 fair value balance of mutual funds was \$0 and \$3,496,373 at August 2, 2022 and December 31, 2021, respectively.

**Note 5 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The preapproved plan has received a favorable notification letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter.

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including June 7, 2023, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Capital Bank and Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 4 - Fair Value Measurements (Continued)**

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

The Level 1 fair value balance of mutual funds was \$0 and \$3,496,373 at August 2, 2022 and December 31, 2021, respectively.

**Note 5 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The preapproved plan has received a favorable notification letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter.
