1. DESCRIPTION OF THE PLAN

The following description of the Alliance Technical Services, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan was a defined contribution plan, which was established by Alliance Technical Services, Inc. (the Company) effective January 1, 2001. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended May 1, 2022 to merge the Plan into the Valiant Integrated Services 401(k) Plan (Note 9).

Eligibility

The Plan allowed employees of the Company who were covered by the Plan, with the exception of non-resident aliens, to make participant contributions. Union employees were not eligible to make participant contributions in the Plan or receive Company contributions except for required contributions stipulated by a collective bargaining agreement. Employees must have been at least 19 years of age and have completed 6 months of service to participate in the Plan. Employees were eligible to enter the Plan on the first day of the Plan year or the first day of the 7th month of the Plan year once the other eligibility requirements are met. Union employees were eligible to receive prevailing wage contributions immediately upon hire, in the amount determined by their prevailing wage contract and were not subject to the age or service requirements.

Participant Contributions

Participants could contribute up to 75% of their pre-tax annual compensation, as defined by the Plan. Participant pre-tax contributions were subject to Internal Revenue Code (the Code) limits, which totaled \$20,500 for the calendar year ended December 31, 2022. Participants who had attained age 50 before the end of the Plan year could make additional catch-up contributions, subject to limitations imposed by the Code. Participants were permitted to make rollover contributions to the Plan.

Company Contributions

The Company contributed to the Plan on behalf of eligible employees. The Company made contributions for each employee's service contract act service or prevailing wage service based on the hourly contribution rate for the employee's employment classification, net of the amount utilized for health care benefit payments. Prevailing wage contributions totaled \$131,632 for the period from January 1, 2022 through August 1, 2022.

The Plan allowed the Company to make discretionary profit sharing contributions to employees. A discretionary profit sharing contribution could be made to eligible employees at a ratio of the participant's eligible compensation to the total compensation of all eligible participants. No profit sharing contributions were made to the Plan during the period from January 1, 2022 through August 1, 2022.

Company Contributions – cont’d.

The Plan allowed the Company to make discretionary matching contributions equal to a percentage of a participant’s elective deferrals determined by the Company. In order to receive a Company contribution, an employee must have worked 1,000 hours during the Plan year and be employed on the last day of the Plan year. The discretionary matching contributions were calculated on an annual basis and invested in the same manner as those directed by the participant. No discretionary matching contributions were made to the Plan during the period from January 1, 2022 through August 1, 2022.

Participant Accounts

Each participant’s account was participant-directed and was credited with the participant’s contributions and Company contributions in accordance with the investment options selected by each participant. Plan earnings, losses, and administrative expenses were allocated to each participant’s account based upon the balance in each account. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Vesting

Participants were immediately vested in participant, rollover and prevailing wage contributions plus earnings thereon. Participants vested in Company matching and profit sharing contributions plus actual earnings and losses thereon based on years of service according to the following schedule:

Forfeitures

Forfeitures of Company matching and profit sharing contributions could be applied to reduce future Company matching and profit sharing contributions. During the period from January 1, 2022 through August 1, 2022, there were no forfeitures used to reduce Company contributions. There were no forfeitures available to the Plan as of August 1, 2022 and December 31, 2021.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, or attainment of age 59 ½, a participant, or the participant’s beneficiary, in the event of death, was entitled to a distribution of the participant’s vested account balance. Distributions from the Plan were payable only in the form of a lump sum payment. Upon termination, if a participant’s account balance was less than \$5,000, the Plan administrator could elect to automatically distribute the participant’s account balance.

Payment of Benefits – cont'd.

Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts could be withdrawn for a hardship purpose. Hardship withdrawals must have been taken for a minimum of \$1,000, could only be taken by a current employee and could only be taken from a fully vested account.

Certain income tax penalties applied to withdrawals or distributions prior to age 59 ½. Distributions were subject to the applicable provisions of the Plan agreement. As of August 1, 2022 and December 31, 2021, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan that had not received such distributions.

Plan Expenses

Expenses incurred in the administration of the Plan were required to be paid by the Custodian with assets of the Plan unless the Company, at its discretion, elected to pay them. During the period from January 1, 2022 through August 1, 2022, the Company paid a portion of Plan expenses and the Plan paid direct expenses of \$1,120. Distribution fees were paid by the Plan and its participants. Investment related expenses are included in net depreciation of fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provided for investments in assets that were exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it was reasonably possible that changes in the value of investment securities could occur in the near term that materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded when earned. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan’s gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification 820, *Fair Value Measurement* (ASC 820), defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets’ or liabilities’ fair value measurement levels within the fair value hierarchy are based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Interests in pooled separate accounts: Valued using the net asset value (NAV) of share held by the Plan at year end as a practical expedient.

The methods described above may produce a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could have resulted in a different fair value measurement at the reporting date. There were no changes in the methodologies used as of August 1, 2022 and December 31, 2021.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through June 12, 2023, the date the financial statements were available to be issued, and determined that there were no material subsequent events that required disclosure.

3. INVESTMENTS

All investment data contained in the accompanying financial statements, including assets held as of August 1, 2022 and December 31, 2021 and interest and dividend income and net depreciation in fair value of investments for the period from January 1, 2022 through August 1, 2022, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Custodian of the Plan, John Hancock Life Insurance Company (U.S.A.).

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by John Hancock Financial, a related party of the Plan’s Custodian. The Company provided the Plan with certain accounting and administrative services to the Plan for which no fees were charged. All such transactions qualified as party-in-interest transactions which are exempt from the prohibited transaction rules.

5. PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon Plan termination, all participants become 100% vested in their accounts. While not a Plan termination, as further described in Note 9, the Plan did merge into the Valiant Integrated Services 401(k) Plan effective May 1, 2022.

6. INCOME TAX STATUS

The Plan operated under a volume submitter document, which received a favorable opinion letter on March 31, 2014. The Plan was amended and restated since receiving the favorable opinion letter. However, the Plan administrator believes, through the Plan merger (Note 9), that the Plan operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes was included in the Plan’s financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan was tax exempt and had no unrelated business income, the provisions of ASC 740 did not have an impact on the Plan’s financial statements. The Plan recognized interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of August 1, 2022 and December 31, 2021.

The Plan was subject to routine audits by the Internal Revenue Service and Department of Labor; however, there are currently no audits for any periods in progress.

7. EXCESS CONTRIBUTIONS PAYABLE

During the year ended December 31, 2021, the Plan failed to comply with certain non-discrimination rules. As a result, the Plan was required to refund certain excess contributions to affected participants. As of December 31, 2021, corrective distributions totaling \$17,937 were required to be made and are included in excess contributions payable in the accompanying statement of net assets available for benefits. The corrective contributions were made during the period from January 1, 2022 through August 1, 2022.

9. PLAN MERGER

Effective June 30, 2021, the Company was acquired by and became a wholly-owned subsidiary of Valiant Integrated Services, LLC (Valiant). As part of the acquisition, Valiant also acquired and maintained the Plan.

On May 1, 2022, the Plan was merged with the Valiant Integrated Services 401(k) Plan (the Valiant Plan) and all participants transferred from the Plan to the Valiant Integrated Services 401(k) Plan. Effective August 1, 2022, the Plan's investments totaling \$1,510,718 held by John Hancock Life Insurance Company (U.S.A.) were transferred to the Valiant Plan, held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the Custodian and Trustee of the Valiant Plan. As a result of this change, there was a blackout period from July 27, 2022 through August 14, 2022 for distribution and allocation changes. During this time, participants were unable to access their accounts or obtain a distribution from the Plan and the Valiant Plan. Furthermore, participants were unable to direct or diversify their investments in the Valiant Plan. Participants were, however, able to make contributions to the Valiant Plan during the blackout period.
