We were engaged to perform audits of the financial statements of Monmouth College 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period ended November 31, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of November 30, 2022 and December 31, 2021 and for the period ended November 30, 2022 and year ended December 31, 2021, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan may not have maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 10 to the financial statements, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

NOTES TO FINANCIAL STATEMENTS

For the Period Ended November 30, 2022 and
Year Ended December 31, 2021

1. DESCRIPTION OF PLAN

The following description of Monmouth College 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Monmouth College (the College), except student employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger

Effective December 1, 2022, the Plan was merged into the Illinois Independent Colleges and Universities Multiple Employer Plan (IICU MEP). The net assets of the Plan were transferred to the IICU MEP at the close of business on November 30, 2022. Management of the Plan believes that the Plan merger was a tax-exempt transaction under the applicable provisions of the Internal Revenue Code (IRC) and, therefore, is not subject to federal income taxes.

Contributions

Participants who had completed one year of service were required to make salary reduction contributions at 5% of their eligible compensation through regular payroll deductions to the Plan with certain limitations. Prior to January 1, 2021, the College was required to match 7% of the participant's eligible compensation. Effective January 1, 2021, the matching contribution was suspended. Upon reinstatement on July 1, 2021, the matching contribution became discretionary and the College matched 100% of employee contributions up to 3.5% of eligible compensation. Effective January 1, 2022, the matching contribution was reinstated at 7%. Adjunct faculty, visiting faculty, and special projects staff hired after December 31, 2019 were excluded from mandatory contributions.

Each year, participants were able to make voluntary salary reduction contributions on a pre-tax basis up to 100% of the remaining portion of eligible compensation through regular payroll deductions to the Plan with certain limitations. Participants could also elect to make post-tax compensation deferrals (Roth contributions) to the Plan.

1. DESCRIPTION OF PLAN (Continued)

Contributions (Continued)

Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants were able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan allowed non-elective employer contributions. This contribution type was used for participants who elected voluntary early retirement under the Monmouth College Voluntary Retirement Incentive Program. Non-elective contributions totaled \$283,244 and \$415,902 for the year ended December 31, 2021 and period ended November 30, 2022, respectively.

All contributions are subject to certain limitations as mandated by the IRC.

Investment Options

Participants could direct all their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions were permitted pursuant to the Plan's provisions.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the College's contribution(s) and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Vesting

Participants were fully vested in their employee and employer contributions at all times.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their account balance, less defaulted loans and plan loans (if any). The loans were secured by the balances in the participants' accounts and bore interest at rates in accordance with the loan policy. The term of the loan could not exceed five years, unless the loan proceeds were used to acquire the principal residence of the participant. Principal and interest was paid ratably by the participant to TIAA.

1. DESCRIPTION OF PLAN (Continued)

Plan Loans

Plan loans were issued as separate contracts by TIAA as contemplated under IRC section 72(p)(5) and did not represent plan assets. Participants could borrow a minimum of \$1,000 up to a maximum of \$50,000, 50% of a participant's account balance, or 45% of a participant's TIAA Traditional Annuity account balance, whichever was less, subject to annuity contract and plan provisions.

Loans were secured by collateral equal to 110% of the outstanding loan balance. The loan collateral was maintained in a TIAA Traditional Annuity. Loan terms ranged from one to five years in one-year increments, or up to ten years for the purchase of a participant's primary residence. Principal and interest were paid ratably by the participant to TIAA Traditional Annuity and each payment reduced the amount collateralized by the TIAA Traditional Annuity. There were no pre-payment penalties. Plan loan balances outstanding from participants to TIAA were \$3,144 and \$10,304 as of November 30, 2022 and December 31, 2021, respectively. Collateral and recordkeeping for plan loans was transferred to the IICU MEP on November 30, 2022.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant could receive a lump sum amount or purchase an annuity contract equal to the value of the participant's vested interest in his or her account, or annual installments. Under certain conditions participants could receive a hardship distribution.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the College and were excluded from these financial statements. Loan administration fees were charged directly to the participant's account and were included in administrative expenses. Certain investment-related expenses were included in net appreciation (depreciation) of fair value of investments.

During 2020, the College began earning expense reduction credits from TIAA that could be used to pay Plan expenses or reallocated to participant accounts. The following table sets forth a summary of changes in the expense reduction credits for the period ended November 30, 2022 and year ended December 31, 2021. Credits remaining at November 30, 2022 were transferred to IICU MEP.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Sub-Committee determines the Plan's valuation policies utilizing information provided by the custodians and insurance company. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest less amounts defaulted (if any). Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Subsequent events are events or transactions that occur after year end but before financial statements are issued or are available to be issued. These events and transactions either provide additional evidence about conditions that existed at year end, including the estimates inherent in the process of preparing financial statements (that is, recognized subsequent events), or provide evidence about conditions that did not exist at year end but arose after that date (that is, nonrecognized subsequent events).

The Plan has evaluated subsequent events through June 12, 2023, which was the date that these financial statements were available for issuance, and determined that there were no significant nonrecognized subsequent events through that date.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

3. FAIR VALUE MEASUREMENTS (Continued)

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2022 and December 31, 2021.

Pooled separate account: Investment in units of pooled separate account held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the net asset value (NAV) of units held by the Plan on a daily basis. The unit value is updated and posted on NASDAQ's website for each day that NASDAQ is open. The NAV is determined by the insurance company based on the market value of the underlying investments held in the pooled fund.

Registered investment company accounts: The funds invest in variable annuities and are valued utilizing each account's daily NAV, which is considered by plan management to be the best approximation of fair value. The funds are registered with the U.S. Securities and Exchange Commission and the unit values are updated and posted on NASDAQ's website for each day that NASDAQ is open.

3. FAIR VALUE MEASUREMENTS (Continued)

Mutual funds: The funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Insurance contracts: Investments in TIAA Traditional Annuity that are not fully benefit-responsive are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to these investments that could impact the value realized upon exiting the contract. In assuming the reasonableness of TIAA's methodology, the College has various procedures in place to monitor TIAA including review of performance on a plan basis and review of the reports of controls on an ongoing basis.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. There were no plan assets as of November 30, 2022.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

4. TIAA TRADITIONAL ANNUITY CONTRACT

The TIAA Traditional Annuity is a guaranteed fixed annuity contract that was available as an investment option to plan participants. Each contract was fully unconditionally guaranteed by TIAA. The TIAA Traditional Annuity was offered through a variety of contract types, including Retirement Annuities (RA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). Participants with RA contracts had certain restrictions over the availability of lump sum withdrawals from the contracts as well as over the number of installments in which participant-initiated transfers and participant-initiated withdrawals were made.

Based on these provisions, the RA contracts were considered to be non-fully benefit-responsive. As there were no comparable restrictions over the SRA and GSRA contracts, those contracts were considered fully benefit-responsive. Participants in the Plan hold investments in both non-fully benefit-responsive and fully benefit-responsive contracts through the TIAA Traditional Annuity. Fully benefit-responsive investment contracts were reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As of November 30, 2022, the contracts were transferred into the IICU MEP. As of December 31, 2021, the contract value of the fully benefit-responsive investment contract was \$3,990,610. Non-fully benefit-responsive contracts are reported at fair value, as described in Note 3.

Participants who chose to allocate a portion of their retirement savings to the TIAA Traditional Annuity made contributions that purchase a specific amount of lifetime income based on the contractual rate of interest guaranteed by TIAA's Traditional Annuity claims-paying ability. When a participant's accumulation in the TIAA Traditional Annuity was converted to a lifetime payout annuity, the present value of the stream of payments was equal to the accumulated balance, and the entire amount was recorded as a distribution in the statement of changes in net assets available for benefits. Interest credited to the TIAA Traditional Annuity included a guaranteed rate, plus additional amounts that were not guaranteed but were established on a year-by-year basis by the TIAA Board of Trustees. Those additional amounts, when declared, remained in effect for the "declaration year" which began each March 1. The minimum guaranteed interest rate for TIAA Traditional Annuity for RA, SRA, and GSRA was generally 3.00%.

For the period ended November 30, 2022, the crediting interest rates ranged from 4.00% to 6.25% for RA contracts. The crediting interest rate for SRA and GSRA contracts for the period ended November 30, 2022 ranged from 3.25% to 5.50%.

All RA contracts are participant-initiated transfers or withdrawals which may only be made in ten annual installments over a period of approximately nine years. SRA and GSRA contracts provide for full participant-directed liquidity.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the contract issuers and with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

5. CERTIFICATION OF FINANCIAL INFORMATION

The following financial data included in the accompanying financial statements as of November 30, 2022 and December 31, 2021 and for the period ended November 30, 2022 and year ended December 31, 2021 has been certified as complete and accurate by TIAA and CREF, qualified institutions, and has not been audited by the independent auditors for the Plan: investments at fair value, investment at contract value, notes receivable from participants, interest and dividends, interest on notes receivable from participants and net appreciation (depreciation) in fair value of investments.

6. PLAN TERMINATION

While the College has not expressed any intent to terminate the Plan, the Plan was merged into the IICU MEP on December 1, 2022. In the event such termination occurs, the distribution of the Plan's assets to participants or their beneficiaries will be made by the trusts of the Plan in accordance with the plan document and subject to the provisions of ERISA.

7. TAX STATUS

The volume submitter plan sponsor has obtained an opinion letter dated August 7, 2017, in which the Internal Revenue Service (IRS) stated that the volume submitter plan document was in compliance with applicable requirements of the IRC. The Plan has not received a determination letter specific to the Plan itself and has been amended since the date of the opinion letter; however, the plan administrator and the Plan's tax counsel believe that the Plan was designed, and is being operated, in compliance with the applicable requirements of the IRC.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by TIAA and CREF, the custodians, therefore, these transactions qualified as party-in-interest. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative expenses were paid by the Plan or the College. The Plan issues loans to participants, which are secured by the vested balance in the participant's accounts. These transactions qualify as party-in-interest. Employees of the College provide administrative services to the Plan for which no fees are charged.

9. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. OTHER MATTERS

The Plan may not have maintained sufficient accounting records and supporting documents for certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009 to determine the proper accounting of plan assets.

The plan administrator has determined that these accounts meet the conditions to be excluded from plan investments. The plan administrator is unable to obtain sufficient documentation to establish the balances in these transferred accounts as of as of November 30, 2022 and December 31, 2021.

10. OTHER MATTERS (Continued)

As permitted by the Department of Labor's Field Assistance Bulletin (FAB) No. 2009-02, the plan administrator has elected to exclude from plan assets certain annuity and custodial accounts issued to current and former employees. The FAB specifically excludes from plan assets annuity contracts and custodial accounts for purposes of ERISA's annual reporting requirements provided that:

1. The contract or account was issued to a current or former employee before January 1, 2009;
2. The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and in fact ceased making contributions to the contract or account before January 1, 2009;
3. All of the rights and benefits under the contract or account are legally enforceable against the insurer or custodian by the individual owner of the contract or account without any involvement by the employer; and
4. The individual owner of the contract is fully vested in the contract or account.
