Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Capstone Corporate Finance LLC 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2022 (in liquidation) and the related statement of changes in net assets available for benefits for the period January 1, 2022 to September 30, 2022 (in liquidation), and the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2022 and December 31, 2021, and for the period January 1, 2022 to September 30, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Capstone Corporate Finance LLC 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of Capstone Corporate Finance LLC 401(k) Profit Sharing Plan and Trust approved a plan of liquidation on May 23, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis of accounting in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

1. Description of the Plan

General

The following description of the Capstone Corporate Finance LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan was established effective January 1, 2005. The Plan sponsor is Capstone Corporate Finance (the “Company”). The Plan covers all employees except union employees covered by a collective bargaining agreement, certain nonresident aliens, and leased employees. Eligible employees may participate in the Plan upon attaining age 21. Employee participation in the Plan is voluntary.

Effective July 21, 2021 the Plan was amended and restated to bring the Plan into compliance with the requirements of the 2017 Cumulative List (Notice 2017-37).

On May 23, 2022, the plan sponsor adopted a resolution to terminate the Plan on the day prior to the consummation of the acquisition between the Company and Huntington Bancshares Incorporated. The acquisition was finalized on June 16, 2022 and the Plan was terminated effective June 15, 2022. All participants were fully vested in their account balances and the account balances were liquidated and distributed to participants as soon as administratively practicable after that time. As result of the imminent liquidation the Plan’s method of accounting switched to liquidation basis of accounting with Plan assets being fully liquidated by September 30, 2022. This had no impact on the values of the assets reported in the financial statements. No liabilities were recognized in connection with the termination.

In connection with the Plan’s termination, participants were permitted to rollover their account balances into The Huntington 401(k) Plan. Participant account balances totaling \$4,312,569 were rolled over into The Huntington 401(k) Plan in September 2022.

Contributions

Participant voluntary contributions:

Each year, participants may elect to contribute up to 100% of their annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

Company contributions:

Each year, the company may make discretionary matching contributions equal to a uniform percentage or dollar amount of a participants elective deferral. Each year, the company will determine the formula for the discretionary matching contributions. In order to share in the discretionary matching contributions the participant must be employed on the last day of the plan year. The company did not make discretionary matching contributions for the period January 1, 2022 to September 30, 2022.

Each year, the company may make a discretionary non-elective contributions to the Plan. In order to share in the discretionary non-elective contributions the participant must be employed on the last day of the plan year or if not employed on the last day of the plan year then credited with at least 501 hours of service during the plan year. The company did not make discretionary non-elective contributions for the period January 1, 2022 to September 30, 2022.

Participant Accounts

All plan investments are participant directed. Plan participants have the option of having their contributions invested in a variety of mutual funds. Each participant's account is credited with the participant's contributions and an allocation of the Company's contribution, Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary non-elective contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service and is subject to the following vesting schedule:

Forfeitures

Generally, when a participant terminates in the Plan, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are utilized to reduce company discretionary matching contributions, discretionary non-elective contributions or pay administrative expenses for the plan year. Forfeitures available to the Plan total \$0 and \$0 as of September 30, 2022 and December 31, 2021, respectively. The company did not apply forfeitures to reduce company discretionary matching contributions, discretionary non-elective contributions or pay administrative expenses for the period January 1, 2022 to September 30, 2022.

Payment of Benefits

Upon termination of service due to separation of service, disability or retirement, a participant may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account, or elect an annuity contract to be purchased and distributed by the Plan. For termination of service due to death of a participant, the beneficiary will receive a lump-sum distribution that will be equal to the participant's account. The participant's account will become fully vested upon the death of the participant.

Notes Receivable from Participants

Participants may borrow from their individual accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within five years unless the loan is granted to allow the participant to purchase his or her principal residence. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

Due to the sale of the company the decision was made to terminate the Plan effective May 23, 2022. Final distributions were made during 2022. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the Plan has changed its basis of accounting used to value plan assets from ongoing basis to liquidation basis for the period January 1, 2022 to September 30, 2022. The change from ongoing basis to liquidation basis is not materially different as the related dispositions of investments were conducted in an orderly manner at fair market values. Therefore, the fair value of the Plan's investments (ongoing basis) approximates net realizable value for the Plan's investments (in liquidation). The accompanying financial statements have been prepared on the accrual basis of accounting, including investment valuation and income recognition.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis using fair value. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. Under certain circumstances, a loan that is in default may be considered a distribution from the Plan.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Brokerage fees, transfer taxes, and other expenses incurred in connection with the investment of the Plan's assets will be added to the cost of such investments or deducted from the proceeds thereof, as the case may be. Fees related to the administration of notes receivable from participants are allocated directly to the participant responsible for the expense. The Plan participates in an expense offset agreement whereby certain administrative expenses are paid with credits received by the Plan from certain investment managers. During the period January 1, 2022 to September 30, 2022, the Plan received investment manager credits of \$4,583 which was offset against certain administrative expenses. The credits are included in net depreciation in fair value of investments in the statement of changes in net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

3. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each general type of assets measured at fair value. There have been no changes in the methodologies used at September 30, 2022 and December 31, 2021.

Mutual funds fair values are determined utilizing quoted market prices reported on the active market on which they are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Unaudited Information Certified by the Trustee

All investment information disclosed in the accompanying financial statements, including investments held and notes receivable from participants as of September 30, 2022 and December 31, 2021, and net depreciation, interest and dividends and interest income on notes receivable from participants for the period January 1, 2022 to September 30, 2022, was prepared by or derived from information certified by Empower Trust Company, LLC (the "Trustee") and furnished to the plan administrator. The plan administrator has obtained certifications from the Trustee that such information is complete and accurate within the meaning of CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

5. Tax Status

On June 30, 2020, the Internal Revenue Service stated that the prototype plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code Section 401(a) (the "Code"). The Plan has not received an opinion letter specific to the Plan itself; however, the Plan administrator believes that the Plan is designed in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan,

and has concluded that, as of September 30, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Parties-in-interest Transactions

The Company, which is a party-in-interest, provides certain administrative services to the Plan at no charge. Certain Plan investments are managed by the Trustee and its affiliates for which they receive fees. The Plan is also serviced by an outside investment advisor, which charges the Plan fees. These transactions qualify as exempt party-in-interest transactions. The Plan also held notes receivable from participants which represent party-in-interest transactions.

7. Subsequent Events

Subsequent events have been evaluated through June 1, 2023, the date the financial statements were available to be issued.
