To the Retirement Committee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the accompanying financial statements of the 401(k) Plan for G4S North America, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of August 10, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through August 10, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of August 10, 2022 and December 31, 2021 and for the period from January 1, 2022 through August 10, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the 401(k) Plan for G4S North America and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of 401(k) Plan for G4S North America (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all nonunion employees of G4S Secure Solutions (USA) Inc. (the "Company") and adopting employers, excluding highly compensated employees as defined by the Plan and the Internal Revenue Service ("IRS"). Adopting employers participating in the Plan include G4S Secure Solutions International, Inc., G4S Retail Solutions (USA), Inc., Renaissance Center Management Company and TWC/FL/01 Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The retirement committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Company has entered into an agreement whereby Principal Trust Company (the "Trustee") has been appointed the Trustee of the Plan's assets, with Principal Life Insurance Company delegated as the recordkeeper. Under the terms of the agreement, the Trustee holds and invests the funds of the Plan.

The Company was acquired effective April 6, 2021 by Atlas UK Bidco Limited ("Allied"). Subsequent to such acquisition, and at varying stages in 2021, deferred payroll contributions by participants into the Plan ceased. As of January 1, 2022, all employees eligible under the Plan became eligible to participate in a plan sponsored by one of Allied's subsidiary's, Universal Services of America, LP ("Universal"), (the "Universal Plan"). Accordingly, no employee deferrals and no employer matching or nonmatching contributions were made to the Plan for pay dates after December 31, 2021.

Effective January 1, 2022, Universal accepted sponsorship of the Plan.

During the period from July 19, 2022 through August 10, 2022, 100% of the Plan's net assets, totaling \$149,799,623, were transferred out of the Plan to the Universal Plan. Accordingly, as of August 10, 2022, the Plan no longer held any assets.

Contributions:

The contribution into the Plan of employee payroll deferrals and Company matching and nonmatching contributions ceased as of December 31, 2021. However, for the period from January 1, 2022 through August 10, 2022, participants were permitted to continue to contribute rollovers, amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions, Company matching and non-matching contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. As of August 10, 2022, 100% of the Plan assets were transferred to the Universal Plan. Any participant account activity subsequent to August 10, 2022 will be transacted under the Universal Plan.

1. Description of Plan (continued)

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Generally, a participant is 100% vested after three years of credited service. As of August 10, 2022, 100% of the Plan assets were transferred to the Universal Plan. Original hire dates and Plan provisions for vesting in the Company's portion of the participants' accounts will be maintained under the Universal Plan.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. As of August 10, 2022, 100% of the Plan assets were transferred to the Universal Plan. Loan repayments subsequent to December 31, 2021 were made from payroll deferrals administered by Universal. Loan repayments and new loan issuances subsequent to August 10, 2022, including the related participant account activity, will be transacted under the Universal Plan.

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or one or more partial distributions. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. As of August 10, 2022, 100% of the Plan assets were transferred to the Universal Plan. Payment of benefits subsequent to August 10, 2022 will be transacted under the Universal Plan.

Forfeited accounts:

At December 31, 2021, forfeited non-vested accounts totaled approximately \$124,000. Under the Plan, forfeited accounts may be used to pay administrative expenses. No forfeitures of nonvested accounts were used to reduce administrative expenses during the period from January 1, 2022 through August 10, 2022.

2. Summary of Accounting Policies

Basis of accounting:

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants is measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 10, 2022 and December 31, 2021.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through June 14, 2023 the date the financial statements were available to be issued. As of August 10, 2022, 100% of the Plan assets were transferred to the Universal Plan. Participant account activity subsequent to August 10, 2022 will be transacted under the Universal Plan.

3. Information Certified by Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at August 10, 2022 and December 31, 2021, and net depreciation in fair value of investments, dividends and interest for the period from January 1, 2022 through August 10, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820, "Fair Value Measurements", are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 10, 2022 and December 31, 2021.

Mutual funds – Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds – Money market funds are valued at the closing price reported by the fund sponsor from an actively traded exchange. The money market funds are open-end mutual funds that invest in short-term debt securities and cash equivalents. These funds are required to publish their daily net asset value and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2021.

5. Related Party Transactions

Certain Plan investments and related transactions were in investment funds managed by the Plan's Trustee and, therefore, these investments and transactions qualify as party-in-interest transactions. The notes receivable from participants are also considered to be party-in-interest transactions. These transactions are not considered prohibited by statutory exemptions under ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. As of January 1, 2022, all employees eligible under the Plan became eligible to participate in and make contributions to the Universal Plan. As of August 10, 2022, 100% of the Plan assets were transferred to the Universal Plan. Plan management believes it has structured the transfer in a manner that does not constitute a plan termination. Participant account activity subsequent to August 10, 2022 will be transacted under the Universal Plan.

7. Tax Status

The IRS has determined and informed the Company by a letter dated February 16, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, Company management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and is tax-exempt.

7. Tax Status (continued)

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of the IRS. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of net assets available for benefits.
