Lightwell, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed an audit of the financial statements of Lightwell, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – in liquidation as of April 6, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits – in liquidation for the period ended April 6, 2022 and the year ended December 31, 2021 and the related notes to the financial statements – in liquidation.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 6, 2022 and December 31, 2021 and the period ended April 6, 2022 and year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements- in Liquidation section of our report. We are required to be independent of Lightwell, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Lightwell, Inc. 401(k) Plan approved a plan of liquidation on October 31, 2021, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting to the liquidation basis used in presenting the 2021 and 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements – in Liquidation

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements – in Liquidation

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Lightwell, Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF PLAN:

The following description of the Lightwell, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all eligible full-time employees of Lightwell, Inc. (the Employer). An employee may participate in the Plan as of the first day that the employee meets the eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan termination

Effective October 31, 2021, the Plan was amended to terminate due to the acquisition of the Employer. All participants became fully vested in their account balances. All benefits were distributed and paid to participants in 2022.

Contributions

Prior to termination, participants could contribute up to 100% of their annual eligible compensation, as defined by the Plan, to the Plan, immediately upon employment with the Employer subject to certain limitations established by law. Additionally, participants were permitted to contribute Roth elective deferrals and amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

For those employees who had reached the age of 21 and completed at least one year of service (90 days effective October 1, 2021), the Plan provided for discretionary matching, safe harbor matching, and discretionary profit-sharing contributions. For the year ended December 31, 2021, the Employer made a safe harbor matching contribution of 100% of the first 3% of employee salary deferrals and 50% of the next 2% of employee salary deferrals. No discretionary matching or discretionary profit-sharing contributions were made for the period ended April 6, 2022 or the year ended December 31, 2021. In order for a participant to receive an allocation of the discretionary profit-sharing contribution, he or she must have worked at least 1,000 hours during the year and be employed on the last day of the plan year, unless certain exceptions were met as defined by the Plan.

Participant accounts

Each participant's account was credited with the participant's contributions, Employer discretionary matching and safe harbor matching contributions, an allocation of the Employer's discretionary annual contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. The Plan's investments were participant-directed.

Vesting

Effective October 31, 2021, the Plan was terminated and participants became immediately vested in all contributions, and actual earnings thereon. Prior to Plan termination, vesting in the Employer's non-safe harbor contributions was based on years of continuous service. A participant was 100% vested after three years of credited service.

Payment of benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants could also make withdrawals of vested account balances prior to termination of employment upon attainment of age 59 ½ or in the event of financial hardship, as defined in the Plan.

Forfeited accounts

Forfeited nonvested accounts could be used to reduce future Employer contributions or pay Plan expenses. At April 6, 2022 and December 31, 2021, there were no forfeited nonvested accounts and none were used during the period ended April 6, 2022 and year ended December 31, 2021.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**Basis of accounting**

As discussed in Note 1, the Plan sponsor terminated the Plan effective October 31, 2021. As a result, the Plan changed its basis of accounting for the period ended April 6, 2022 and the year ended December 31, 2021 from the going concern basis to the liquidation basis.

Investment valuation and income recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation/(depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Employer and were excluded from these financial statements. Investment related expenses were included in net appreciation/(depreciation) in fair value of investments. Fees related to certain transactions initiated by participants were charged directly to the participant's account and were included in administrative expenses. Certain expenses were paid through revenue sharing rather than direct payment.

3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodians, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of April 6, 2022 and December 31, 2021, the related investment activity reflected in the statements of changes in net assets available for benefits for the period ended April 6, 2022 and the year ended December 31, 2021.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Pooled separate accounts: Pooled separate accounts were held in investment contracts with the custodian and were invested according to the stated objectives of the various accounts. The principal was not guaranteed. The pooled separate accounts were valued at the net asset value, which was based on the market value of its underlying investments. The net asset value was

used as a practical expedient to estimate fair value. This practical expedient would not have been used if it was determined to be probable that the fund would sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) could occur daily.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table was based on the lowest level of any input that was significant to the fair value measurement:

5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

Certain Plan investments were shares of mutual funds managed by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodians as defined by the Plan. Therefore, these transactions qualify as party in interest transactions.

6. TAX STATUS:

The Employer adopted a volume submitter plan which received a favorable opinion letter from the Internal Revenue Service (IRS) dated August 8, 2014. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Employer has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
