Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Summit Service Group, Inc. 401K P/S Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 11, 2022 (terminated) and December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the period ended August 11, 2022 (terminated), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Summit Service Group, Inc. 401K P/S Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 11, 2022 and December 31, 2021, and for the period ended August 11, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Summit Service Group, Inc. 401K P/S Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 1 to the financial statements, the Summit Service Group, Inc. 401K P/S Plan was terminated on March 16, 2022, and final distributions were made on August 11, 2022. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the August 11, 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Summit Service Group, Inc. 401K P/S Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Description of plan

The following description of Summit Service Group, Inc. 401k P/S Plan, (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Plan termination

Effective March 16, 2022, Summit Service Group, Inc. (the "Company") terminated the Plan. Final distributions were determined based on all participants being 100% vested and were made on August 11, 2022. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the August 11, 2022 financial statements.

General

The Plan was a defined contribution plan which was established January 1, 2004. The Plan covered all eligible employees of Summit Service Group, Inc., age 21 and over who had completed one year of service with a minimum of 1,000 hours worked. The plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was administered by HR administrators of Summit Service Group, Inc.

Contributions

Participants could elect to contribute from 1% to 100% of their compensation (as defined by the Plan document) up to a maximum of \$20,500 for 2022. Participants age 50 or more could contribute up to an additional \$6,500.

The Company could make contributions for matching and profit sharing amounts on a discretionary basis. There were no matching contributions or profit sharing amounts for 2022.

Participant accounts

Each participant's account was credited with the participant's contribution and allocations of plan earnings. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Investment options

All of the Plan's accounts were maintained by PAi Trust Company (PAi). The investment options consisted of a variety of mutual funds and common/collective trusts. Upon enrollment in the Plan, a participant could direct their contributions into any combination of these funds. Thereafter, the participant could change their investment allocations directly with PAi.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in any discretionary contributions made by the Company plus actual earnings thereon. Each participant's account was 100% vested upon termination of the Plan.

Loans

The Plan did not allow participant loans.

Payment of benefits

On termination of service, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or defer distribution in accordance with the terms of the Plan agreement. For Participants with an account balance of \$1,000 or less, the Plan had the option to make a lump-sum cash distribution as soon as administratively practicable following termination of employment.

Forfeited accounts

Forfeited accounts were credited to the Company and could be used to reduce future contributions to the Plan. As all participant contributions and any discretionary company contributions were immediately vested, there were no forfeitures.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Fair value measurements

Accounting Standards Codification (ASC) Topic 820 defines fair value as the price that would be received to sell an asset or liability in an orderly transaction between market participants at a measurement date. It provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value; the three levels of the fair value hierarchy are described below:

Level 1 – Valuations are based on unadjusted quoted prices in an active market for identical assets or liabilities.

Level 2 – Valuations are based on quoted prices for similar assets or liabilities in active markets, or quoted prices in markets that are not active for which significant inputs are observable, either directly or indirectly.

Level 3 – Valuations are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. Inputs reflect management's best estimate of what market participants would use in valuing the asset or liability at the measurement date.

There were no investments in the plan at August 11, 2022. All investments in the plan at December 31, 2021 were in registered investment company assets, which are measured at fair value and are categorized as Level 1.

Realized gains and losses represent the difference between proceeds received and fair value at the beginning of the year, or purchase price if acquired during the year.

Payment of benefits

Benefits were recorded when paid.

Plan expense

Plan administrative expenses were paid by the Company.

4. Tax status

The Plan adopted a prototype non-standardized profit sharing plan provided by Plan Administrators, Inc. The IRS has issued a determination letter, dated March 31, 2014, stating that the form of the prototype plan is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of employees. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. Subsequent events

There were no subsequent events through June 14, 2023, which is the date the financial statements were available to be issued, requiring recording or disclosure in the financial statements for the period ended August 11, 2022.
