### ***Basis for Opinion***

As a result, the Klein Steel Service Inc. 401(k) Profit Sharing Plan & Trust changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Klein Steel Service Inc. 401(k) Profit Sharing Plan & Trust's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

NOTE A: DESCRIPTION OF THE PLAN

The following description of the Klein Steel Service Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan document, including amendments, for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution retirement plan established on January 1, 2000 to provide retirement benefits for employees of Klein Steel Service Inc. (the “Plan Sponsor”) who meet certain age and length of service requirements. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan termination

On April 29, 2022, the Company was sold to a third party and the Company approved termination of the Plan in accordance with the provisions of ERISA, effective May 31, 2022. There were no further contributions to the Plan after this date. At termination, participants were considered 100% vested in their accounts. The Plan began making distributions in May 2022 and made final distributions in August 2022. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to value plan assets from ongoing basis to the liquidation basis for the periods after April 29, 2022.

Administration

The Plan Sponsor administers the Plan. Reliance Trust Company (“Reliance Trust”) is the trustee of the Plan and custodian of the Plan’s assets. ADP Retirement Services is the Plan’s third-party administrator and provides bookkeeping services for the Plan.

Participant requirements

Each employee shall be entitled to make elective deferrals to the Plan upon attaining 18 years of age and completion of three months of service, as defined in the Plan. Effective January 1, 2019, the Plan was amended to change the service requirement for newly eligible employees to be one hour of service, as defined in the Plan. In addition, each employee shall be entitled to share in discretionary employer matching or profit-sharing contributions if the employee is an eligible participant and made elective deferrals during the Plan year.

Contributions

Each year, eligible employees may contribute between 1% and 86% of their eligible compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. Once meeting eligibility requirements, an employee will be enrolled into the Plan with an elective deferral rate of 5% of eligible compensation, unless the employee elects otherwise.

The Plan Sponsor may make matching contributions to eligible employees each pay period, based on participant deferrals for that pay period. The matching contribution is equal to 50% of the participant’s elective deferrals, up to a maximum deferral rate of 5%. The Plan includes an annual true up provision to the employer match calculation. The Plan Sponsor may also, at its discretion, make profit-sharing contributions to the Plan on behalf of the participants in proportion to each participant’s eligible compensation compared to the total eligible compensation of all other eligible employees. The matching contributions totaled \$79,868 for the period January 1, 2022 to August 31, 2022. There were no discretionary profit sharing contributions for the period ended August 31, 2022 or the year ended December 31, 2021.

Participant accounts

Participants may direct the investment of their accounts among the investment options offered by the Plan. Each participant's account is credited with the participant's contributions and an allocation of the employer contributions and Plan earnings and charged with withdrawals and an allocation of expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become vested in employer contributions plus actual earnings thereon based on years of service, as shown below:

Payment of benefits

Upon retirement, death, termination of employment or permanent and total disability, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested balance in his or her account. If the participant's vested account balance exceeds \$5,000, the participant may also choose to receive installments or defer receiving payments until age 72. If a participant's balance is less than \$1,000, the Plan Sponsor may distribute the vested balance as a lump sum to the participant or roll the balance to an Automatic Rollover IRA. If a participant's balance exceeds \$1,000 but less than \$5,000, the Plan Sponsor may roll the vested balance into an Automatic Rollover IRA. In addition, hardship withdrawals are available under the Plan, subject to certain early withdrawal penalties. Other withdrawals may be subject to restrictions as defined in the Plan.

Forfeitures

Forfeitures of non-vested employer contributions may be used to reduce future employer contributions and Plan administrative expenses. At December 31, 2021, the Plan had \$1,374 of non-vested employer contribution forfeitures. There were no non-vested employer contributions forfeitures at August 31, 2022. During 2022, employer contributions were reduced for forfeited account balances by \$7,994.

Participant notes receivable

Participant notes receivable are measured and valued at their unpaid principal balance plus any accrued but unpaid interest. The Plan allows participants to borrow from their vested account balance. The minimum amount of each loan is \$500. The maximum amount of borrowings permitted cannot exceed the lesser of (1) 50% of a participant's vested account balance or (2) \$50,000, reduced by the highest outstanding loan balance, if any, the participant had at any one time during the previous twelve-month period. The notes must generally be repaid through payroll withholding in equal installments consisting of principal and interest, at a reasonable interest rate, over a period not to exceed five years unless for the purchase of a primary residence, in which case the repayment period may not exceed thirty years. Principal and interest payments on the notes are redeposited into the participant's account based on their current investment allocation election.

The Plan classifies all participant loans in default if any scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which a payment is first missed. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying 2021 financial statements of the Plan are prepared on the accrual basis of accounting.

The 2022 financial statements have been prepared under the liquidation basis. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update ("ASU") 2013-07, Liquidation Basis of Accounting. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan in April 2022.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefit payments to participants are recorded when paid.

Use of estimates in the preparation of financial statements

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deduction in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through June 13, 2023, which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE C: FAIR VALUE MEASUREMENTS

The Plan follows the fair value measurement guidance presented by accounting principles generally accepted in the United States of America for financial assets and liabilities and nonfinancial assets and liabilities. This guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2022 and December 31, 2021.

*Registered Investment Companies:* These investments are valued using the Net Asset Value (“NAV”) of shares held by the Plan at year end.

*Common Collective Trust:* Valued at the net asset value reported by the fund as a practical expedient as determined by the issuer. There are no unfunded commitments and investments can be redeemed on a daily basis without restriction and are not subject to redemption notification provisions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E: TAX STATUS

The Internal Revenue Service determined and stated by a letter dated July 16, 2014, that the prototype plan under which the Plan was adopted, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of IRC. Therefore, they believe that the Plan is qualified and the related trust is exempt from taxation as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2019.

NOTE F: TRANSACTIONS WITH PARTY-IN-INTEREST

Reliance Trust is the trustee for the Plan. Transactions in any affiliated investments qualify as party-in-interest transactions which are exempt from the prohibited transactions rules. Participant loans qualify as party-in-interest transactions. As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.
