Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AGSPRING IDAHO 1, LLC RETIREMENT SAVINGS PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits for the three month period ended August 30, 2022 and the year ended May 31, 2022, and the related statement of changes in net assets available for benefits for the three month period ended August 30, 2022 and the year ended May 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AGSPRING IDAHO 1, LLC RETIREMENT SAVINGS PLAN's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution for the three month period from June 1, 2022 through August 30, 2022 and for the year ended May 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of AGSPRING IDAHO 1, LLC RETIREMENT SAVINGS PLAN and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about AGSPRING IDAHO 1, LLC RETIREMENT SAVINGS PLAN's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1: DESCRIPTION OF THE PLAN

The Agspring Idaho 1, LLC Retirement Savings Plan was originally established effective as of June 1, 2013 under the name "Agspring, LLC Retirement Savings Plan". The Plan was amended most recently, effective July 1, 2021, to change the Plan Sponsor from Agspring, LLC to Agspring Idaho 1, LLC and to change the Plan name to Agspring Idaho 1, LLC Retirement Savings Plan. The Plan has been terminated and all participant accounts have been distributed as of August 30, 2022, the final date of the Plan. See Note 8 for Plan termination details. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Prior to Plan termination, the Plan is a defined contribution plan covering substantially all employees of Agspring, LLC, Agspring Logistics, LLC, FO-ND, LLC, Agspring Idaho, LLC and Agspring Idaho 1, LLC who are age eighteen or older and are not union employees, nonresident aliens, part-time, temporary or seasonal employees regularly scheduled less than one thousand hours, or leased employees. The Plan Sponsor is Agspring Idaho 1, LLC. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan participation is voluntary. No participants shall enter the Plan after the effective date of Plan termination.

Contributions

Prior to Plan termination, each year, participants may elect to defer up to an annual limit of the lesser of 100% of eligible compensation or \$20,500 for the calendar year 2022, \$27,000 for employees age 50 or older. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes safe harbor matching contributions equal to 100% of salary deferrals which do not exceed 6% of eligible compensation. The Company may make annual discretionary profit sharing contributions in an amount to be determined by the Board of Directors. For the three months ended August 30, 2022, no profit sharing contributions were made. No contributions shall be made after the effective date of Plan termination.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution (when applicable) and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings and compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the 401(k) Plan, a participant may direct Plan assets to any or all 18 investment options offered. Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear a reasonable interest rate determined by the Plan Administrator; no loans were outstanding at August 30, 2022. All loans are considered a directed investment of the participant's account under the Plan, and all payments of principal and interest by the participant on a loan will be credited to the participant's account.

Payment of Benefits

Prior to Plan termination, a participant is eligible to request a distribution of their vested account balance based upon any of the following events: death, disability, retirement, minimum required distributions, in service withdrawal after age 59½, and termination of employment. The payment may be a lump sum cash payment and/or a direct rollover distribution. For termination of service for reasons other than death, disability or normal retirement, the participant will receive the value of the vested account balance automatically, as a lump-sum cash out distribution if the vested account balance does not exceed \$5,000.

Due to Plan termination, for those participants and beneficiaries who did not respond to the termination distribution form, the Plan administrator has directed the payment of all Plan benefits to individual retirement accounts (IRA) for the participant's benefit.

Prior to Plan termination, the Plan allows hardship distributions of the participant's pretax contributions in the event of specific, immediate and heavy financial need. There is no deferral suspension period following a hardship withdrawal.

Plan Termination

The employer has the right to amend or terminate the Plan at any time. The Plan was terminated August 30, 2022 and all Plan assets distributed to Plan participants or beneficiaries by August 30, 2022.

Forfeited Accounts

At August 30, 2022 and May 31, 2022, forfeited nonvested accounts totaled \$0 and \$0, respectively. These accounts are used to pay administrative expenses or to reduce future employer contributions. The Plan sponsor paid the remaining administrative expenses, such as audit and legal fees.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan for the year ended August 30, 2022 and for the three months ended thereon are prepared using the accrual method of liquidation accounting, due to the Plan termination on August 30, 2022. The financial statements of the Plan for the year ended May 31, 2022 are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative expenses, if paid from plan assets, are included in the statement of changes in net assets available for benefits and allocated to the participant's accounts. If the administrative expenses are paid by the Plan sponsor, they are not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net depreciation of fair value of investments.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Participant Loans

Participant loans are measured at amortized cost, which is their unpaid principal balance plus accrued but unpaid interest. No allowance for doubtful accounts is required as participants have the option of repaying the loan or having the loan distributed to them upon termination. A loan will be processed as a deemed distribution against the vested account balance if it is not repaid following termination.

Payment of Benefits

Benefits are recorded when paid.

Income Tax Status

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the Determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3: INVESTMENTS-UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE

The August 30, 2022 and May 31, 2022, Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets in Liquidation Available for Benefits for the three months ended August 30, 2022, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Minnesota Life Insurance Company, the Plan trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and contract value
- Net appreciation (depreciation) in fair value of investments
- Interest income
- Interest income on participant loans
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4: FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establish a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 30, 2022 and May 31, 2022.

- Pooled Separate Investment Account: Valued at net asset value (NAV) of the units of the separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The unit NAV is calculated based on the net fair value of the underlying investments. Participant transactions (purchases and sales) may occur daily. A full redemption of the separate account by the Plan may result in a temporary delay in withdrawal from the account to ensure that securities liquidations will be carried out in an orderly business manner.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of August 30, 2022 and May 31, 2022.

NOTE 5: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan has a fully benefit-responsive investment contract with Minnesota Life Insurance Company. Minnesota Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

As described in Note 2, because the guaranteed portfolio fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed portfolio fund. Contract value, as reported to the Plan by Minnesota Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: premature termination of the contracts by the plan, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE 6: RELATED PARTY TRANSACTIONS

Plan investments include various Pooled Separate Accounts and a fully benefit-responsive contract managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company, a related company, is the trustee as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for the investment management services are absorbed by the investments and reflected in the funds fair value. Certain other expenses are absorbed by the Plan Sponsor.

NOTE 7: RISKS AND UNCERTAINTIES

Prior to Plan termination, the Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 8: PLAN TERMINATION

In June 2021, the Board of Directors expressed their intent to sell Agspring Logistics, LLC (Agforce), FOND, LLC (Firebird), and Agspring Idaho, LLC (Thresher), as well as their intent to close Agspring, LLC and Agspring Idaho 1, LLC, and, therefore, terminate the Plan.

Effective July 1, 2021 all corporate employees were transferred into Agspring Idaho 1, LLC, leaving no employees in Agspring, LLC, and the Plan Sponsor was changed from Agspring, LLC to Agspring Idaho 1, LLC. Agforce, Firebird, and Thresher were sold on November 16, 2021, December 3, 2021, and December 6, 2021, respectively, therefore ceasing participation in the Plan. The final payroll deferrals for the remaining corporate employees of Agspring Idaho 1, LLC were funded to the Plan May 2, 2022.

All participants had the option of either receiving a distribution (less applicable penalties and taxes) or transferring their balance to another qualified fund. All of the Plan's assets were either distributed or transferred, as elected by each participant, by August 29, 2022, and the Plan was terminated on August 30, 2022.

NOTE 9: SUBSEQUENT EVENTS

Subsequent events have been evaluated through the date of the attached auditors' report, the date the financial statements were available to be issued. Management has determined that the Plan did not have any material recognizable or nonrecognizable subsequent events, through the date of the attached auditor's report.
