Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tatum Development Corp 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits in liquidation as of August 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits in liquidation for the period ended August 1, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of August 1, 2022 and December 31, 2021 and for the period ended August 1, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Termination and Liquidation Basis

As discussed in Note 1 to the financial statements, the Board of Directors of Tatum Development Corporation, the Plan's sponsor, voted on December 30, 2021, to terminate the Plan, and management determined liquidation is imminent as of December 30, 2021. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting to the liquidation basis of accounting used in presenting the 2022 and 2021 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following brief description of Tatum Development Corp 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Tatum Development Corporation (the "Company" or the "Sponsor") for the benefit of participating employers' full-time employees who have at least 90 days of service and are eighteen years old or older. An employee may begin participation in the Plan on the first day of January or July following the date in which the employee meets the requirements for eligibility. Participation ceases upon termination of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Termination

On December 30, 2021, Sponsor's Board of Directors adopted resolutions to terminate the Plan effective December 30, 2021 ("Termination Date"). As a result, management determined liquidation was imminent as of December 30, 2021. All participants became fully vested in their account balances as of December 30, 2021. All of the Plan assets were either distributed or transferred, as elected by each participant, by August 1, 2022.

Contributions

The Plan allows for participants to make pretax or after tax contributions, including catch-up contributions, to the Plan subject to the limitations set forth in the Internal Revenue Code (the "Code"). The Company may contribute matching contributions at their discretion. For the period ended August 1, 2022, the Company made profit sharing contributions in the amount of \$10,835.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's discretionary matching contributions, as well as allocations of the Company's discretionary profit sharing contributions and Plan earnings and losses and charged with an allocation of administrative expenses to the extent such expenses are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All participants are immediately vested in their voluntary contributions and allocated earnings or losses thereon.

Regardless of the years of service, the participant's employer contribution account becomes fully vested in the event of death, disability or the attainment of normal retirement age (age 65).

On December 30, 2021, the Board of Directors of the Company voted to terminate the Plan. Upon termination, the accounts of all participants became fully vested.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50 percent of the fair value of the participant's vested account balance. Note terms range from one to five years, unless used for the purchase of a principal residence and are collateralized by the balance in the participant's account. The notes bore interest rates ranging from 3.25 percent to 5.50 percent for the period ended August 1, 2022. Notes receivable from participants totaling \$971,323 were transferred out of the Plan during the period ended August 1, 2022.

Payment of Benefits

Benefits are generally payable on termination, retirement, death or disability. Benefits may be paid by either lump-sum payment, periodic payments over an actuarially determined period or rolled over into a qualified plan, subject to regulatory requirements. After attaining age 59 ½, a participant may elect to receive an in-service distribution for all or a portion of their vested balance. Hardship distributions are also available from participants' elective deferral accounts, including earnings on such deferrals, subject to regulatory requirements.

Forfeitures

Forfeitures, which result from employees withdrawing from the Plan prior to fully vesting in Company contributions, are used to offset Plan expenses or Company contributions. During the period ended August 1, 2022, forfeitures totaling \$28,643 were used to reduce employer contributions. As of August 1, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$-0- and \$24,578, respectively.

Note 2. Summary of Accounting Policies

Basis of Presentation

The accompanying 2022 and 2021 financial statements of the Plan have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at liquidation value. For all investments, fair value approximates the amount the Plan expects to collect at liquidation.

Purchases and sales of investments are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net depreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 1, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Distributions pursuant to the Plan termination were paid at the participants' election by (a) cash distribution of the present value of the participant's account; or (b) rollover distribution to an eligible retirement plan.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses of the Plan, to the extent that the Sponsor does not pay such expenses, are paid by the Plan.

Note 3. Information Certified and Provided by Principal

The information, including investments disclosed in the accompanying financial statements at August 1, 2022 and December 31, 2021 and net depreciation in fair value of investments, interest and dividends for the period ended August 1, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company (collectively "Principal"), the custodians of the Plan.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. As discussed in Note 2, fair value approximates the amount the Plan expects to collect at liquidation.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Pooled separate accounts: Pooled separate accounts held by the Plan are invested in domestic and international stocks, mutual funds or fixed securities. These are primarily valued at NAV per share based on quoted market prices of underlying investments (Level 2).

Collective investment trusts: The collective investments trusts include the Principal Stable Value Preferred Fund ("Fund") and Principal LifeTime Hybrid Collective Investment Trusts ("CITs") (Level 2).

Note 4. Continued

The Fund invests in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The objective of the Fund is to provide preservation of capital with relatively stable returns. The fund is valued at NAV, as reported by investment managers of the Fund and are supported by unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date resulting in a readily determinable fair value. Participant transactions and redemptions (purchases and sales) may occur daily. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, require twelve month advance written notice. As of August 1, 2022 and December 31, 2021, there were no unfunded commitments.

CITs invest in a collective trust fund as well as a variety of separate accounts and mutual funds that seek total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor with a specific target retirement date. These are valued at NAV per unit held by the Plan at year-end as reported by the custodians, which is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As a result of the Plan termination discussed in Note 1 to the financial statements, there were no Plan assets as of August 1, 2022.

Certain Plan investments are units or shares of pooled separate accounts and collective investment trusts managed by Principal, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to Principal totaled \$86,320 for the period ended August 1, 2022.

NOTES TO FINANCIAL STATEMENTS

Note 6. Plan Termination

The Board of Directors of the Company voted to terminate the Plan, effective December 30, 2021. Upon termination, the accounts of all participants become fully vested and the assets of the Plan, after payment of expenses, were distributed as elected by each participant, by August 1, 2022.

Note 7. Income Tax Status

The Company has adopted a prototype non-standardized plan whose sponsor obtained its latest opinion letter on March 31, 2014, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Code. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Note 8. Risks and Uncertainties

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through June 12, 2023, the date these financial statements were available to be issued.
