Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Fresquez, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of August 2, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period of January 1, 2022 to August 2, 2022 and the year ended December 31, 2021 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2021 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of August 2, 2022 and December 31, 2021, and for the period of January 1, 2022 to August 2, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the financial statements of the Plan referred to in the first paragraph. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan did not have sufficient accounting records and supporting documents relating to certain documentation in the Plan. We were unable to audit the Plan's records and procedures to assure the completeness of participants' data on which contributions and benefit payments are determined prior to December 31, 2021, as well as communications of eligibility to participants. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Emphasis of Matter—Plan Termination

As discussed in Note 7 to the financial statements, the governing body of the Plan terminated the Plan and transferred all plan assets into a pooled employer plan effective August 2, 2022.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4i Schedule of Assets (Held at End-of-Year) and Schedule H, Line 4a: Schedule of Delinquent Participant Contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph section of our report it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The Fresquez, Inc. 401(k) Retirement Plan (the Plan) was established on July 1, 1995 for the benefit of the employees of Fresquez, Inc (the Company). The Company acts as the Plan sponsor and administrator. Participants should refer to the Plan document for a more complete description of the Plan.

General

The Plan is a defined contribution plan covering all employees of the Company who have reached one year of service and have attained age twenty-one. Plan entry dates are the first day of the Plan year quarter coinciding with or next following one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974, as amended.

Contributions

Each year participants may elect to contribute a portion of their compensation, as defined, to the Plan. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor contributes to the Plan for all employees that meet the requirements in the Plan document. The contributions include a matching safe harbor contribution at 100% of an employee's contributions of the first 3% of their salary and 50% of the next 2% of the employee's salary. Employees become eligible to defer compensation and receive the matching safe harbor contribution on the first entry date after beginning employment.

Administration

Administration costs incurred by the Plan can be paid from forfeitures of the Plan. The Company may also choose to pay administration costs.

Participant Accounts

Each participant's account is credited with the participant and employer contributions, account earnings, gains and/or losses. Allocations of employer matching contributions are based on employee contributions made during the Plan year.

Employees can direct that their accounts be invested in any combination of the available funds.

Notes Receivable from Participants

Participants are allowed to obtain loans from the Plan for one-half of their vested interest in the Plan up to \$50,000, reduced by the highest outstanding loan amount during the preceding twelve-month period. The loans are repaid over a term not to exceed five years. The interest rate approximates market at the time of the loan.

NOTE 1 – DESCRIPTION OF PLAN – CONTINUED

Vesting

Participants are immediately vested in their salary deferral contributions, the Plan Sponsor's safe harbor contributions and investment earnings from these contributions.

Forfeitures

Forfeitures were zero in 2022 and 2021. Forfeitures are used to reduce employer match contributions in the Plan year immediately following the Plan year in which the forfeiture occurred and to pay Plan expenses.

Benefits

Upon termination of service, a participant may receive their account balance in the form of a lump sum distribution, rollover or installment payments over a specified period.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Fair Value Measurements

The fair value framework prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1 – Unadjusted quoted prices in active markets for identical investments that the Plan has the ability to access at the measurement date.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Fair Value Measurements – Continued

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the investment, either directly or indirectly. These inputs may include quoted prices for the identical instrument in an inactive market, inputs other than observable quoted prices, or inputs derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy are based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments

Investments are stated at fair market value and notes receivable from participants are valued at their outstanding balance.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Plan Tax Status

The Plan operates on a volume submitter document and obtained its latest opinion letter on July 8, 2014, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Plan administration believes there are no uncertain tax positions related to Plan activities.

Subsequent Events

The Plan has evaluated all events occurring subsequent to August 2, 2022 and through June 16, 2023, which is the date that the financial statements were issued and believes that all events occurring during this period requiring either recognition or disclosure are included in the accompanying financial statements.

NOTE 3 – INFORMATION CERTIFIED BY CUSTODIAN

Financial information relating to Plan investments at August 2, 2022 and December 31, 2021, as well as investment income, realized and unrealized gains (losses) on investments and investment transactions, has been certified as complete and accurate by John Hancock Life Insurance Company and as of August 2, 2022 and December 31, 2021 and for the period of January 1, 2022 to August 2, 2022 and for the year ended December 31, 2021. Therefore, in accordance with the request of the Plan Administrator and as allowed under 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subject to auditing procedures generally accepted in the United States of America by the Plan's Independent Public Accountants.

NOTE 4 – FAIR VALUE MEASUREMENTS

Registered Investment Companies: Valued at the net asset value per share of the account at year-end, which is not publicly quoted.

NOTE 6 – RELATED PARTY TRANSACTIONS

Certain Plan investments are funds managed by Automatic Data Processing, Inc. and its subsidiaries Automatic Data Processing, Inc. is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

NOTE 7 – PLAN TERMINATION

Effective August 2, 2022, the Plan Sponsor terminated the Plan and transferred all plan assets into a pooled employer plan.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – COMPLIANCE

Management, during 2019, identified the inaccurate filing of the 2017 IRS Form 5500 identifying the Plan as having less than 100 “participants” at the end of 2017. Through Management, Plan Providers, and other personnel changes during the periods ending December 31, 2020, 2019, and 2018 documentation to support participant deferral elections, loans, hardship and other withdrawals and eligible participant notifications, are unavailable to provide to the independent auditor to demonstrate Plan compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under the ERISA of 1974.

The 2018, 2019, 2020 IRS Form 5500’s were filed delinquent. Management had assessed the likely impact to the Plan and the Plan Sponsor. Impact to the Plan was estimated and remitted to the Plan during 2021.
