Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Centric Consulting, LLC Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of August 4, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended August 4, 2022, and the related notes to the financial statements.

Notes to Financial Statements
August 4, 2022

1. Description of Plan

The following description of the Centric Consulting, LLC Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General – The Plan was a defined contribution plan covering all employees of Centric Consulting, LLC (Company) who were 21 or older except collectively bargained, non-resident aliens, or leased employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 24, 2022, the plan administrators and plan trustees voted to cease future Company contributions to the Plan, and effective August 4, 2022, the Plan was merged into the Centric Consulting, LLC 401(k) and Profit Sharing Plan (the 401(k) Plan), an affiliated plan sponsored by the Company.

Contributions – Company contributions were made at the option of the Company's managing members as defined by the Plan. The maximum contribution to the Plan in any year is determined by provisions in the Plan and the Internal Revenue Code (IRC) and Income Tax Regulations. No contributions were made for 2022. The participants directed the investment of contributions into various investment options offered by the Plan prior to the merger with the 401(k) Plan.

Participant Accounts – Prior to the merger, each participant's account was credited with allocations of (a) the Company's contribution, if any, (b) plan earnings, and (c) administrative expenses. Allocations were based on the participant earnings, account balances, or participant events, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Vesting in the Company's contribution plus earnings thereon was based on years of continuous service. A participant was 100 percent vested after five years of credited service. In addition, a participant became 100 percent vested upon death, disability, or retirement as defined by the Plan.

Payment of Benefits – Upon termination of service, a participant could elect to receive a lump-sum amount equal to the participant's vested interest in his or her account. The Plan provided for an automatic distribution of account balances of \$5,000 or less. The Plan also allowed for in-service withdrawals of participants' vested interest for participants over age 59½.

Forfeited Accounts – Forfeited amounts were used to pay plan expenses or reduce Company contributions. At December 31, 2021, forfeited non-vested accounts totaled \$47,891. In 2022, the Company utilized \$47,891 of forfeited non-vested balances to reduce the 2021 Company contributions, \$2,979 to pay plan expenses, and transferred \$16,638 of forfeitures to the 401(k) Plan.

Notes Receivable from Participants – Prior to the merger, participants could borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. The minimum amount of a loan was \$1,000. Note terms ranged from one to five years except for the purchase of a primary residence, which was a longer term determined by the plan administrator. The notes were secured by the vested balance in the participant's account and bore interest at a rate commensurate with prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through payroll deductions. Outstanding loans on August 4, 2022 totaling \$63,515 were transferred to the 401(k) Plan.

Revenue Sharing Credits – The Plan utilized an Expense Budget Account (EBA) for the purpose of paying plan expenses. The EBA represented an unallocated account funded via quarterly revenue sharing credits earned from certain investment holdings of the Plan. Excess amounts in the EBA must be allocated to participant accounts. For the period ended August 4, 2022, the Plan earned revenue sharing credits of \$16,825, which were allocated to participant accounts. The balance of the EBA account was \$10,908 as of December 31, 2021 (included in investments, at fair value on Exhibit A), and was \$11,304 as of August 4, 2022 (merged into the 401(k) Plan).

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are valued at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans that are fully collateralized but treated as deemed distributions under Form 5500 reporting rules are carried on the Plan’s books until a distributable event occurs based upon the terms of the plan document, at which time the loan is treated as a distribution.

Investment and Administrative Expenses – The Plan’s expenses are paid either by the Plan or the employer, as provided by the Plan document. Expenses paid directly by the employer are excluded from these financial statements. Certain fees are charged to the Plan for services provided by the investment custodian of the Plan and are netted with investment earnings.

Payment of Benefits – Benefits are recorded when paid for financial statement purposes.

Subsequent Events – The Plan has evaluated subsequent events through June 13, 2023, the date on which the financial statements were available to be issued.

3. Information Certified by Fidelity Management Trust Company, the Investment Custodian

Certain information, as noted below, related to investments disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2021, and net depreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the period ended August 4, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

4. Fair Value Investments

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used during 2022.

The following is a description of the valuation methodologies used for assets measured at fair value:

- *Money Market Fund*: Valued at the total of the invested deposit plus earnings thereon, which approximates fair value.
- *Mutual Funds*: Valued at quoted market prices, which represent net asset value (NAV) of shares held by the Plan at year end.
- *Self-Directed Brokerage Account (BrokerageLink Account)*: Accounts primarily consist of 1) cash and common stocks that are valued on the basis of readily determinable market prices, and 2) unit investment trusts that are valued based on underlying investments that have readily determinable values.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of August 4, 2022 all investments have been merged and transferred to the 401(k) Plan.

5. Administrative Expenses and Party-In-Interest Transactions

A transaction with a plan service provider or a participant of the Plan qualifies as a party-in-interest transaction. Service provider fees, either directly or indirectly, are paid to Fidelity Management Trust Company, the investment custodian, third-party administrator, investment advisor, and record keeper. Of these fees, \$9,468 is included in administrative expenses on Exhibit B. Other investment fees are netted with investment earnings. Expenses incurred in the administration of the Plan were also paid by the plan sponsor.

Notes receivable from participants are considered to be both party-in-interest and a related-party transaction. Additionally, prior to the merger, certain plan investments were both held and managed by the custodian.

6. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their Company contributions. The Plan was not terminated, instead was merged with the 401(k) Plan in 2022.

7. Tax Status

The volume submitter plan, on which the Plan, prior to merger, was designed, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable sections of the IRC. Although the Plan was restated and amended since receiving this determination letter, the plan administrator and the volume submitter plan sponsor believe that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no open audits for any tax periods in progress.
