To the Trustees
Merfish United 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Merfish United 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of November 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 through November 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **Merfish United 401(k) Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **Merfish United 401(k) Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Emphasis of Matter – Plan Termination

As described in Note 1 to the financial statements, the Board of Directors of Reliance Steel & Aluminum Co. voted to terminate the Plan and transfer all Plan assets into the Reliance Steel & Aluminum Co. Master 401(k) Plan which occurred in July 2022. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

MERFISH UNITED 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF PLAN

The following description of Merfish United 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General and Plan Merger: The Plan was a defined-contribution plan established on January 1, 1985 and amended July 1, 2020 to provide retirement and other related benefits to all employees of United Pipe and Steel Corporation (the “Company”). Employees, other than excluded employees, who had attained the age of 21 and completed three months of service were eligible to participate in the Plan. An employee was an excluded employee if they were a non-resident alien, union employee, a leased employee, or a resident of Puerto Rico. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

During 2021, the Board of Directors voted to suspend all contributions to the Plan effective January 1, 2022. Substantially all of the assets were transferred out of the Plan on July 29, 2022 with the residual amounts fully distributed out of the plan by November 30, 2022. Participants were notified that their account balances would be automatically transferred into the Reliance Steel & Aluminum Co. Master 401(k) Plan.

Plan Termination: The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Participant Contributions: Prior to January 1, 2022 participants could contribute an amount up to 100% of their annual compensation, as defined in the Plan, or the limits set by the Internal Revenue Service (“IRS”). Participants could designate a portion, or all, of their deferred contributions as Roth contributions, which were includable in the participant’s gross income. Participants who had attained the age of 50 before the end of the plan year were eligible to make catch-up contributions as prescribed by Treasury regulations. Participants may deposit amounts received from any other retirement plan which satisfy the tax rules for rollovers.

Employer Contributions: The Company had elected to make discretionary employer matching contributions determined each year based on the amount contributed by a participant, subject to limits imposed by federal law. The Company could also make a discretionary non-elective profit-sharing contribution to the Plan based on each participant’s compensation. There were no non-elective profit-sharing contributions made during the period ended November 30, 2022.

Participant Accounts: Each participant’s account was credited with the participant’s contributions and Plan earnings or losses and charged with an allocation of administrative expenses, if any. Allocations of participant earnings (losses) were based on account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account balance.

Investment Options: Participants directed the investment of contributions into various investment options offered by the Plan.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Vesting: Participants were immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Company discretionary matching contributions and profit-sharing contributions were subject to a vesting schedule based on the number of years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 year but less than 2 years	20%
2 years but less than 3 years	40%
3 years but less than 4 years	60%
4 years but less than 5 years	80%
5 years or more	100%

Notes Receivable from Participants: Participants could borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Interest rates on these loans were at prime plus 1% and the interest rates for outstanding loans ranged from 4.25% to 7.25% at the time of transfer. Loans must have been repaid within five years, unless the loan was taken for the purchase of a primary residence, which could be repaid over a longer repayment term. Participants repaid principal and interest through payroll deductions. If participants terminated or retired, they would have the choice of repaying the loan or having the loan offset from their account. The offset loan amount would be considered a taxable distribution.

Payment of Benefits: On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic installment distributions. If a participant terminated employment for any reason, his or her account became 100% distributable if below \$1,000. A participant could also request a withdrawal upon attainment of age 59 ½, or upon demonstration by the participant to the Plan Administrator that the participant was suffering from a hardship, as defined by the Plan document. Participants could also withdraw any portion of their account attributed to rollover contributions at any time.

Forfeitures: A participant who left the employment of the Employer forfeited any non-vested balance at the end of the earlier of five one-year breaks in service or the distribution of the participant's entire vested account. Forfeited balances were used to reduce future Employer contributions or pay Plan expenses. There was \$0 and \$12,935 in the forfeiture account as of November 30, 2022 and December 31, 2021, respectively. During the period ended November, 2022, the Plan sponsor utilized \$22,394 of forfeitures to reduce the Plan expenses.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan were prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The financial statements have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investment Valuation and Income Recognition: Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisers, trustees and other parties involved with the Plan. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in conformity with GAAP required Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan utilized various investment instruments. Investment securities, in general, were exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities would occur in the near term and that such change could have materially affected the amounts reported in the statements of net assets available for benefits.

Payment of Benefits: Benefit payments to participants were recorded when paid.

Notes Receivable from Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of November 30, 2022 and December 31, 2021.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Uncertain Tax Positions: GAAP required plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator had analyzed the tax positions taken by the plan, and had concluded that as of November 30, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

NOTE 3: TAX STATUS

On November 30, 2020, the Internal Revenue Service stated the prototype adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan had been amended since receiving the determination letter. However, the Plan Administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

NOTE 4: CERTIFICATION OF TRUSTEE

The Plan Administrator had elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, the trustee certified that the following data included in the accompanying financial statements was complete and accurate.

NOTE 5: FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, “*Fair Value Measurement and Disclosures*”, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the asset or liability.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021. There were no assets at fair value at November 30, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common/collective trusts: Valued at the net asset value of units of a collective trust. The NAV, as provided by the fund manager, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used if it was determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

NOTE 5: FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

There were no assets held for investment at November 30, 2022.

NOTE 6: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Fidelity was the trustee and custodian of the Plan which qualified as a party-in-interest. Sentinel Benefits and Financial Group was the third-party administrator of the Plan, which also qualified as a party-in-interest. Fees paid by the Plan to Fidelity for services in connection with the Plan were reported as administrative expenses in the statement of changes in net assets available for benefits. The Plan extended loans to participants, who were considered parties-in-interest. These party-in-interest transactions were exempt from prohibitive transaction rules.
