## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of The Compass School 401(k) Profit Sharing Plan & Trust:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of The Compass School 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of November 11, 2022 (in liquidation) and December 31, 2021, the related statement of changes in net assets available for benefits for the period January 1, 2022 through November 11, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Compass School 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of November 11, 2022 and December 31, 2021, and for the period January 1, 2022 through November 11, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Emphasis-of-Matter – Plan Termination and Liquidation Basis of Accounting**

As discussed more fully in Note A to the financial statements, the Plan sponsor terminated the Plan in August 2022. The Plan was fully liquidated in November 2022. As a result, the Plan has changed its basis of accounting from the ongoing basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not affected with respect to this matter.

The supplemental schedule of assets (held at end of year) as of or for the period January 1, 2022 through November 11, 2022, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **A. Description of Plan**

The following description of The Compass School 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

Plan Termination

The Compass School (the "Company") was the sponsor of the Compass School 401(k) Profit Sharing Plan and Trust (the "Plan"). In August 2022, the Company was acquired by The Gardner School. Immediately prior to the acquisition, as of August 18, 2022, the Plan trustee amended the Plan to cease all contributions and terminate the Plan. Participants became 100% vested in all employer contributions.

Plan assets were held for the participants from the date of termination until the final distributions were made November 11, 2022. Distributions were made subject to direction of the participants. Participants had three distribution options: transfer assets to The Gardner School plan, transfer assets to a personal IRA, or take a distribution in cash. For those participants that did not provide direction, assets were transferred to an IRA account established in the name of the participant. All Plan assets were distributed as of November 11, 2022.

General

The Plan was a defined contribution, tax-deferred profit sharing plan originally established January 1, 2005, and most recently restated January 1, 2021. The Plan covered all employees of The Compass School (the "Company") who were at least 21 years of age, had one year of service (1,000 hr. minimum) with the Company. Employees covered by a collective bargaining agreement were exempt from participation in the Plan. Plan entry dates were monthly. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants could contribute up to 100% of compensation on a pre-tax basis, not to exceed the maximum salary deferral limit and other limitations established by law. Compensation was defined as wages, tips and other compensation on Form W-2, including bonuses and commissions and elective deferrals and contributions made to a qualified cafeteria plan.

Participants could elect deferral contributions as pre-tax elective deferrals. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions as allowed by the Internal Revenue Code (IRC). Participants also could make rollover contributions of distributions from other qualified defined benefit or defined contribution plans and certain individual retirement accounts. Participant contributions were invested according to direction of the participants.

The Company has the option to make matching contributions and profit sharing contributions to the Plan, although the Company was not required to do so. The amount of any matching contributions will be according to an allocation formula as determined by the Company. During 2022 and 2021, the Company contributed matching contributions in the amount of 10% of participant deferral contributions up to 4% of eligible compensation. Any profit sharing contributions will be allocated to eligible employees according to the allocation formula specified in the Plan. Company contributions were invested according to participant investment elections.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of any Company profit sharing contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their own deferral and rollover contributions and earnings thereon. Participants vested in Company matching and profit sharing contributions and earnings under a three year cliff vesting schedule. Participants become 100% vested under certain other circumstances, including attainment of age 65, the Plan's normal retirement age. Non-vested balances were subject to forfeiture upon termination of employment.

Participant Loans

Participants who were active employees could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants could have one outstanding loan at a time. The loans were secured by the vested balance in the participant's account. The loan interest rate was set at one percent above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Plan participants were eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, and at death. Benefit payments could be elected as a lump-sum payment equal to the value of the participant's vested interest in his or her account, or installments over a period of time to meet minimum distribution requirements. Terminated or deceased participants whose account balances do not exceed \$5,000 could be automatically distributed to the participant or beneficiary. If the balance exceeds \$5,000, the participant could elect to remain in the Plan or take a distribution in the form of a rollover or cash.

Forfeitures

At November 11, 2022 and December 31, 2021, forfeited non-vested balances were zero and \$134, respectively. Forfeitures could be used to pay any Plan expenses and then to offset other employer contributions. Forfeitures in the amount of \$134 were used to offset employer matching contributions during 2022.

**B. Summary of Accounting Policies**

Basis of Accounting

The financial statements of the Plan for the period January 1, 2022 through November 11, 2022, were prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. The financial statements of the Plan as of December 31, 2021 were

prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. The loans were secured by vested participant account balances. No allowance for credit losses was recorded as of November 11, 2022 and December 31, 2021. Delinquent participant loans were reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain administrative expenses of the Plan were paid by the Company and were excluded from these financial statements. Per-use transaction fees were charged directly to specific participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions. In addition to per-use transaction fees, participants with account balances shared in the operational expense of the Plan. Investment related expenses were included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through May 19, 2023, the date the financial statements were available to be issued.

**C. Information Prepared and Certified by the Custodian of the Plan**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A), the custodian of the Plan, has certified as to the

**D. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at November 11, 2022 and December 31, 2021.

Pooled separate accounts: Valued at the net asset value (NAV) of units as determined by the custodian. NAV was a readily determinable fair value and was the basis for current transactions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**E. Related Party and Party-In-Interest Transactions**

John Hancock Life Insurance Company (U.S.A) ("John Hancock") was the custodian of the Plan and received fees for custodial services, recordkeeping services, and per-use transactions, including loan setup, distribution and other administrative services that were included in administrative expenses. Certain Plan investments were managed by John Hancock, for which John Hancock received fees that were included in net appreciation in fair value of investments.

A third party administrator received payment for administrative and transaction processing services that were included in administrative expenses. A financial advisor received fees for services that were included in administrative expenses. The Company provided the Plan with accounting and administrative services, for which no fees were charged to the Plan. The Plan allowed loans to participants. The Plan individual trustee was eligible to participate in the Plan. These transactions qualified as exempt party-in-interest transactions.

**F. Tax Status**

The plan documents were restated effective as of January 1, 2021, as required by the Internal Revenue Service for the Plan to remain in compliance and maintain its tax-exempt status. Related to the restatement, the Internal Revenue Service had determined and reported in its opinion letter dated June 30, 2020, that the form of the adopted pre-approved plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes the Plan was being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions were taken that required recognition or disclosure in the financial statements.

**G. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would

## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of The Compass School 401(k) Profit Sharing Plan & Trust:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of The Compass School 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of November 11, 2022 (in liquidation) and December 31, 2021, the related statement of changes in net assets available for benefits for the period January 1, 2022 through November 11, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Compass School 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of November 11, 2022 and December 31, 2021, and for the period January 1, 2022 through November 11, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Emphasis-of-Matter – Plan Termination and Liquidation Basis of Accounting**

As discussed more fully in Note A to the financial statements, the Plan sponsor terminated the Plan in August 2022. The Plan was fully liquidated in November 2022. As a result, the Plan has changed its basis of accounting from the ongoing basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not affected with respect to this matter.

The supplemental schedule of assets (held at end of year) as of or for the period January 1, 2022 through November 11, 2022, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **A. Description of Plan**

The following description of The Compass School 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

Plan Termination

The Compass School (the "Company") was the sponsor of the Compass School 401(k) Profit Sharing Plan and Trust (the "Plan"). In August 2022, the Company was acquired by The Gardner School. Immediately prior to the acquisition, as of August 18, 2022, the Plan trustee amended the Plan to cease all contributions and terminate the Plan. Participants became 100% vested in all employer contributions.

Plan assets were held for the participants from the date of termination until the final distributions were made November 11, 2022. Distributions were made subject to direction of the participants. Participants had three distribution options: transfer assets to The Gardner School plan, transfer assets to a personal IRA, or take a distribution in cash. For those participants that did not provide direction, assets were transferred to an IRA account established in the name of the participant. All Plan assets were distributed as of November 11, 2022.

General

The Plan was a defined contribution, tax-deferred profit sharing plan originally established January 1, 2005, and most recently restated January 1, 2021. The Plan covered all employees of The Compass School (the "Company") who were at least 21 years of age, had one year of service (1,000 hr. minimum) with the Company. Employees covered by a collective bargaining agreement were exempt from participation in the Plan. Plan entry dates were monthly. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants could contribute up to 100% of compensation on a pre-tax basis, not to exceed the maximum salary deferral limit and other limitations established by law. Compensation was defined as wages, tips and other compensation on Form W-2, including bonuses and commissions and elective deferrals and contributions made to a qualified cafeteria plan.

Participants could elect deferral contributions as pre-tax elective deferrals. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions as allowed by the Internal Revenue Code (IRC). Participants also could make rollover contributions of distributions from other qualified defined benefit or defined contribution plans and certain individual retirement accounts. Participant contributions were invested according to direction of the participants.

The Company has the option to make matching contributions and profit sharing contributions to the Plan, although the Company was not required to do so. The amount of any matching contributions will be according to an allocation formula as determined by the Company. During 2022 and 2021, the Company contributed matching contributions in the amount of 10% of participant deferral contributions up to 4% of eligible compensation. Any profit sharing contributions will be allocated to eligible employees according to the allocation formula specified in the Plan. Company contributions were invested according to participant investment elections.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of any Company profit sharing contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their own deferral and rollover contributions and earnings thereon. Participants vested in Company matching and profit sharing contributions and earnings under a three year cliff vesting schedule. Participants become 100% vested under certain other circumstances, including attainment of age 65, the Plan's normal retirement age. Non-vested balances were subject to forfeiture upon termination of employment.

Participant Loans

Participants who were active employees could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants could have one outstanding loan at a time. The loans were secured by the vested balance in the participant's account. The loan interest rate was set at one percent above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Plan participants were eligible to receive benefit payments from the Plan at retirement, prior to retirement under certain circumstances, upon termination of employment with the Company, and at death. Benefit payments could be elected as a lump-sum payment equal to the value of the participant's vested interest in his or her account, or installments over a period of time to meet minimum distribution requirements. Terminated or deceased participants whose account balances do not exceed \$5,000 could be automatically distributed to the participant or beneficiary. If the balance exceeds \$5,000, the participant could elect to remain in the Plan or take a distribution in the form of a rollover or cash.

Forfeitures

At November 11, 2022 and December 31, 2021, forfeited non-vested balances were zero and \$134, respectively. Forfeitures could be used to pay any Plan expenses and then to offset other employer contributions. Forfeitures in the amount of \$134 were used to offset employer matching contributions during 2022.

**B. Summary of Accounting Policies**

Basis of Accounting

The financial statements of the Plan for the period January 1, 2022 through November 11, 2022, were prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America. The financial statements of the Plan as of December 31, 2021 were

prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. The loans were secured by vested participant account balances. No allowance for credit losses was recorded as of November 11, 2022 and December 31, 2021. Delinquent participant loans were reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain administrative expenses of the Plan were paid by the Company and were excluded from these financial statements. Per-use transaction fees were charged directly to specific participant accounts for certain services, such as processing loans, in-service withdrawals, distributions, and other transactions. In addition to per-use transaction fees, participants with account balances shared in the operational expense of the Plan. Investment related expenses were included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through May 19, 2023, the date the financial statements were available to be issued.

**C. Information Prepared and Certified by the Custodian of the Plan**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A), the custodian of the Plan, has certified as to the

**D. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at November 11, 2022 and December 31, 2021.

Pooled separate accounts: Valued at the net asset value (NAV) of units as determined by the custodian. NAV was a readily determinable fair value and was the basis for current transactions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**E. Related Party and Party-In-Interest Transactions**

John Hancock Life Insurance Company (U.S.A) ("John Hancock") was the custodian of the Plan and received fees for custodial services, recordkeeping services, and per-use transactions, including loan setup, distribution and other administrative services that were included in administrative expenses. Certain Plan investments were managed by John Hancock, for which John Hancock received fees that were included in net appreciation in fair value of investments.

A third party administrator received payment for administrative and transaction processing services that were included in administrative expenses. A financial advisor received fees for services that were included in administrative expenses. The Company provided the Plan with accounting and administrative services, for which no fees were charged to the Plan. The Plan allowed loans to participants. The Plan individual trustee was eligible to participate in the Plan. These transactions qualified as exempt party-in-interest transactions.

**F. Tax Status**

The plan documents were restated effective as of January 1, 2021, as required by the Internal Revenue Service for the Plan to remain in compliance and maintain its tax-exempt status. Related to the restatement, the Internal Revenue Service had determined and reported in its opinion letter dated June 30, 2020, that the form of the adopted pre-approved plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan administrator believes the Plan was being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management believes that no uncertain tax positions were taken that required recognition or disclosure in the financial statements.

**G. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would
