Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Sports Physical Therapy of New York, P.C. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, (date of liquidation), and December 31, 2021, (ongoing), and the related statements of changes in net assets available for benefits for the years ended December 31, 2022, (date of liquidation), and December 31, 2021, (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022, (date of liquidation), and December 31, 2021, (ongoing), and for the years ended December 31, 2022, (date of liquidation), and December 31, 2021, (ongoing), stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 3 to the financial statements, the Board of Directors of Sports Physical Therapy of New York, P.C., the Plan's Sponsor, voted on August 5, 2022, to terminate the Plan and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2022, (date of liquidation), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to, the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of plan

The following description of the Sports Physical Therapy of New York, P.C. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Plan termination - Effective August 5, 2022, the Plan was terminated, and all plan assets were distributed during the year ended December 31, 2022, (date of liquidation); see plan amendments below as well as Notes 2 and 3.

General - The Plan was a qualified defined contribution profit sharing plan under Section 401(a) of the Internal Revenue Code with a Section 401(k) provision. Employees of Sports Physical Therapy of New York, P.C. (the "Company") were eligible to participate in the Plan after completing three months of service and attaining age twenty-one. All assets acquired under the Plan were the result of employee and employer contributions thereto and all income and other additions thereto were administered, distributed, forfeited or otherwise governed by the provisions of the Plan and ERISA.

Plan amendments - Effective January 1, 2022, the Plan was amended and restated to comply with required Internal Revenue Service rules and regulations. Effective June 27, 2022, the Board of Trustees elected to terminate the Plan effective August 5, 2022. During 2020, the Plan implemented certain provisions of the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act), a law which allows immediate changes to the Plan to, among others, provide temporary tax relief for Coronavirus related distributions up to \$100,000 and suspends required minimum distributions. The Plan has also implemented certain required provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), a law which, among others, extends the age for required minimum distributions to seventy-two. Written amendments to the Plan to reflect these operational changes were adopted as of August 2, 2022.

Contributions - Participants were allowed to make elective 401(k) salary deferrals up to the maximum amount allowed by the Internal Revenue Code. The Plan had an auto-enroll feature in which the participants were automatically enrolled in the Plan with an initial deferral rate of 3% of their annual compensation to the 401(k) plan, which was increased automatically by 1% each year, up to a maximum of 6%, unless the participant elected a different percentage or expressly elected not to participate in the Plan. Participants were allowed to make rollover contributions to the Plan.

The Company had a Safe Harbor matching contribution provision. Under the Safe Harbor matching contribution, the Company was required to match at a minimum, 100% of the first 1% of pay contributed by the participant, plus 50% of the next 5% of pay for a maximum match of 3.5% of compensation. The Safe Harbor matching contributions amounted to \$36,205 for the period January 1, 2022 through August 5, 2022, (date of termination). Safe Harbor matching contributions amounted to \$57,182 for the year ended December 31, 2021. The Company could make additional discretionary contributions. These discretionary company contributions would be

determined annually by the Board of Trustees of the Company. There were no additional discretionary contributions made for the period January 1, 2022 through August 5, 2022, (date of termination), and the year ended December 31, 2021.

Vesting - Participants were immediately vested in their elective salary deferral contributions plus actual earnings thereon. Vesting in the remainder of their account was based on years of continuous service. A participant was 100% vested after two years of credited service for any Safe Harbor matching contributions. A participant vested at a rate of 20% after two years of service and 20% each year thereafter, with full vesting upon completion of six years of service for any additional discretionary company contributions. Effective August 5, 2022, (date of termination), all participants became 100% vested.

Forfeited and non-vested accounts - These accounts were used to reduce future employer contributions, pay administrative expenses or were allocated to participants, which was at the discretion of the Trustees. There were no available non-vested accounts as of December 31, 2022, (date of liquidation). There were approximately \$11,500 of forfeited non-vested accounts as of December 31, 2021. The Plan used approximately \$11,500 and \$11,800 to pay administrative expenses for the year ended December 31, 2022, (date of liquidation), and the year ended December 31, 2021, respectively, (see Note 5).

Participant accounts - Each participant's account was credited with the participant's elective salary deferral contribution, company contributions, the plan earnings and forfeitures of terminated participants' non-vested accounts. Allocations were based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant was entitled was the benefit that can be provided from the participant's account balance. Participants had access to their account information via Voya Retirement Insurance and Annuity Company's (VOYA) website, where they had the ability to change their elective deferrals and investment options as well as apply for participant notes receivable and request distributions.

Notes receivable from participants - Participants were able to borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account. There were no outstanding participant notes receivable as of December 31, 2022, (date of liquidation). Principal and interest were repaid ratably through payroll deductions. According to requirements of the participant note receivable program, the plan administrator would consider a note in default if any scheduled payment remained unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. Any notes that were in default as defined by the plan document were reported as either deemed distributions or benefit payments.

Deemed distributions - Deemed distributions represent the amount of unpaid principal on notes receivable from participants who were actively participating in the Plan and had not continued to make payments on the outstanding notes as required under the notes receivable from participants program. There were no deemed distributions for the years ended December 31, 2022, (date of liquidation), and December 31, 2021, (ongoing),

Investment options - Upon enrollment in the Plan, a participant could direct contributions to the Plan in various investment options. Participants had the option to change their investment options daily through online access.

Payment of benefits - Upon termination of service due to death, disability, retirement or other reasons, a participant or beneficiary would receive the value of the vested interest in his or her account as a lump sum distribution.

Note 2 - Summary of accounting policies

Method of accounting - The Plan maintained its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Effective August 5, 2022, the Board of Trustees adopted a resolution to terminate the Plan. As a result, the Plan's financial statements as of December 31, 2022, (date of liquidation), have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of the Plan is probable, and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realizable value and liabilities, if any, are stated at their anticipated settlement amounts.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Risks and uncertainties - The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, credit and overall market risk. Market risks included global events which could impact the value of investment securities, such as a pandemic or international conflicts. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in liquidation and the statements of changes in net assets available for benefits in liquidation.

Investment valuation and income recognition - Investments held by the Plan were stated at net asset value (see below), with the exception of the Voya Fixed Account Fund investment, which was fully benefit responsive and therefore valued at contract value (see Note 5). All investment values have been determined and certified by VOYA, the Trustee of the Plan, (see Note 4). Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

Pooled separate accounts invested primarily in equities, bonds, real estate and mutual funds, which were mainly publicly traded securities. Pooled separate accounts were valued at net asset value (NAV) per share, which served as a practical expedient to estimate its fair value. The NAV of each pooled separate account was not publicly quoted in the active markets. Each pooled separate account could have been redeemed at NAV as of the measurement date and could have been redeemed on a daily basis. There were no unfunded commitments or redemption restrictions on these investments as of December 31, 2022, (date of liquidation), and December 31, 2021, (ongoing). Investments measured at net asset value per share used as a practical expedient were not required to be classified in the fair value hierarchy.

Economic dependency and concentration of credit risk - All of the Plan's investments were invested with and managed by VOYA for the year ended December 31, 2022, (date of liquidation), and as of December 31, 2021, (ongoing). Accordingly, the Plan was dependent upon the financial condition of VOYA.

Administrative costs - Administrative costs, including maintaining participant accounts, legal and auditing costs, were the obligation of the Plan; however, the Plan Sponsor may have paid for such expenses or reimbursed the Plan for any payment of these expenses. Costs of managing the investments were paid directly out of the plan assets (see Note 5).

Notes receivable from participants - Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Management individually reviewed all notes receivable balances that exceeded ninety days from the date of the most recent payment and based on the assessment of credit worthiness, estimated the portion, if any, of the balance that would not be collected. Currently, there is no valuation allowance recorded; however, management would have recorded an allowance if potentially uncollectible participant notes receivable had become material. If a participant defaulted on a note receivable and distribution from the participant account had been made during the plan year because the participant had left the Plan, the defaulted note receivable would be reported as a benefit paid to participants on the statements of changes in net assets available for benefits in liquidation and deducted from the receivable balance.

Payment of benefits - Benefits were recorded when paid.

Subsequent events - Management has evaluated subsequent events through May 16, 2023, the date that the financial statements were available for issue.

Note 3 - Plan termination

On June 27, 2022, the Board of Trustees expressed their intent to terminate the Plan. Benefits were accrued through August 5, 2022, (date of termination), and all participants were considered fully vested as of August 5, 2022, (date of termination). Employees received lump sum payments from the Plan and were provided the option to have their lump sum amount rolled over into an IRA. The final distributions were made from the Plan on December 31, 2022, (date of liquidation).

Note 4 - Investments

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VOYA has certified that the trustee investments and investment income included in the accompanying financial statements as of December 31, 2022, (date of liquidation), and December 31, 2021, (ongoing), and for the year ended December 31, 2022, (date of liquidation), and for the year ended December 31, 2021, (ongoing), and supplemental schedule as of December 31, 2022, (date of liquidation), are complete and accurate. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to this information, except to compare such information to the related information included in the financial statements and supplemental schedule.

Note 5 - Fully benefit responsive investment contract

The Plan held an investment in The Voya Fixed Account Fund, a fully benefit responsive investment contract stated in accordance with the Financial Accounting Standards Board's authoritative guidance regarding accounting for fully benefit responsive investment contracts held by certain investment companies, which states that contract value was the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represented contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise. Investments measured at contract value were not required to be classified in the fair value hierarchy.

The crediting interest rates of the contract were based on agreed upon formulas with the issuer, as defined in the contract agreements, but could not have been less than 0%. Such interest rates were reviewed on a periodic basis for resetting. The key factors that could have influenced future interest crediting rates include the following: the level of market interest rates, the amount and timing of participant contributions, transfers and withdrawals into/out of the contract and the duration of the underlying investments backing the contract.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the sponsor or other sponsor event (e.g., divestures or spin-offs of a subsidiary) that caused a significant withdrawal from the Plan; (iv) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA; or (v) premature termination of the contract. No events were probable of occurring that would limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants except for plan termination as discussed in Note 3 above.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events included (i) an uncured violation of the Plan's investment guidelines; (ii) a breach of material obligation under the contract; (iii) a material misrepresentation; and (iv) a material amendment to the agreement without the consent of the issuer.

Note 6 - Related party transactions

The Plan's investments were managed by VOYA. Investment fees paid for these services qualified as party-in-interest transactions and are reported in the net appreciation (depreciation) in investments on the accompanying statements of changes in net assets available for benefits in liquidation.

The Plan contracted with Actuarial Pension Analysts, Inc. to provide third party administrative services and Dannible & McKee, LLP to provide independent auditor services. These transactions qualify as party-in-interest transactions under ERISA and are reported as administrative expenses in the accompanying statements of changes in net assets available for benefits in liquidation. Fees for these services amounted to \$12,450 for the year ended December 31, 2022, (date of liquidation). Fees paid for these services amounted to \$26,667 for the year ended December 31, 2021, (ongoing), of which the Plan paid \$15,167 and the remaining \$11,500 was accrued as an operating payable as of December 31, 2021, (ongoing), for which the Plan used available forfeited non-vested accounts as discussed in Note 1, to pay these operating payables during the year ended December 31, 2022, (date of liquidation).

Note 7 - Tax status of plan

The Plan adopted the DATAIR Cash or Deferred Profit-Sharing Plan Volume Submitted Adoption Agreement. The Internal Revenue Service has determined that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (the "Code"). Accordingly, the Plan has been accounted for as a tax-exempt plan. The Plan has been amended since receiving the determination letter. The plan administrator and the Trustees believe that the Plan was being operated in compliance with the applicable requirements of the Code.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and interest for the year ended December 31, 2022, (date of liquidation), and the year ended December 31, 2021, (ongoing). The Plan is no longer subject to regulatory examinations by tax authorities for the closed years before 2019.
