We have performed audits of the financial statements of Atlantic Capital Bank 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 24, 2022 and December 31, 2021, the related statement of changes in net assets available for benefits for the period ended June 24, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Atlantic Capital Bank 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Atlantic Capital Bank 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Emphasis of Matter - Basis of Accounting

As described in Note 1 to the financial statements, on February 28, 2022, the Plan was formally amended to terminate the Plan effective June 2, 2022. In accordance with GAAP, the Plan changed its basis of accounting used to determine the amounts in which investments are stated from the going concern basis used in presenting the statement of net assets available for benefits as of December 31, 2021, to the liquidation basis used in presenting the June 24, 2022 financial statements. Our opinion is not modified with respect to that matter.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Notes to Financial Statements

Note 1: Description of Plan

General

Atlantic Capital Bank 401(k) Plan (the "Plan"), a defined contribution plan, formed in 2007 to provide benefits exclusively for the employees of Atlantic Capital Bancshares, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, and designed to comply with all regulations of the Internal Revenue Service (IRS). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions

Eligibility

Eligible employees include all regular full-time employees, excluding non-resident aliens, of the Company over the age of 21. Employees are eligible to participate in the Plan on the first day of the first month subsequent to one month of service as defined by the Plan.

Contributions

Employees of the Company participating in the Plan are entitled to make before and Roth after-tax contributions to the Plan through payroll deductions in amounts up to the maximum percentage allowable not to exceed limits of the IRS. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund, set to increase annually by 1% until the maximum of 5%, or until changed by the participant.

The Company will contribute an ADP safe harbor matching contribution up to 100% of the first 5% of eligible compensation that a participant contributes to the Plan.

The Company, at its discretion, may make profit sharing contributions each plan year. There were no profit sharing contributions during 2022.

The Plan also allows for rollover and transfer contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor contributions, and allocations of (a) the Company's profit sharing contributions and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Company's profit sharing contribution portion of a participant's account is based on the number of years of service.

Company profit sharing contributions vest according to the following schedule:

The Company's ADP safe harbor matching contribution portion of participant accounts is immediately vested. Rollover and Transfer contributions are always 100% vested. Participants automatically become 100% vested if they become disabled or die.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 4.75%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or for other reasons, a participant is entitled to receive 100% of their account balance in a lump-sum distribution. In addition, hardship distributions out of the participant's vested contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Forfeitures

Forfeited nonvested accounts totaled approximately \$1,500 at December 31, 2021. These accounts will be used to reduce future Company contributions in accordance with the plan document. During the period ended June 24, 2022, the Company contributions were reduced by approximately \$17,900 from forfeited nonvested accounts.

Plan Termination, Participant Vesting, Participant Distributions and Tax Status

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA with the approval of the Board of Directors. Effective February 28, 2022, this Plan was terminated by the Company. Participants' matching contributions vested on that date and notice was provided to distribute account balances by June 2, 2022. For participant account balances not distributed by that date, the Plan's trustee was directed to initiate an automatic rollover on behalf of each participant to a qualified individual retirement account. All balances were distributed as of June 24, 2022.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Money Market and Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed income fund: The issuer of the fund declares a rate which is guaranteed for six months. The fund is valued at the rate that has been declared by the issuer as of the end of the Plan year. The fund is a general account structure with the issuer and is not actively traded in the public market.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable held at December 31, 2021, and net depreciation in fair value of investments, and interest and dividends for the period ended June 24, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, as agent for Ascensus Trust Company, the Trustee of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by Ascensus Trust Company. Ascensus Trust Company is the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for the investment management services were \$34,678 for the period ended June 24, 2022. Morgan Stanley provides certain investment management services to the Plan. The fees paid to Morgan Stanley (which qualify as party-in-interest transactions) amounted to \$100,923 for the period June 24, 2022.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Subsequent Events

The plan administrator has evaluated subsequent events through May 24, 2023, the date the financial statements were available to be issued.
