**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Temperature Equipment Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of August 22, 2022 and December 31, 2021, the related statement of changes in net assets available for benefits in liquidation for the period ended August 22, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 22, 2022 and December 31, 2021, and for the period ended August 22, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter—Plan Termination and Liquidation Basis**

As discussed in Note 1 to the financial statements, the Board of Directors of the Temperature Equipment Corporation, the Plan's sponsor, voted on October 21, 2021 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan's basis of accounting for presenting the 2022 and 2021 financial statements is the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. Plan Description

The following description of the Temperature Equipment Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. On October 21, 2021 the Board of Directors of Temperature Equipment Corporation resolved to terminate the Plan effective December 24, 2021.

Plan sponsor management communicated the pending Plan termination to participants in January 2022 and fully vested all participants effective December 24, 2021. As such, management determined that the liquidation of the Plan was imminent. Therefore, the Plan's 2021 financial statements are presented in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification 205, Presentation of Financial Statements: Liquidation Basis of Accounting. Final distributions were completed by August 22, 2022.

**General:** The Plan is a defined contribution plan maintained for the benefit of eligible employees of Temperature Equipment Corporation and National Excelsior Corporation (collectively, the Sponsor or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** Employees who have completed 1,000 hours of service (as defined) and reached 19 years of age are eligible to participate in the Plan. Eligible employees are enrolled in the Plan on January 1, April 1, July 1, or October 1 once all eligibility requirements were met. Unless otherwise elected, eligible employees were automatically enrolled in the Plan once they met the eligibility requirements.

**Participant accounts:** Each participant's account is credited with the participant's contributions, an allocation of the Employer's contributions (if any), an allocation of plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

**Vesting:** As a result of the decision to terminate the Plan during 2021, all participants became fully vested in their account balances effective December 24, 2021.

**Investment options:** Plan participants direct the investment of their account balance and future contributions into various investment options offered by the Plan. The allocation of investment options can be changed daily by the Plan participant.

**Notes receivable from participants:** As a result of the decision to terminate the Plan, outstanding notes receivable will become taxable income to participants at the time of distribution or they have the option to repay the outstanding loan balance if the participant elects a rollover into a qualified retirement plan.

Prior to termination, a participant could borrow from their account a minimum of \$1,000 up to a maximum of the lesser of 50% of the vested portion of their account balance or \$50,000 reduced by the excess, if any, of the participant's highest outstanding notes receivable balance during the one-year period prior to the date of the loan over the participant's current outstanding notes receivable balance. The Plan allowed participants to have up to two outstanding notes receivable at any given time. Notes receivable terms range from one to five years, or greater than five years for the purchase of a primary residence. The notes receivable is secured by the balance in the participant's account and bears interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator at the time the funds are borrowed. Principal and interest are paid ratably through payroll deductions. All loans were repaid or treated as a taxable distribution during 2022.

**Payment of benefits:** Distributions pursuant to the Plan termination were paid at the participants' election by (a) cash distribution of the present value of the participant's accrued benefit or (b) rollover distribution to an eligible retirement plan. For participants that do not make an election by March 31, 2022, any account balances under \$1,000 were sent a cash distribution, and any account balances over \$1,000 were rolled over into an individual retirement account (IRA).

Prior to termination, payments were made to participants or their beneficiaries upon termination of service due to retirement, death or disability. Vested benefits, less any loan amount outstanding, were payable in a lump-sum or in installments as defined in the plan document. Participants could make withdrawals from their vested account balances upon attaining the age 59 1/2, or by determination that a financial hardship, as defined, had occurred, without incurring penalties. The Plan would automatically make lump-sum distributions to terminated participants with vested balances of \$5,000 or less and would automatically rollover vested balances of terminated participants that are \$5,000 or less into an IRA.

**Forfeited accounts:** Forfeited nonvested accounts may first be used to either restore any prior forfeitures in the event of a former participant's return to employment, or to pay plan administrative expenses. During 2022, \$3,237 of forfeited nonvested accounts were used to pay plan expenses.

#### Note 2. Summary of Significant Accounting Policies

**Basis of presentation:** The financial statements of the Plan have been prepared in accordance with accounting standards set by the FASB. The FASB sets U.S. generally accepted accounting principles (GAAP) to ensure net assets available for plan benefits and changes in net assets available for plan benefits are consistently reported. References to GAAP issued by the FASB in these footnotes are to the FASB Accounting Standards Codification (FASB ASC).

As mentioned in Note 1, in connection with the termination of the Plan, the Plan's financial statements are presented in accordance with FASB Accounting Standards Codification 205, Presentation of Financial Statements: Liquidation Basis of Accounting.

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and accompanying notes. Actual results could differ from those estimates.

**Payment of benefits:** Benefit payments to participants are recorded upon distribution.

**Valuation of investments:** All investments in the 2021 statement of net assets available for benefits are reported at liquidation value. For all investments, except the guaranteed investment contract, fair value approximates the amount the Plan expects to collect at liquidation. For the guaranteed investment contract, contract value approximates the amount the Plan expects to collect at liquidation.

Purchases and sales of securities were recorded on a settlement-date basis. Interest income and dividends were recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net depreciation includes the Plan's gains and losses on investments sold during the year.

**Notes receivable from participants:** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans were treated as distributions based upon the terms of the plan document.

#### Note 3. Information Certified and Provided by Principal Trust Company

The following is a summary of the Plan's asset and income information as of August 22, 2022 and December 31, 2021, and for the period ended August 22, 2022, included throughout the Plan's financial statements, that was prepared by or derived from information provided by Principal Trust Company, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee is complete and accurate related to the following assets and income. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements related to the following assets and income:

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Investments valued at the net asset value (NAV) as practical expedient are not classified within the fair value hierarchy.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

**Registered investment companies:** Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

**Pooled separate accounts:** Valued at the total of the NAV of shares of mutual funds held by the account at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the period ended August 22, 2022, there were no transfers in or out of Level 3.

#### Note 5. Guaranteed Investment Contract

The Plan maintains a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% or greater than 3%.

As the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Changes in future interest crediting rates will not affect the amount reported on the statements of net assets available for benefits representing the adjustment for the portion of net assets attributable to full benefit-responsive investment contracts from fair value to a contract value as fair value is considered book value less early withdrawal charge.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date unless agreed upon by both parties.

The Principal Fixed Income Guaranteed Option is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a Stable Value fund. As a result, the average yield earned by the Plan is the yield earned on the group annuity contract.

#### Note 6. Related Party and Party-In-Interest Transactions

Certain plan investments are managed and administrated by Principal Trust Company, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Expenses incurred by the Plan, including those of the trustee in the performance of its duties and fees for its services, are shared by the Plan and the Sponsor. The administrative expenses paid by the Plan to the trustee were \$63,004 for 2022. Certain employees of the Sponsor provide administrative services to the Plan without reimbursement for their services from the Plan.

#### Note 8. Plan Termination

In April 2021, Temperature Equipment Corporation was acquired by Watcso, Inc. On October 21, 2021, the Board of Directors voted to terminate the Plan, effective December 24, 2021. As a result, management determined liquidation was imminent as of December 24, 2021. All participants became fully vested in their accumulated benefits as of December 24, 2021. All of the Plan assets were either distributed or transferred, as elected by each participant, by August 22, 2022.

The 2021 financial statements include \$63,004 of accrued administrative costs for future expenses the Plan expects to incur through the final liquidation. The 2021 financial statements include \$19,019 of accrued dividend income that the Plan expect to earn through final liquidation.

#### **Note 9. Tax Status**

The Plan obtained its latest determination letter on August 8, 2014, in which the Internal Revenue Service (IRS) states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan elected to not file for a qualification from the IRS.

#### **Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. These investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 11. Subsequent Events**

The Plan Administrator has evaluated subsequent events through June 15, 2023, the date the financial statements were available to be issued.
