Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Retirement Plan for Winston-Salem Dental Care (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit), which comprise the statements of net assets available for benefits as of October 7, 2022 (in liquidation) and December 31, 2021, and the related statements of changes in net assets available for benefits for the period ended October 7, 2022 (in liquidation) and the year ended December 31, 2021, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of October 7, 2022 and December 31, 2021, and for the periods then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the certified investment information in the accompanying financial statements agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination

As described in Notes 1, 2 and 6 to the financial statements, the Company's Board of Directors approved a resolution to terminate the Plan effective June 21, 2022. The Plan was fully liquidated as of October 7, 2022. Accordingly, the Plan has changed its basis of accounting from the going concern basis used in presenting the Plan's 2021 financial statements to the liquidation basis used in presenting the Plan's 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of Plan

The following description of the Retirement Plan for Winston-Salem Dental Care (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions

The Company’s Board of Directors approved a resolution to terminate the Plan effective June 21, 2022, subject to Plan provisions and in accordance with the Internal Revenue Code of 1986 (the “IRC”), as amended, and the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was fully liquidated as of October 7, 2022.

General

The Plan is a defined contribution plan available to substantially all employees of Drs. Ailetu, Andrews, Gravel, Gregory, Hutton, Johnson, Reilly & Associates, PA (formerly Kenneth M. Sadler, D.D.S. & Associates, P.A.) (the “Company” or “Employer”). Employees are eligible to participate in the Plan upon date of hire. Participants become eligible for the Company’s discretionary matching contributions upon completion of one year of employment with 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Eligible employees are automatically enrolled to defer 3% of their pre-tax compensation unless they elect an alternative percentage or decline participation. Participants may otherwise elect to contribute up to 60% of their annual pre-tax and/or after-tax compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company may make discretionary matching and non-elective contributions at a rate to be determined annually. No discretionary matching or non-elective contributions were made during 2022 or 2021.

Participants may direct contributions between the investment options offered by the Plan. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their participant contributions, plus earnings thereon. Vesting in the Company’s contributions is based on a three-year cliff vesting schedule.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant may generally elect to receive the value of the vested interest in his or her account in a lump-sum payment. In-service distributions may be made to participants who have reached age 59½. Withdrawals may also be made upon circumstances of financial hardship, as specified by the Plan.

1. Description of Plan (Concluded)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The maximum term for notes is generally five years, except for those used in the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at the prime rate. Only one note may be outstanding at a time. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

Forfeitures from non-vested participant accounts may be used to offset administrative expenses or Company discretionary contributions. Forfeitures of approximately \$22 and \$8 were used to offset administrative expenses during 2022 and 2021. At October 7, 2022 and December 31, 2021, there were \$0 and \$22 available in the forfeiture account.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Certain plan expenses, such as trustee and recordkeeping expenses, are permitted to be paid from the Plan's assets. Distribution and loan fees are paid from the affected participant's account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on a liquidation basis, in accordance with accounting principles generally accepted in the United States of America ("GAAP"). This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. As a result of the Plan termination in June, the Plan's financial statements as of October 7, 2022 and for the period ended October 7, 2022, have been prepared on the liquidation basis and in accordance with GAAP. The statements as of December 31, 2021 and for the year then ended have been prepared on a going concern basis in accordance with GAAP. There were no changes to the 2021 financial statements as a result of the change to liquidation basis of accounting in 2022.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through the Guaranteed Income Fund.

2. Summary of Significant Accounting Policies (Concluded)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 7, 2022 and December 31, 2021. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through June 5, 2023, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements including investments and notes receivable from participants held at October 7, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended October 7, 2022 and year ended December 31, 2021, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus.

4. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a non-standardized plan document sponsored by Ascensus LLC. Ascensus LLC obtained a determination letter dated June 30, 2020, in which the IRS stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

In June 2022, the Plan was terminated. As a result, all participant accounts became fully vested and nonforfeitable. The Plan was fully liquidated as of October 7, 2022.

7. Party-in-Interest Transactions

During 2021, Ascensus acquired the legacy BB&T bundled recordkeeping business from Truist Bank, which resulted in a change in the Plan's trustee and recordkeeper service providers.

Fees paid by the Plan to BB&T and related entity for trustee, recordkeeping, investment advisory, and administrative services, were approximately \$9,000 for 2021. BB&T was the trustee and recordkeeper of the Plan until March 3, 2021, as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Fees paid by the Plan to Ascensus for administrative services were approximately \$46,000 and \$28,000 for 2022 and 2021. Ascensus is the trustee and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Fees paid to Smith Leonard for auditing services were approximately \$21,000 (for two audit years) and \$9,500 (for one audit year) in 2022 and 2021.

Fees paid to Resource Investment Advisors for investment advisory services were approximately \$12,000 and \$10,000 in 2022 and 2021.

Fees paid to One Digital for investment advisory services were approximately \$12,000 in 2022.

Fees paid to ProNvest for investment advisory services were approximately \$15,000 in 2021.

Fees paid to NextCapital Group, Inc. for investment services were approximately \$4,000 in 2021.

8. Guaranteed Investment Contracts

The Guaranteed Income Fund is a group annuity product issued by Prudential Retirement Insurance and Annuity Company ("PRIAC"). Amounts contributed to the contract are invested in a broadly diversified fixed-income portfolio within PRIAC's general account including public bonds, commercial mortgages, and private placement bonds. The contract is designed to provide safety of principal, liquidity, and a competitive rate of return. Principal and accumulated interest are fully guaranteed by PRIAC. Generally, there are not any events that could limit the ability of the Plan to transact at contract value.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of those contributions. Interest crediting rates are reviewed on a semi-annual basis for resetting. The minimum crediting rate under the contract was 1.50% at December 31, 2021. It was terminated in June 2022.

9. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurement

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used in 2022 and 2021.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Common stock: Valued at the closing price reported on the active market on which the securities are traded and classified within Level 1 of the valuation hierarchy.

Common collective trust funds: Valued at NAV as determined by the issuer using estimated fair value of the underlying assets, minus liabilities, held in the funds. These investments are classified within Level 2 of the valuation hierarchy because the unit value is quoted on a private market that is not active; however, the unit value is based on the underlying investments, which are traded on an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table summarizes the investments by level as defined within the fair value hierarchy as of December 31, 2021.
