Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The American Film Institute, Inc. Money Purchase Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of August 10, 2022, and December 31, 2021, the related statement of changes in net assets available for benefits in liquidation for the period then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of August 10, 2022, and December 31, 2021 and for the period ended August 10, 2022 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis

As discussed in Note 1 to the financial statements, the Board of Trustees of the American Film Institute, Inc., the Plan's sponsor, voted on June 16, 2021 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – PLAN TERMINATION

Effective June 16, 2021, the Plan Sponsor terminated the Plan. Upon termination, all of its participants were immediately fully vested in the benefits provided pursuant to the plan, and the trustee of the plan was directed to distribute the assets of the Plan to eligible participants. All participants accounts were distributed to participants as of August 10, 2022.

NOTE 2 – PLAN DESCRIPTION

The following description of The American Film Institute, Inc. Money Purchase Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan that was established in July 1981 by The American Film Institute, Inc. (the "Institute" or "Employer") to provide benefits to eligible employees, as defined in the Plan agreement. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (IRC), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The board of trustees is responsible for oversight of the Plan.

Administration

The Institute has appointed a Plan administrator to manage the operation and administration of the Plan, as well as the investments selected. The Institute has contracted with Principal Life Insurance Company ("Principal") to act as the trustee, and Principal Retirement Plan Processing Services, a third-party administrator, to process and maintain the records of participant data.

Eligibility

Employees of the Institute are eligible to participate in the Plan upon attaining the age of 21, completion of 750 or more hours of service, and employment by December 31, 2021. Employees may enter the Plan semiannually, after completion of eligibility requirements.

Employer Contributions

As set forth in the Plan, the Institute contributes 3% of active participants' annual pay. Participants must be employed with the Institute on the last day of the Plan year and must have worked at least 750 hours during the Plan year. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Employer contributions were made for eligible participants through June 27, 2020.

Forfeitures

Forfeited non-vested employer contributions are used to reduce Plan expenses and employer contributions. During the years ended August 10, 2022 and December 31, 2021, there were no forfeited non-vested employer contributions used to reduce employer contributions. At August 10, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$22,695, respectively.

NOTE 2 – PLAN DESCRIPTION (Continued)

Vesting

As a result to terminate the plan during 2022, all participants became fully vested in their accrued benefits.

Participant Accounts

Each participant's account is credited with allocations of the employer contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants must direct employer contributions to selected investments, as made available and determined by the Plan administrator. Participants may change their investment options any time throughout the year, via the internet website offered by the trustee.

Payment of Benefits

Upon termination of employment due to death, disability, or retirement, participants or their beneficiaries will be entitled to receive the value of the participants' vested account balances as a lump-sum distribution, or upon death, participants' beneficiary may select an annuity option. For termination of employment due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Rollovers

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Plan Expenses

Substantially all administrative expenses are paid by the Institute. Certain expenses are charged directly to participants' accounts related to requested transactions.

NOTE 3 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Basis of Presentation

Due to the decision to terminate the Plan during 2022, management determined that liquidation of the Plan is imminent and the financial statements for 2022 have been prepared using the liquidation basis of accounting. The 2021 financial statements were prepared as a going concern on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought or sold, as well as held during the year.

Management fees charged to the Plan for investments in pooled separate accounts are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

The Plan's investment in the guaranteed interest account with Principal has been reported in the financial statements at fair value. The investment in the guaranteed interest account is intended to be held until maturity, although early liquidation could result in a termination charge. The fair value of the guaranteed interest account approximates contract value.

Benefit Payments

Benefits are recorded when paid.

NOTE 3 – SIGNIFICANT ACCOUNTING POLICIES (Continued)

Income Taxes

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan's opinion letter has been relied upon by this Plan. The Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provisions for income taxes have been recorded in the Plan's financial statements.

Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 4 – FAIR VALUE MEASUREMENT

The fair value measurement standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs, other than quoted prices, that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data, by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts

Units held in pooled separate accounts (PSA) are valued using the NAV practical expedient (NAV) of the PSA, as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information.

Guaranteed Interest Account

Valued at fair value based on the amount that would be received if the contract were terminated on the reporting date, which is book value, less an early withdrawal charge.

Registered Investment Companies

Valued at fair value are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value, or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan had no investments at August 10, 2022.

As of December 31, 2021, the Plan invests in pooled separate accounts, which have a daily redemption frequency, and a 30-day redemption notice period.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Life Insurance Company, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market, at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 – CERTIFIED INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the trustee of the Plan, has certified the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of August 10, 2022 and 2021.
- Net depreciation in fair value of investments, interest and dividend income, and other gains, reflected on the accompanying statement of changes in net assets available for benefits for the for the period from January 1, 2022 to August 10, 2022.
