## **Independent Auditor's Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Super ATV 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of the period ending November 30, 2022 and year ending December 31, 2021, and the related statement of changes in net assets available for benefits for the period ending November 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Super ATV 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### **Opinion**

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## **NOTE A – PLAN DESCRIPTION**

The following description of the Super ATV 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### *GENERAL*

The Plan is a defined contribution 401(k) plan sponsored by Super ATV with a plan year end of December 31<sup>st</sup>. The Plan was formed effective May 1, 2015 with the most recent Plan amendment taking effect on April 19, 2022. This amendment updated the Plan document for recent changes in laws and regulations governing retirement plans. The participating employers of the Plan are Super ATV, Clifty Warehouse & Logistics, LLC, and Armor Plastics, LLC, hereon collectively referred to as the “Company” and “Employer.” The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company was acquired by Dorman Products in late 2022, resulting in the transfer of the assets from the Plan to the Dorman retirement plan. The Plan was effectively terminated on November 30, 2022, when the remaining Plan assets were transferred to Dorman Products, Inc. 401(k) Retirement Plan & Trust.

### *ELIGIBILITY*

Covered employees of the Company who are of age 19 or older are eligible to join the Plan on the first of the month following their meeting of the eligibility requirements. There is no service requirement for employees to join the Plan.

### *PARTICIPANT AND COMPANY CONTRIBUTIONS*

Each year, participants may elect to make pre-tax contributions to the Plan using a percentage of their eligible compensation not to exceed 90 percent, subject to a maximum annual limitation set by the Internal Revenue Service (IRS). After-tax Roth contributions were permitted beginning June 1, 2019. Participants who have attained age 50 or more before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan using amounts distributed to them from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary matching contribution to the Plan. There is no service requirement for participants to receive the discretionary matching contribution. Allocation of these contributions to participants will be made in accordance with the formula selected by the Company as defined in the Plan document. For the period ending November 30, 2022 and year ending December 31, 2021, there was \$266,840 and \$306,356 of discretionary matching contributions, respectively.

The Company may make a discretionary profit-sharing contribution to the Plan. Participants of the Plan must have one year of service, be a full-time employee (those with less than 1,000 hours of service in the year are not eligible) and be employed on the last day of the Plan year to be eligible for the discretionary profit sharing contribution. Allocation of these contributions to participants will be made in accordance with the formula selected by the Company as defined in the Plan document. For the period ending November 30, 2022 and year ending December 31, 2021, there was no discretionary profit sharing contribution.

### *PARTICIPANT ACCOUNTS*

Each participant’s account is credited with the participant’s contribution as well as the Company discretionary, matching and profit-sharing contributions, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## NOTE A – PLAN DESCRIPTION – CONT.

### *VESTING AND FORFEITURES*

Vesting is based on years of service for employer contributions. Participants are immediately vested in their elective (voluntary) contributions and earnings thereon. Interests in the Company's discretionary matching and profit-sharing contributions and earnings thereon vest as follows:

<u>Years of Service</u>	<u>Vesting</u>
1	20%
2	40%
3	60%
4	80%
5	100%

Upon termination of active participation in the Plan, other than as a result of retirement, total or permanent disability or death, the non-vested portion of the participant's account will be forfeited. Forfeitures of non-vested accounts may be used to reduce future employer contributions or used toward allowable administrative expenses. There were \$23,873 of forfeitures used in 2022 toward discretionary matching contributions. The ending balance in the forfeiture account as of December 31, 2021 was \$306.

### *PAYMENT OF BENEFITS*

Distributions of benefits are defined in the Plan document. Generally, upon termination of employment, death, disability, or normal retirement, a participant (or designated beneficiary) may elect to receive 100% of his or her vested account balance in either a lump sum cash payment or a direct rollover to another qualified plan, or partial payouts. Participants who have attained age 59 1/2 may also withdraw all or a portion of their vested account balances. Minimum distributions are required once the participant reaches age 72. Participants may also receive a lump sum amount upon demonstration of a financial hardship.

### *NOTES RECEIVABLE FROM PARTICIPANTS*

The Plan provides that participants can borrow funds of at least \$1,000 up to a maximum equal to 50 percent of their vested account balance, reduced by any Roth elective deferrals, or \$50,000. The loans are secured by the balance in the participant's account and bear interest at prime plus 1 percent. The term of the loan cannot exceed five years, except if the loan proceeds are used to finance the purchase of a primary residence, in which case the loan term may not exceed thirty years. Principal and interest is paid ratably through weekly payroll deductions. A participant may only have one loan outstanding at a time.

## NOTE B – SUMMARY OF ACCOUNTING POLICIES

### *BASIS OF ACCOUNTING*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### *USE OF ESTIMATES*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could vary from these estimates.

### *INVESTMENT VALUATION AND INCOME RECOGNITION*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note D for a discussion of fair value measurements.

## **NOTE B – SUMMARY OF ACCOUNTING POLICIES – CONT.**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *NOTES RECEIVABLE FROM PARTICIPANTS*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of the period ending November 30, 2022 and year ending December 31, 2021.

### *EXCESS CONTRIBUTIONS PAYABLE*

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with the corresponding reduction to contributions. The Plan distributed the 2021 excess contributions before March 15, 2022 to the applicable participants.

### *PAYMENT OF BENEFITS*

Benefit payments to participants and their beneficiaries are recorded when paid.

### *FUND TRANSFERS TO OUTSIDE PLAN*

Fund transfers to outside plan relate to the transfer of assets to Dorman Products, Inc. 401(k) Retirement Plan & Trust.

### *OPERATING EXPENSES*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of the investments.

### *DATE OF MANAGEMENT REVIEW*

Subsequent events were evaluated through June 27, 2023, which is the date the financial statements were available to be issued. Management is not required to and has not evaluated events or transactions that occurred after June 27, 2023.

## **NOTE C – UNAUDITED INVESTMENT INFORMATION CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor Rules and Regulations and disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the trustee, Reliance Trust Company, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. All investments and notes receivable from participants shown in the accompanying statements of net assets available for benefits.
- b. Net Investment income from the investments, as shown in the accompanying statement of changes in net assets available for benefits, including dividends and interest income and net realized and unrealized appreciation (depreciation) in the fair value of assets.

## NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB (Financial Accounting Standards Board) ASC (Accounting Standards Codification) 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement of the assets and liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no transfers between levels in 2022 or 2021.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

**Money Market Fund:** Valued based on quoted prices in active markets for identical securities.

**Common Collective Trusts:** Valued at the NAV of the units in the Common Collective Trust Funds. The NAV as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan’s management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

## NOTE E – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company is the custodian of the Plan assets. ADP provides third party administrative and recordkeeping services. Pooler CPA Group, LLC is the Plan auditor. Robert W. Baird & Co., Inc. provides investment advisory services to the Plan and participants. Therefore, these transactions qualify as party-in interest transactions.

Audit fees and certain other administrative expenses are rendered by parties in interest and are paid by the Company. The Company also provides certain administrative services for the Plan for which it receives no compensation.

## NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

## NOTE G – TAX STATUS

The Plan, which is a prototype plan sponsored by ADP, has received a favored opinion letter dated October 6, 2020, in which the Internal Revenue Service has stated that the Plan Documents are acceptable under section 401 of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of the period ending November 30, 2022 and the year ending December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

## NOTE H – PLAN TERMINATION

The Company was acquired by Dorman Products in late 2022, resulting in the transfer of the assets from the Plan to the Dorman retirement plan. Participants were given the option to rollover their funds to the Dorman Products, Inc. 401(k) Retirement Plan & Trust, cash out, or move their funds to an individual retirement account (IRA). The Plan was effectively terminated on November 30, 2022, when the remaining Plan assets were transferred to Dorman Products, Inc. 401(k) Retirement Plan & Trust.
