

IV. Actuarial Assumptions

A. Funding – The following actuarial assumptions were used in the calculation of the required contribution:

- 1) Interest Rate – Segment Rates of 1.07/4.75%, 2.68/5.36% and 3.36/6.11 were used. The Effective Interest Rate is 5.80%.
- 2) Mortality Table – The 2021 Applicable Mortality Table was used for the post-retirement period.
- 3) Salary Scale – It was assumed that salaries would remain constant until Normal Retirement Date.
- 4) Severance Discount – No discount for early severance was assumed.
- 5) Retirement Age – It was assumed that employees would retire on their Normal Retirement Date or immediately if later.
- 6) Asset Valuation – Assets were valued at market value for purposes of calculating the required contribution.
- 7) Actuarial Cost Method – No longer applicable. Method is now mandated.

V. Principal Plan Provisions - A summary of the main operational features of the Plan is as follows:

- A. Effective Date – October 1, 2021.
- B. Eligibility - On the Oct. 1 or April 1 after one Year of Service and attainment of age 21. All employees on the Effective Date are immediately eligible.
- C. Benefit Service - All Plan Years (Jan. 1-Dec. 31) of 1000 hours are counted.
- D. Retirement Date - The first of the month following age 62 or the later completion of 5 Years of Participation.
- E. Benefit Formula - A monthly life annuity at Normal Retirement Date equal to 7.632% of Average Compensation multiplied by Years of Participation to a maximum of 10 Years. For minority Partners and spouses thereof, the percentage is 5.00%
- F. Pre Retirement Death Benefit - The benefit which can be provided by the Actuarial Equivalent of the accrued retirement pension plus the proceeds of the life insurance in force.
- G. Vesting – Participants become 20% vested after Two Years of Service plus an additional 20% per year to 100% after six Years of Service.
